The meeting was called to order at 7:03pm by Chairperson Coffin.

1. APPROVAL OF MINUTES

Chairperson Coffin requested a motion to accept the minutes of the September 9, 2021 Police Commission Meeting. Commissioner Kain made the motion and Commissioner Money seconded the motion.

4. <u>NEW BUSINESS</u>

A. 1. Uniform Division Commander Annual Report

Captain Terzian updated the Commissioners on the equipment, Accountability Bill and the effect it has had on officers. Captain Terzian went on to explain that officers are active on the roadways conducting traffic enforcement details. Captain Terzian stated that most of Ridgefield's crime is mostly related to juvenile crime, which is happening throughout the state. Most of these crimes are stolen motor vehicles and larcenies from motor vehicles committed by juveniles from out of town. He explained that most of the stolen vehicles are recovered within a few days to a few weeks. Captain Terzian praised the officers for their professionalism and dedication to the department and the citizens of Ridgefield.

He thanked previous School Resource Officer Daly for his years of service as an SRO, and welcomed Officer Samoskevich to replace SRO Daly. He also praised Officer Caba and Officer Williams for their assistance filling in at the schools when needed. Captain Terzian spoke highly of the Records Division Personnel Alison Heibeck and Elaine Wasicki, for their daily assistance with records requests and countless other duties. Discussion regarding the Uniform Division Commander Annual Report ensued.

A.2. Detective Division Report

Captain Terzian has been filling in for Captain Comstock for the past few months. He explained that the detectives assist with most cases that are going to be lengthy or more in depth investigations. Also, they assist in the collection of evidence to include DNA, Fingerprints, and Physical Evidence. He briefly explained the duties of all the members of the Detective Division: Det. Papstein, Det./Y.O. Dardis, Det. DuBord, and Det. Ryan. The Detective Division has handled or assisted in the following cases in 2021:

- 3- Death Investigations
- 7- Burglaries
- 10- Identity Thefts
- 21- Larcenies
- 4- Stolen M/V
- 4- Sex Assaults
- 122- Pistol Permits

Detectives have made 6 felony arrests (larcenies and sexual assault included)

He stated that the Juvenile Review Board is a positive resource for less serious crimes, which has been well received. Discussion regarding the Detective Division Report ensued.

B. State Project 0174-0424 Semi-Final Design Plan Review (Route 7/Haviland Road)

The Chief has reviewed the plan, and recommends that the pedestrian crossing button remains in place with no change.

C. PBA Fundraising Letter

Chairperson Coffin made a motion to make a couple minor changes with the wording of the PBA Fundraising letter and suggested corrections be made before being sent to print. The Commissioners recommended that it be noted that the PBA is not a 501(c)3 as well as a change to the language. Commissioner Money seconded the motion.
