#### 7:30 pm Public Hearing on Proposed Changes to Livestock Ordinance

R. Marconi called the Public Hearing to order at 7:30 p.m.

## **Speakers**

- 1. Paula Cipot Schmidt, 43 Parley Rd.- has lived here 52 years and has always had ponies. She has three daughters who were raised with ponies. Asked for grandfathering in the revised ordinance. Submitted a letter to the BOS. Willing to serve on committee AGAINST
- 2. Joseph Giaccone, 79 Manor Rd.- Owner of Property in question and renter to family with horses. Read statement about current lease and a letter he received from the Health Department AGAINST
- 3. Steven Strieter, 79 Manor Rd.- (Owner of horse in question) stated that he has a proper, above average shelter for the horses. He stated he is completely within the law; the Health Department has reviewed the situation 12 times AGAINST
- 4. Mario Giannettino,- 2 Manor Rd. an attorney, stated the acreage is questionable. "Draft is least restrictive." FOR

- 6. Marzena Piwko, 224 Pine Mountain Rd. AGAINST
- 7. Kate Sheafe, 5 Lewis Dr. FOR
- 8. Christopher Coles, 12 7th Lane (Horse Professional on U.S. Olympic team; has 40 horses in North Salem, NY on 20 acres; 1/2 acre per horse; 8' setback (horse has about a 4' reach)) AGAINST
- 9. Dr. Jeffrey Hubsher 239 Ridgebury Rd.- Veterinarian. Moved here for horses. Can there be a compromise? He talked to the owner of the horses 1) use shed; 2) raise fence; 3) reduce number of horses AGAINST
- 10. Patricia Kuehner, 384 West Lane (Horse Professional) AGAINST
- 11. Dennis Peterson, 60 Powdermaker Dr. FOR
- 12. Tom Pesce, 32 Lewis Dr.- Gave overview of neighborhood situation; does not agree with compromise; current situation is unsafe and therefore unfair; suggested give backs: 1.5 acre reduce to 1 acre, 15' setbacks FOR

- Many horseowners do not want their rights to own infringed upon because of one situation by one owner.
- Some supporters believe the ordinance should apply to the full town not just the "town area".
- Residents of area in question believe the neighborhood should be solely residential.
- Horse professionals willing to help fix the problem before an ordinance changes their rights.
- Smell is most noted factor that prevents neighbors from enjoying their property.
- Calls for compromise before change of ordinance.

B. Manners moved and S. Zemo seconded a motion to renew the Zawacki's permit for the Zawack Shack. Motion passed 5-0.

## 5. 729 North Salem Road Rent Increase Approval

R. Hebert moved and S. Zemo seconded a motion to approve the 729 North Salem Road rent increase. Motion passed 5-0.
