Approval of January minutes: Mary Morrisroe made the motion to approve the

VSAFE: Sheila reported that people were called who had taken the vaccine to see how they are feeling or reacted. At this time, we can only use cell phone numbers. George would like to be able to call people on their home phones also.

Call to Seniors in Isolation: George suggested sending emails to seniors. What does "in isolation" mean? What information do we need to share- relevant town phone numbers and emails, Meals on Wheels? Support system? Teaching zoom to seniors for ease of having doctor appts.

- Legal aspect of obtaining contact info- could become a FOIA request
- HIPAA issues
- Need for a singular list- who or what entity could develop this list.
- Sheila recommended somehow reaching seniors with a form to fill out an "emergency" card formal application. The seniors' responses would be voluntary.

COVID update: Stephaine explained the new CT vaccine guidelines and rollout plan. Cannot use preexisting conditions to bypass. Vaccines will be given by age. Yet, teachers can bypass as essential workers. Starting March 1st, VAMS will permit sign up for ages 55-64. New groups will be added to the vaccine sign up list. Goal is by May 12th, vaccines will be available for individuals 16-34.
