## 1. APPROVAL OF MINUTES

#### 3. OPEN SPACE

# a) McKeon Farm

 Henny Penny Agreement – Mr. Coyle reported that Ms. Freeman has filed the NRCS application without obtaining Town approval for a five-year lease. The five-year lease will be discussed at the November 2, 2016 Board of Selectmen meeting.

- Mowing Hans Williams mowed both sections of the large hay field and expects Parks & Rec to mow the two front fields shortly.
- Decision making for the farm was discussed. Mr. Kace suggested finding an individual who could provide us with advice/help managing the farm. Ms. Snow and Mr. Cronin will meet with Hans Williams and Whitney Freeman to come up with possible solutions and present them at the next RCC meeting.
- b) **Deer Committee** The RCC sent a letter on October 20, 2016 to the First Selectman explaining the commission's dissatisfaction with the hunt notification process. There has been no response.
- c) Ranger Recognition Ms. Lake has ordered a trial sample of 12 caps, scheduled to arrive by November 8, 2016. If satisfactory, another 70 caps will be ordered to be given out to RCC rangers.
- d) **20 Mopus Bridge** The homeowner has agreed to the terms of the easement swap. It will go before the Board of Selectmen on November 2, 2016.
- e) **267 lvy Hill** The homeowner has proposed a 2:1 land swap. Ms. Lake will investigate zoning regulations and Highway Department requirements with respect to lot size, property accessways, and deed restrictions, if any, of the abutting open space. Ms. Lake will send commission members the results of her investigations before the next meeting. The owner will appear at our November 14, 2016 meeting to discuss her proposal.
