#### 1. APPROVAL OF MINUTES

TREASURER'S REPORT – Mr. Brewster asked for approval on an invoice for \$257.03 from Ridgefield Power for equipment tune-up and repair.

UPON motion duly made, seconded and unanimously carried, it was RESOLVED to approve payment of the invoice.

2. GREEN EXPO – The RCC is a sponsor of the event being held outside the Ridgefield Playhouse on Sunday. July 22 from 12-2pm. Mr. Coyle, Mr. Cronin, Ms. Snow and Ms. Baker will represent the RCC. Ms. Baker will look into getting a tent. Walkbooks, open space maps, trail maps and the banner will be displayed at the RCC table.

### 3. OPEN SPACE

Skytop Road – Mr. Cronin reported that it is not practical to move the chain barrier. Mr. Levine will speak to the abutting property owner about a solution for future use.

**The McKeon Farm** – Mr. Coyle updated the commission on several farm issues.

- The three fields have been haved. Joseph Natal is cleaning up the edges and stonewalls.
- Cornerstone has been delayed due to rough soil and unresolved ADA issues. Solutions are being worked on.

- Liming of the two Stagecoach fields will be done Tuesday, 7/17. Mr. Cronin, Beckenstein and Coyle will assist. Help will be needed for the additional two Ridgebury fields next Tuesday, 7/24 at 9am.
- The cattle chute and roofless structure will be dismantled and removed sometime in the fall.

**Understory Study Update** – Four plots in Hemlock Hills and three plots in Bennetts Pond have been visited. One more area in Hemlock Hills will be visited this weekend, after which data will be compiled and sent to Ed Faison at Highstead for comment and validation. A draft of results should be available in September.
