Monthly Meeting Minutes

June 9, 2009

Minutes:

May minutes were approved.

Treasurer's Report:

Ruth provided an updated budget report. Some grant funds remain; Ruth has discussed the deadlines and restrictions with both John Cusano of CCT and John Mannuzza of the Town. Ruth reported that, despite the June 30th deadline, the CCT grant reported materials are not yet available.

OLD BUSINESS:

Behind the Scenes Award: Nancy Andrews

Nancy reported that, following this year's ceremony, she was asked to consider presenting two awards, based on age or years of service. The council agreed that adjustments to the awards and nomination process will be discussed by the sub-committee when planning begins for next year's event.

Remaining Grant Funds: Ruth Wilder-Feldman

Ruth reported that grant funds are still available and must be spent by June 30, 2009. The excess is due to the delayed delivery of grant funds, which were earmarked for advertising and the engagement of an independent contractor (neither of which could begin until funds were in hand). Funds should be directed towards activities that promote or support the website (as outlined in our grant request).

Nancy shared a letter she received from a student requesting scholarship assistance. Council members agreed that RAC is currently not in a position to grant scholarships. The request sparked conversation and it was resolved that the developing a scholarship program will be explored in the future.

Council members approved the drafting of by-laws and development of standing committees for the Council. Meg will prepare a draft for the next meeting.
