Mr. Sergiovanni:

#### Administrative:

1. Handed out financial comparisons from the previous 6 Fiscal Years. The Committee reviewed and discussed various items.
2. There will be a Membership Special that will be offered for New Memberships at the end of August.
3. There will be 2 new signs specifying the Golf Course Policy concerning Liquor brought onto the Golf Course.
4. A new Ice Machine was purchased and installed in the bar area of the Restaurant to replace the old Ice Machine that was not repairable.
5. A new picnic table was installed for smokers to sit. It was installed on the ground level on the Snack Shed side of the deck.

#### Maintenance:

1. Due to the excessive rain and high humidity, the Golf Course is being treated with a fungicide to prevent turf damage.
2. Until the current weather conditions let up, the fairways will be mowed one-quarter inch higher.
3. Tomorrow morning riding carts will not be in use in order to prevent damage and allow the Golf Course some time to drain.
