ITEM # 2 REPORTS AND DISCUSSION ON COURSE OPERATIONS

Mr. Sergiovanni:

1. Discussed financials that compared the past 8 Fiscal Years. FY 2020 set a low revenue record for April due to the course closure 3/22/2020 through 4/26/2020. May and June set record high revenue amounts. FY 2020 was ranked 4th best of the past eight Fiscal Years.
2. Heat and Humidity are stressing the greens and fairways. Steps are being taken to control Mold Growth.
3. A new bunker has been outlined on the 10th fairway where the large tree was removed. Work will begin soon.
4. Golf Course Membership continues to fall off. Currently membership is approximately 1300. Guest play is about the same for Mondays, Wednesdays and Fridays.

ITEM # 3 INTERVIEWS FOR VACANT GOLF COMMITTEE POSITIONS

1. The Committee interviewed Mr. Maurice Mancini and Mr. Mark Colamaria. A short presentation was made by each candidate. The Committee then asked questions of each candidate.
