- 3. The Board of Selectman of the Town of Ridgefield reserves the right to accept or reject any or all options, bids or proposals; to waive any technicality in any bid or part thereof, and to accept any bid deemed to be in the best interest of the Town of Ridgefield, Connecticut.
- 4. Bidders may be present at the opening of bids.
- 5. Bids may be held by the Town of Ridgefield for a period not to exceed sixty (60) days from the opening of bids for the purpose of reviewing the bids and investigating the qualifications of bidders prior to the awarding of the contract.
- Insurance requirements, if any, must be submitted with the bid. This includes any Hold Harmless requirements as well as Certificates of Insurance, if required, for the full amounts specified.

The Town of Ridgefield Parks & Recreation Department is requesting sealed bid **<u>purchase</u>** prices for one New 2017 Dodge Diesel 5500 truck painted in Timberline Green Pearl Coat. Required Specifications details are shown on the next page. Interior color for all trucks to be a dark color. <u>No</u> other make, model or color of trucks will be considered.

There are no trade-in vehicles as part of this bid.

Sealed Bids must be received by April 11, 2017 by 11:00 a.m. where they will be publicly opened and read aloud.

Vendors shall state expected delivery time from when the order has been given. A timely award is anticipated.

The Town is purchasing <u>ONLY</u> the cab & chassis <u>without</u> a body for purposes of this bid. It is very likely that delivery will be directly to the awarded body vendor.
