A POCD review took place on 2/4/20. The updated RAHC Homefront affordable housing plan will inform a future update to POCD.

Brief discussion on deed restricting existing organically affordable housing in Ridgefield. This is only a concept at this point.

On February 19th the RAHC will update the BOS on progress. Dave and Kent plan to attend that meeting.

Dave and Fran Normann (member of New Milford AHC) discussed forming an area council of on affordable housing. LISC will help support. Details to follow. There will be a meeting of the Housing Alliance of CT on Thursday Feb 20th at 8am. Dave is considering attending. If others are interested, please contact Dave.

The League of Women Voters is considering updating its position on Affordable Housing. Our committee will support if asked.

Per recent news articles, Gov Lamont is looking into connecting some of the Transit funding to affordable housing.

Home front update. Dave indicated he was following up with the state commissioner to see where they stand in providing us with data and other information from the regional planning authority. Dave will ask Rudy to assist in follow up. Dave has been asked to be a member of a state advisory committee.

MADZ. Dave continues to reach out to select Ridgefield developers for their comments.

Housing for adults with disabilities. Sheryl and Dave are meeting with Ability Beyond on Friday 2/7.

Discussion on Bailey Ave property and the fact it is well located for potential affordable housing.

Housing Trust Fund. Dave indicates that First Selectman is supportive of the concept. RAHC will work to develop a proposal. Lori Mazzola agreed to the committee focal point for developing this concept.
