1. Call to Order

The meeting was called to order by Ms. Mucchetti at 6:30 p.m.

2. Public Comment

John Tartaglia of 638 Danbury Rd would like a reaffirmation of "home rule" added to the Charter. He also recommended that the Charter have the Board of Selectman responsible for mandating the mission and limitations of committees and commissions.

Gianna Petroccio of 78 Harvey Rd would like representatives of the Town or CRC to give a presentation to high school students on the Charter and its impact on the Town's governance.

Mr. Rettger moved, and Mr. Cascella seconded a motion to table the discussion of Mr. Rettger's suggested review of the terms "agency" and "department" in the Charter to a future meeting. Motion carried 6-0.

Mr. Rettger moved, and Mr. Lansen seconded a motion to table the discussion on Mr. Rettger's suggested deletion of Section 4-17 of the Charter to a future meeting. Motion carried 6-0.
