George suggested we get a phone/ email buddy for the residents so they could FaceTime and write to a resident to provide some social interaction. This may cause a privacy issues. Resident would need to opt into this service.

Refilling of laundry cards is still an issue for the Meadows Building A. Seniors have to walk a long way to Congregate to get their cards refilled for use in laundry. Unit to refill cards ha been on the RHA agenda. At this time they as saying they need to divert cost to 2021 due to COVID financials.

Founder Hall is doing a great job keeping their clients engaged, moving and active. Isolation is still an issue for all.

Lynn Marie discussed that Fire Alarm at Congregate is consistent with state code. 35 False alarms from Jan.-Sept. per her research. Lynn Marie will review her report at the next COA meeting December.

Private property signs at Ballard Green are still not preventing nonresidents from trespassing.

The Commission discussed possibly buying a small gift for each resident at Congregate. Will discuss further on December call with ideas from everyone.

George made a motion to adjourn, Sheila seconded, all were in favor.
