2) Discussion of 2017-2018 Controlled Hunt.

Chair Zandri spoke with Connecticut State officials who advised Stefano Zandri of the importance of continuing Ridgefield's Controlled Hunt to control the deer population. The officials had recommended adding locations to the Controlled Hunt to make a better impact on the deer population. Current practices maintain the numbers as they presently are.

Chair Zandri said that the 2017-18 Controlled Hunt was a success with sixty (60) deer taken and a total from State records of 161, making Ridgefield number nine (9) in deer taken. Twenty (20) deer were taken in January 2018. Given a delay of the Controlled Hunt and two (2) properties not approved for the Controlled Hunt, the numbers indicate a successful season for the hunt.

- 4) Paul Payne reported on his meeting with Ms. Jennifer Reid regarding Lyme Disease and felt it would benefit the Committee to have Ms. Reid present to the Committee members agreed.
