Golf Course:

1. Financials at this time are trending where they need to be for the Fiscal Year.
2. Rounds and Revenues are fine.
3. The PGA Junior Golf Tournament was hosted by RGC this year. The event was successful.

Maintenance Department

1. Three weeks ago the Golf Course was in great shape but the high temperatures, humidity and rain over the past three weeks created molds and fungus over the entire Golf Course. A Fungicide has been applied and with better weather the problem should be resolved in about a week.
2. All greens have been aerated with the "pin aerator".
3. Mr. Reid asked if we posted signage when Fertilizer was spread and if we didn't, should we be doing so.

ITEM # 3 RESTAURANT DISCUSSION

1. A part of the Regular "Touch Base" that the Committee is doing is a Discussion of the Restaurant Pros and Cons in order to prevent issues from exculpating into problems. The Committee discussed several areas in which the Restaurant is successful and one or two areas where some improvement may be needed.
