1. There are only two weeks left in the Fiscal Year and the numbers are looking good. A full Fiscal Summary for the past 9 years will be presented at the July meeting.
2. Second phase of the cart path paving is out to bid.
3. Mowing the 130 acres of grass is keeping the four full time employees fully occupied.
4. GPS and power modules have been installed in the new Riding Golf Cart fleet. Control zones are being defined for the cart control modules.
5. There is "blue grass weevil" damage on some greens (6, 13, 12 primarily) causing small brown circles. The greens should take about 2 weeks to recover.
