### **ITEM # 2 REPORTS AND DISCUSSION ON COURSE OPERATIONS**

**Mr. Sergiovanni:**

**Course:**

- In September and into October, there continued to be a lot of maintenance to the course given the rain in August. The grass was growing significantly. 9/1 into 9/2 the course had 7.5" of rain, water over bridge
- Aeration of the entire course was completed.
- Irrigation system was winterized.
- Snow and mold protection to be completed in the next month.

**Golf Operation:**

- Course Superintendent Search
  - The list was narrowed to 3 participants.
  - Expectation that the new superintendent would be hired in 2-3 weeks.
- Cell tower. We are awaiting a proposal from Homeland Towers.
- The tent over the deck had been requested to be taken down two weeks ago with hopes the vendor would be removing it very soon.

**Range:**

- The netting cost is closer to \$65,000 verse the \$45,000 previously stated.
- This is due to the height required to keep balls off the 9<sup>th</sup> hole and neighboring properties.
- There does not seem to be any reduced flight range balls available in the marketplace.
- Any major renovation or improvement will not be done in 2022.
- Frank Sergiovanni was meeting with town executives to discuss other possible options.
