MEETING

The meeting was called to order by Mr. Dan O'Brien at 6:30 p.m.

1) 74 High Ridge Avenue

Mr. Alex Bellina of Doyle Coffin and Mehdi Ali, the property owner were present.

Mr. Bellina distributed large scale plans showing the proposed placement of a garage addition to be sited and angled as discussed and approved at the Commission meeting on March 16, 2023 subject to presentation of a design agreeable with the Commission. (The Commission had previously made a site visit to the property on Sunday, February 5, 2023, for the purpose of viewing the proposed site.)

The Commission members viewed various aspects of the proposed design of the structure presented by Mr. Bellina and Ms. Kaplan and Mr. O'Kane commented that the proposed changes in design with a gambrel roof without dormer windows gave the structure a sense of less mass and a reduced size appearance.

The property may only be viewed from High Ridge Avenue by looking down its somewhat long driveway. Commission members commented that the proposed garage structure being angled away from the main house and sited further back in a southeast direction towards the south property line as proposed would be more complementary to the main house than the initial plans presented at the earlier meeting.

Mr. Ali inquired whether the panels shown on the garage door plans on the upper part of the doors would have glass to which Mr. Bellina answered in the affirmative. Mr. Ali suggested that he preferred no see-thru glass on the doors and Mr. Bellina suggested that such panels could instead be painted to which the Commission members had no comment.

Mr. Bellina pointed out that given the siting of the proposed garage structure was not within the regulatory set back from the property line, the Applicant would need to obtain a regulatory waiver and approval by the requisite Town Planning & Zoning or Appeals Board as appropriate in order to proceed with construction.

Ms. Daughters proposed and Mr. Moore seconded a motion to approve the plans dated November 28, 2023 for the two-car detached garage and related modification of existing driveway and parking area as presented subject to Town of Ridgefield regulatory approval of the site plan presented. Motion passed 5-0.
