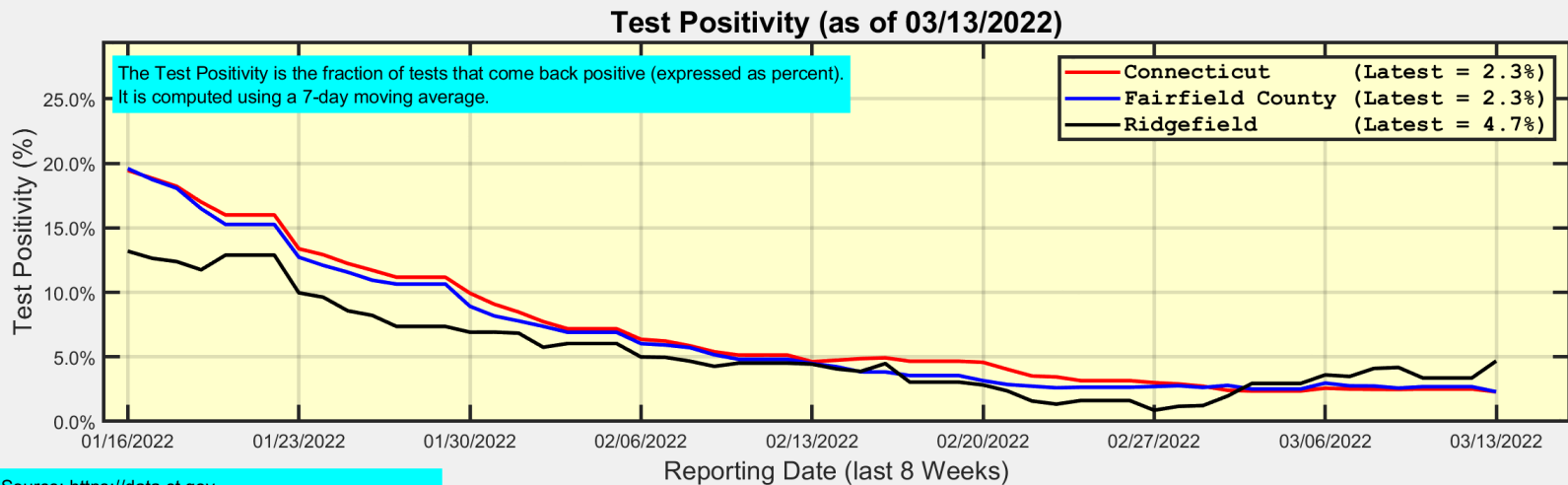
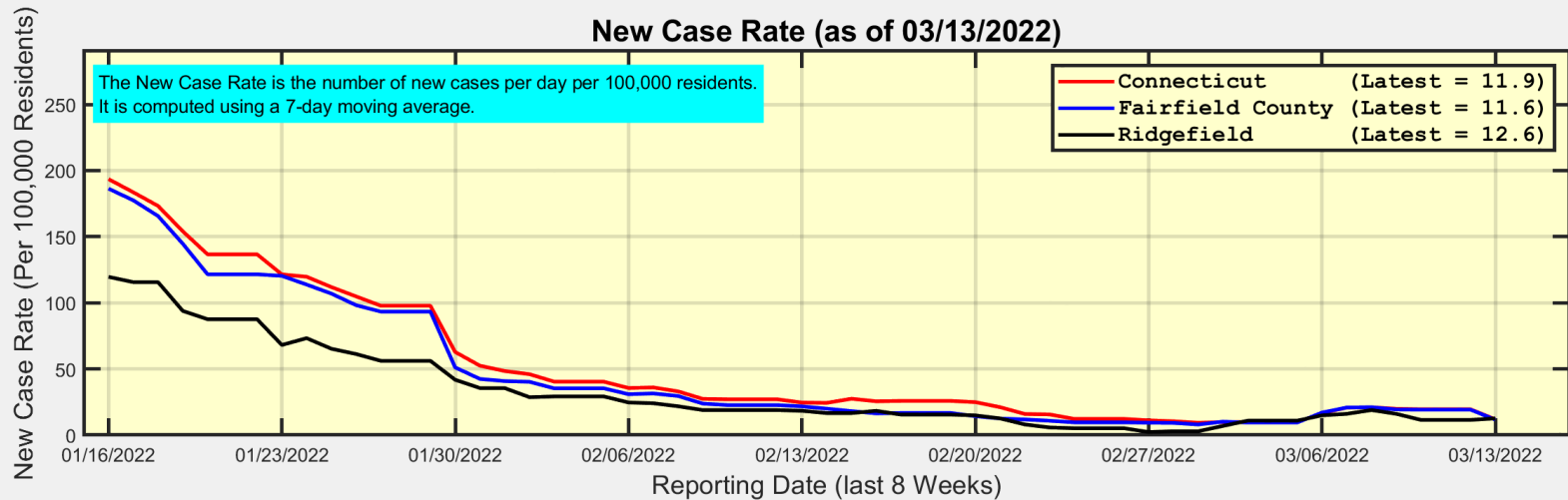

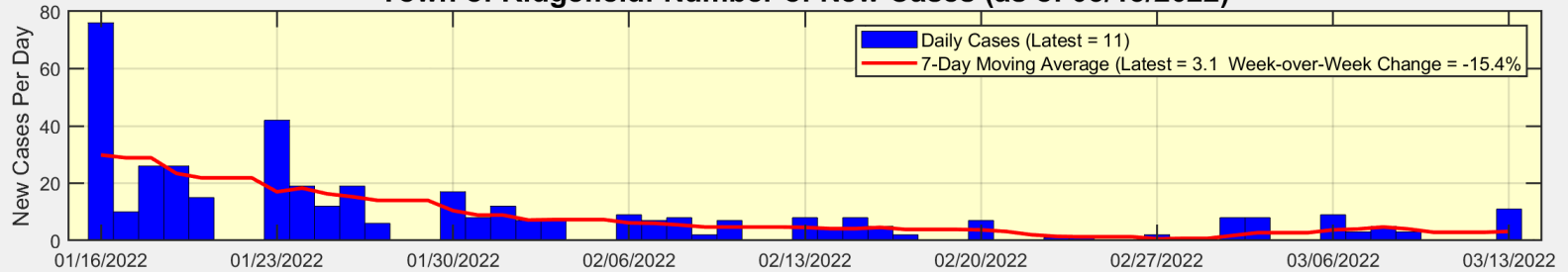

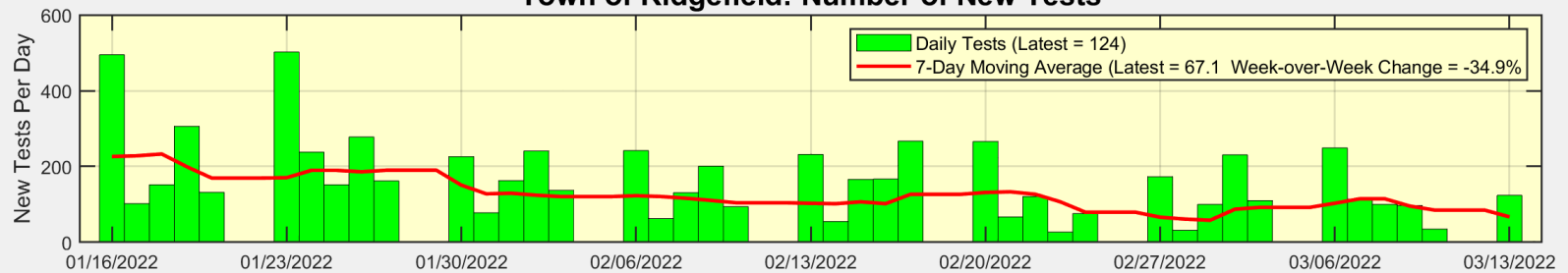

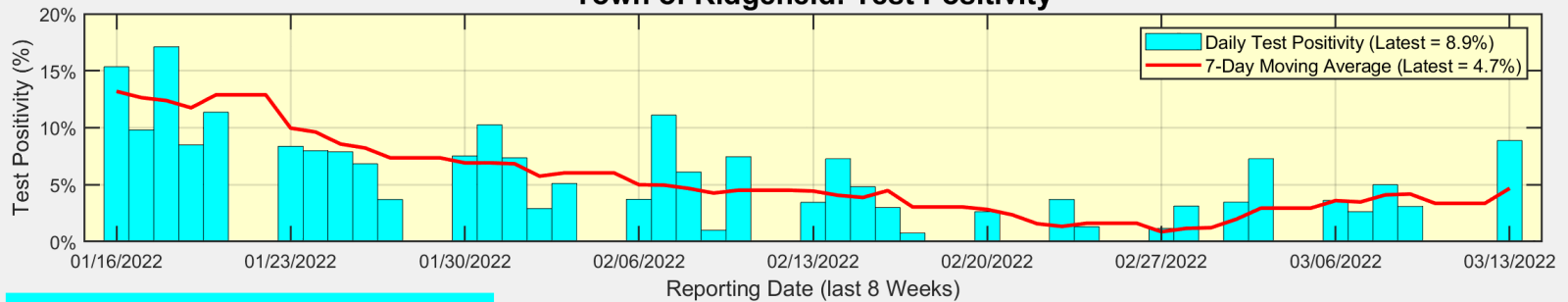
Town of Ridgefield: Number of New Cases (as of 03/13/2022)



Town of Ridgefield: Number of New Tests



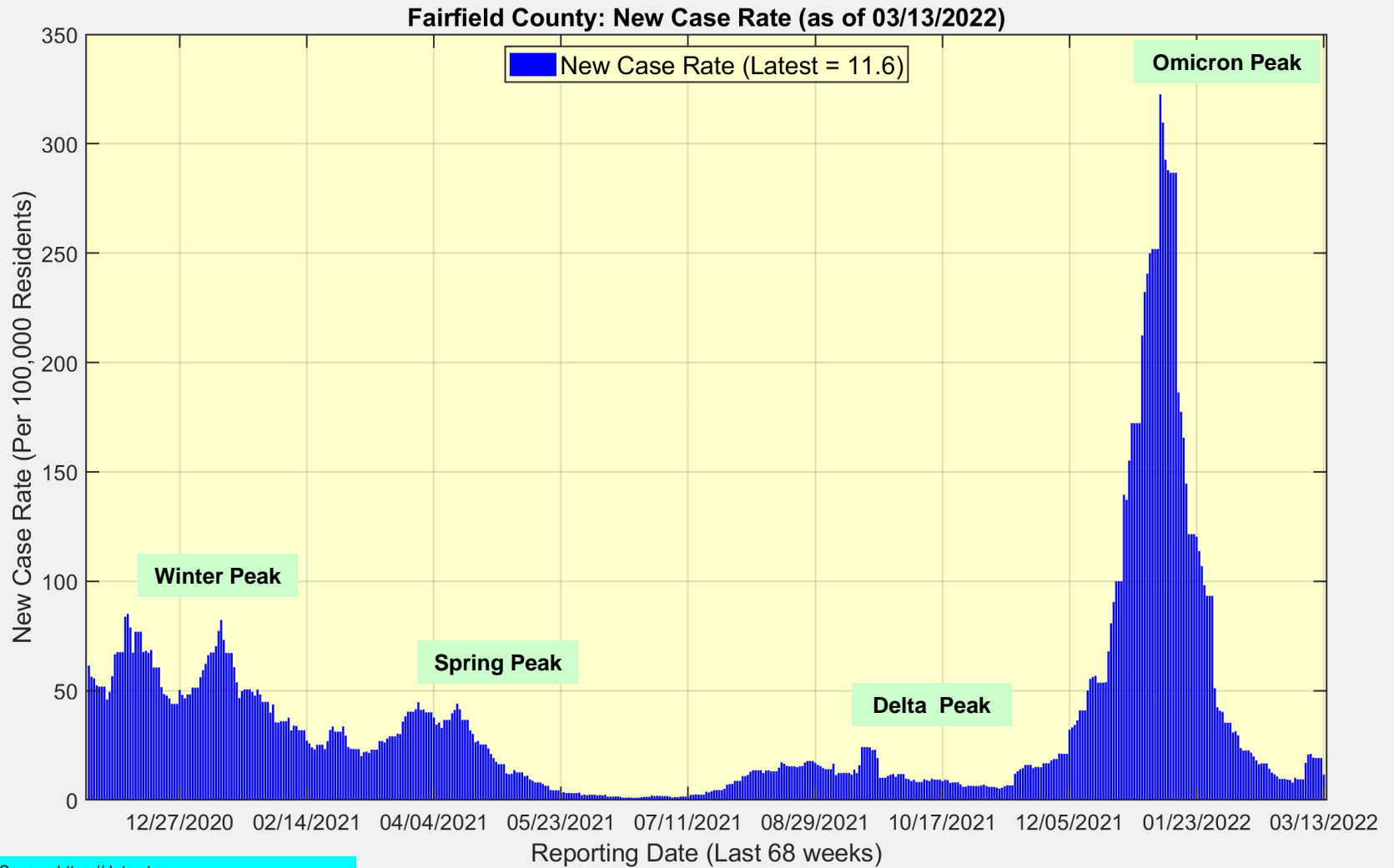
Town of Ridgefield: Test Positivity



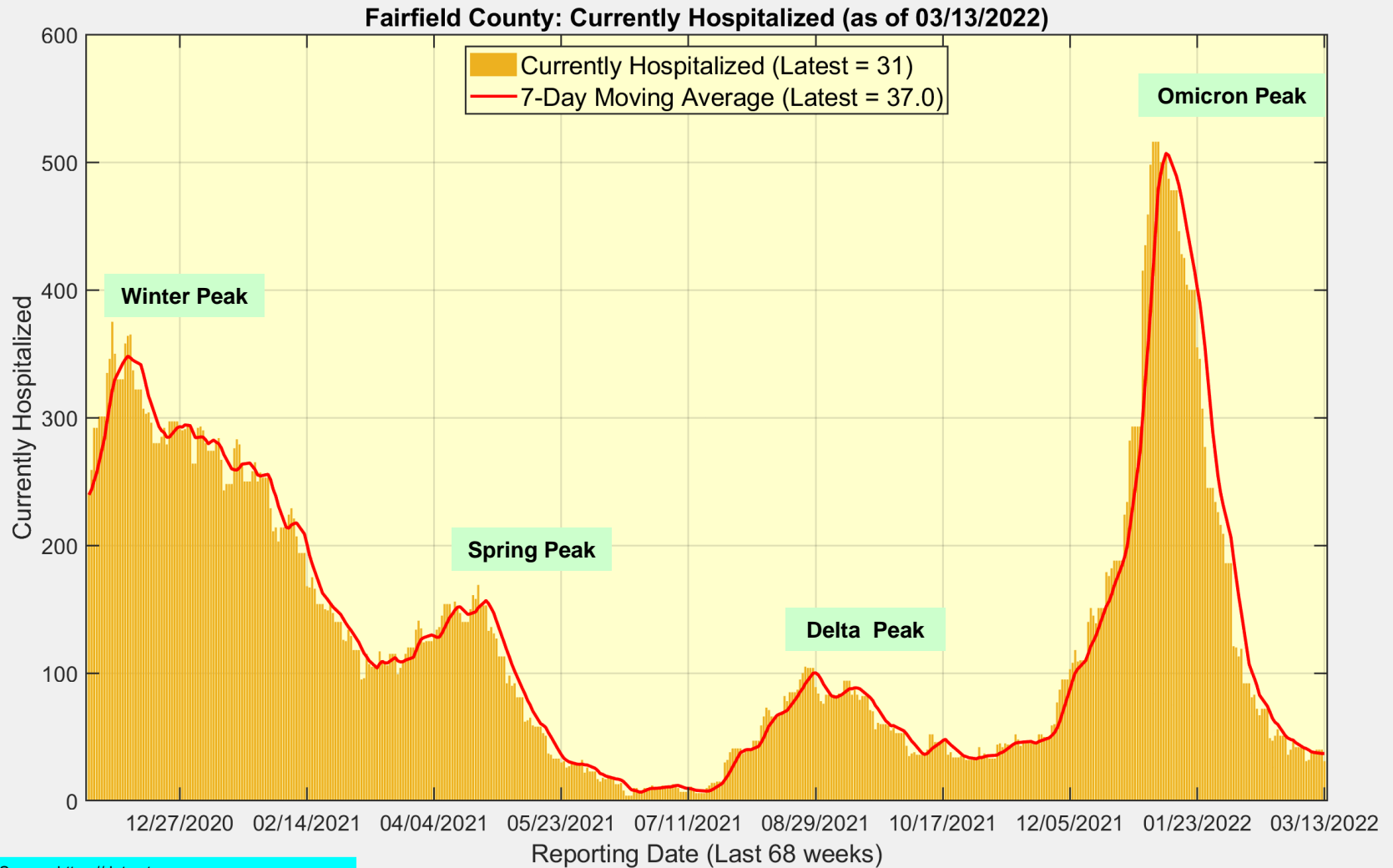

Fairfield County: Currently Hospitalized



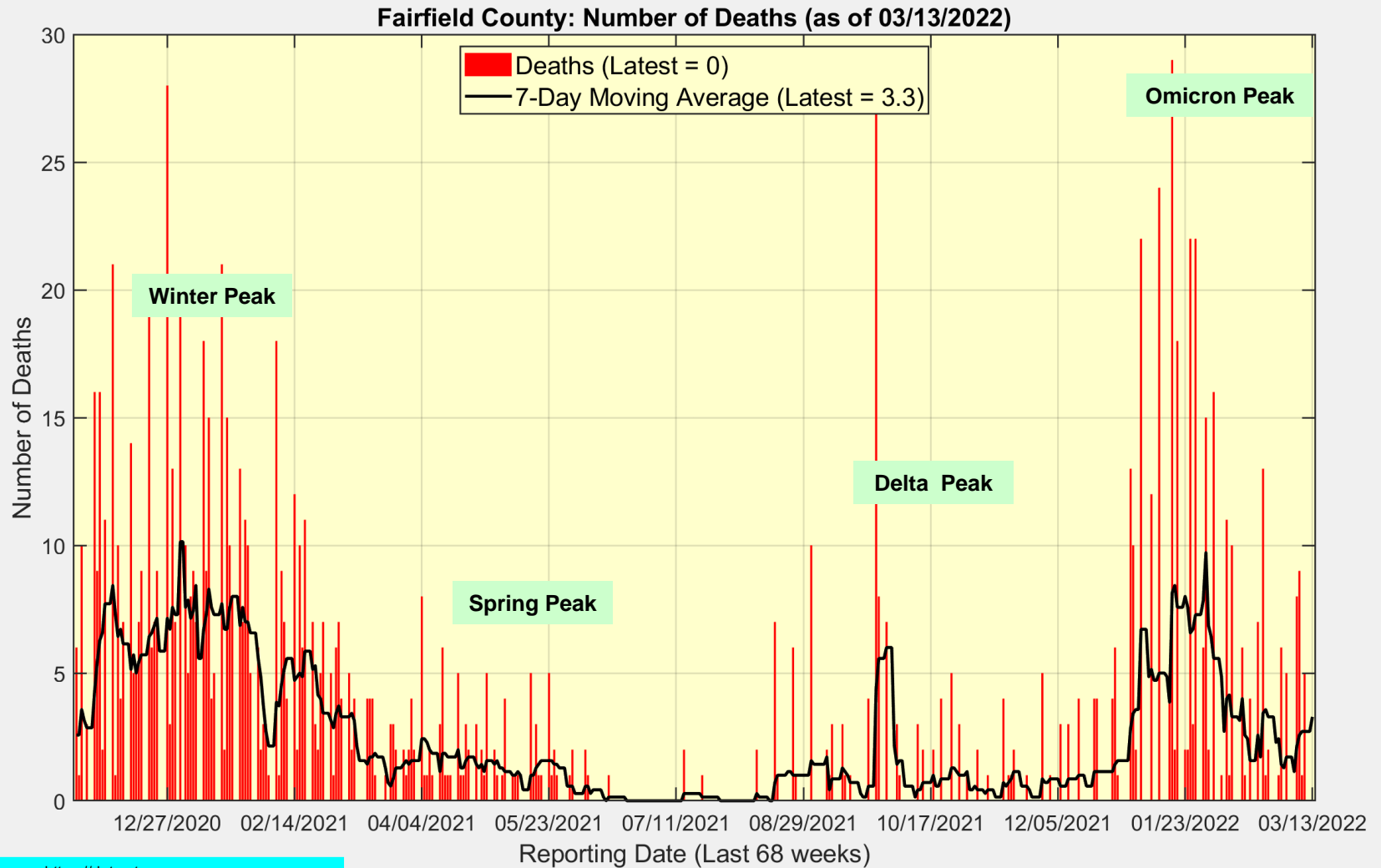

Fairfield County: Number of Deaths

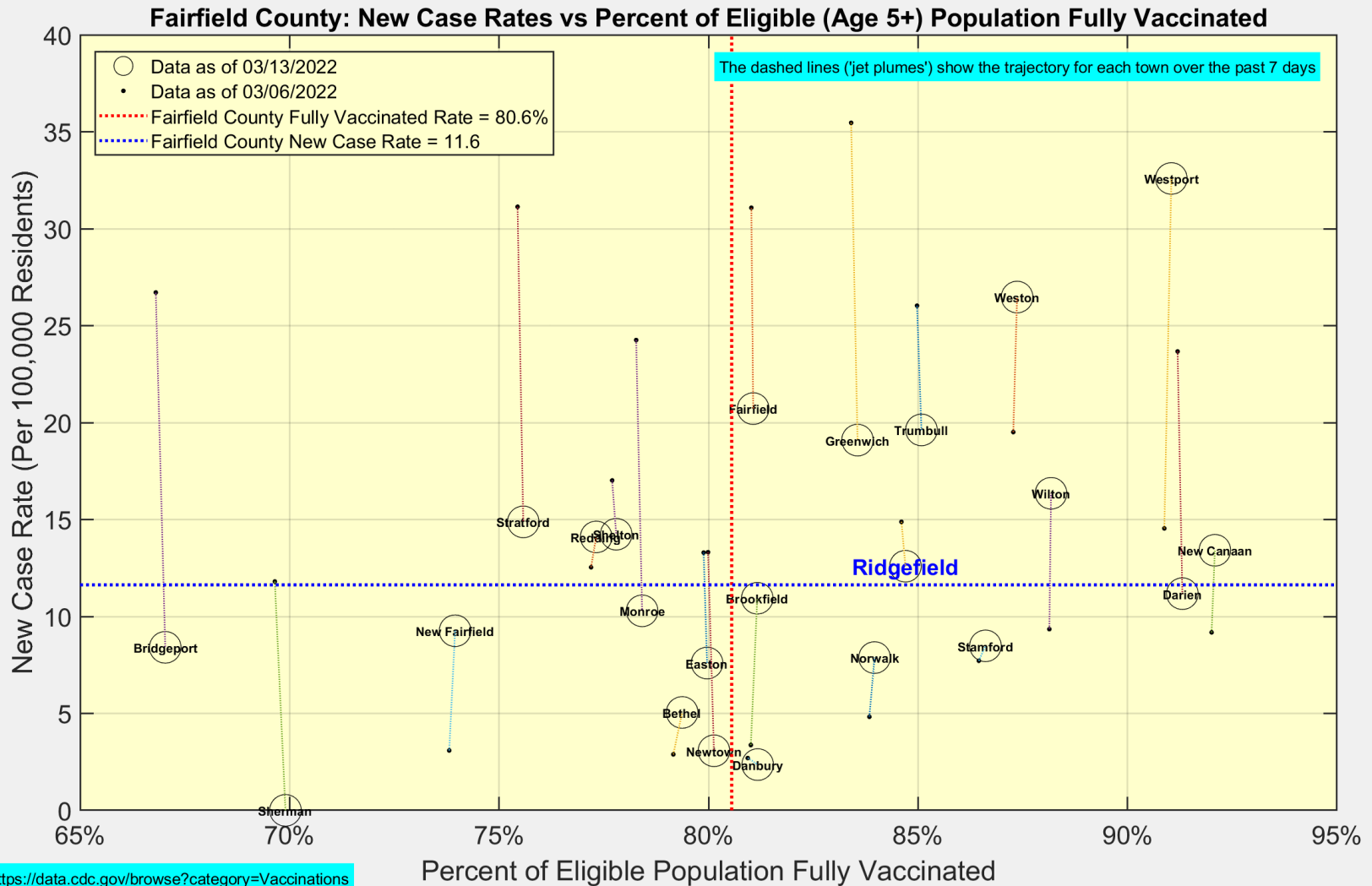

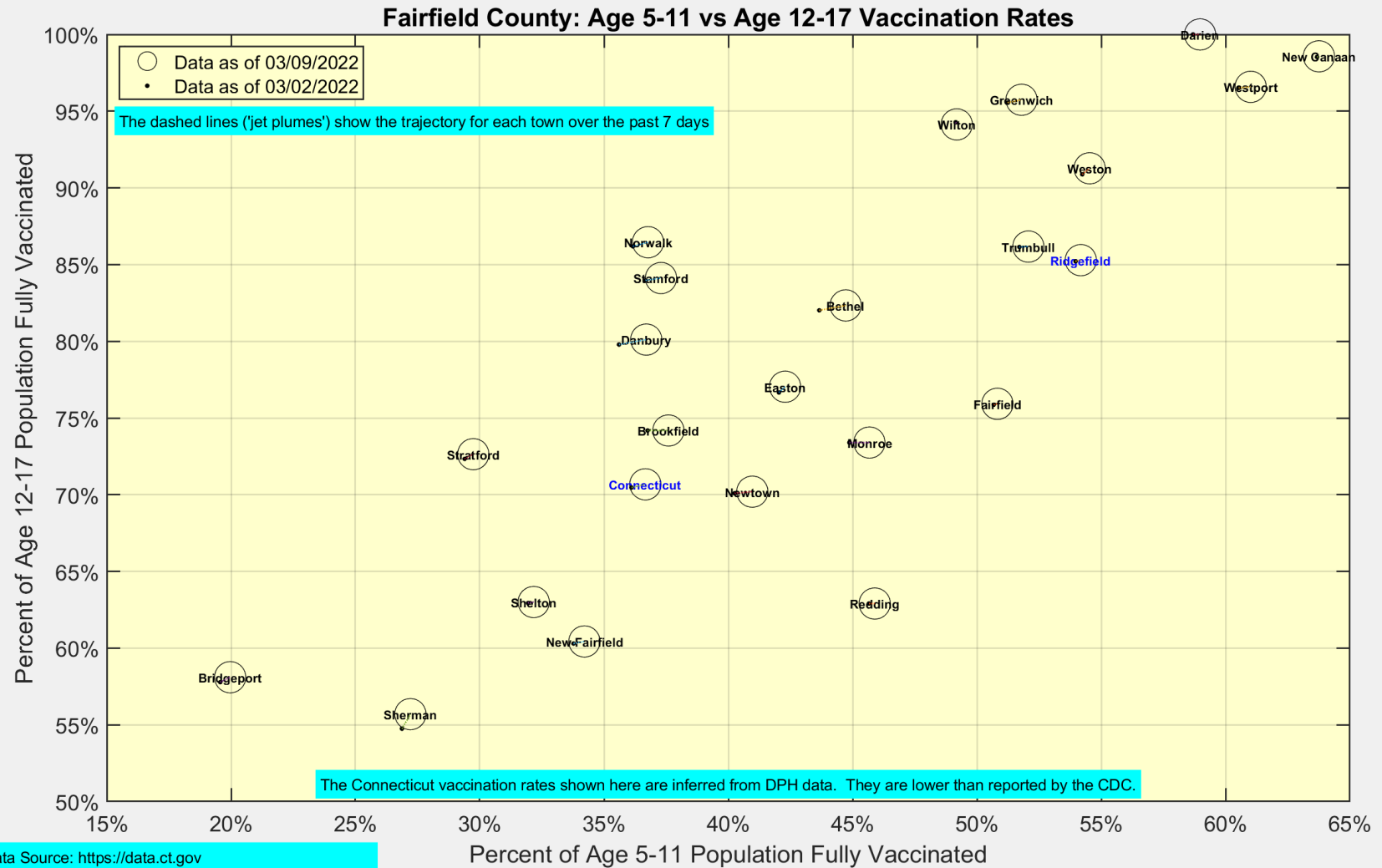

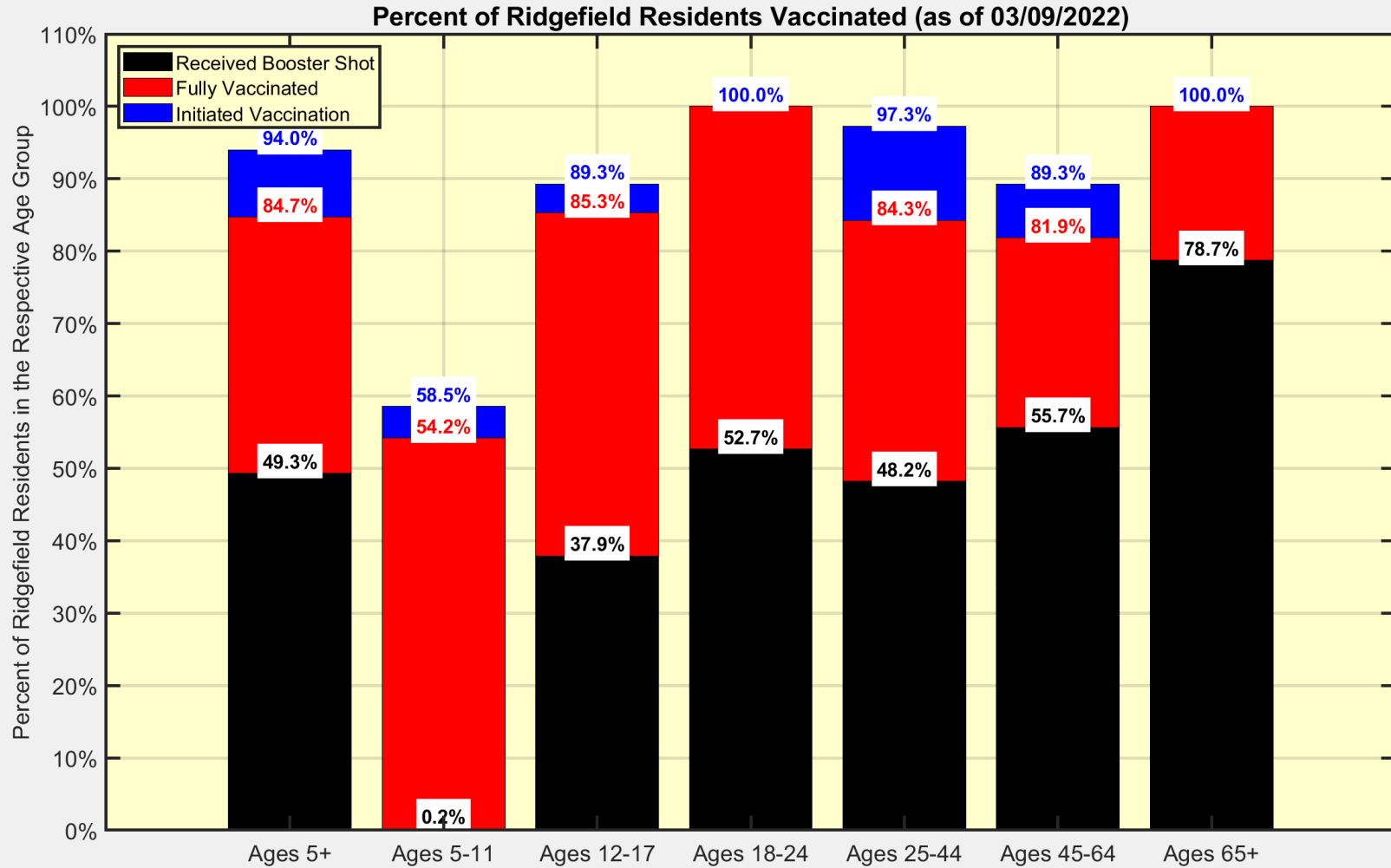

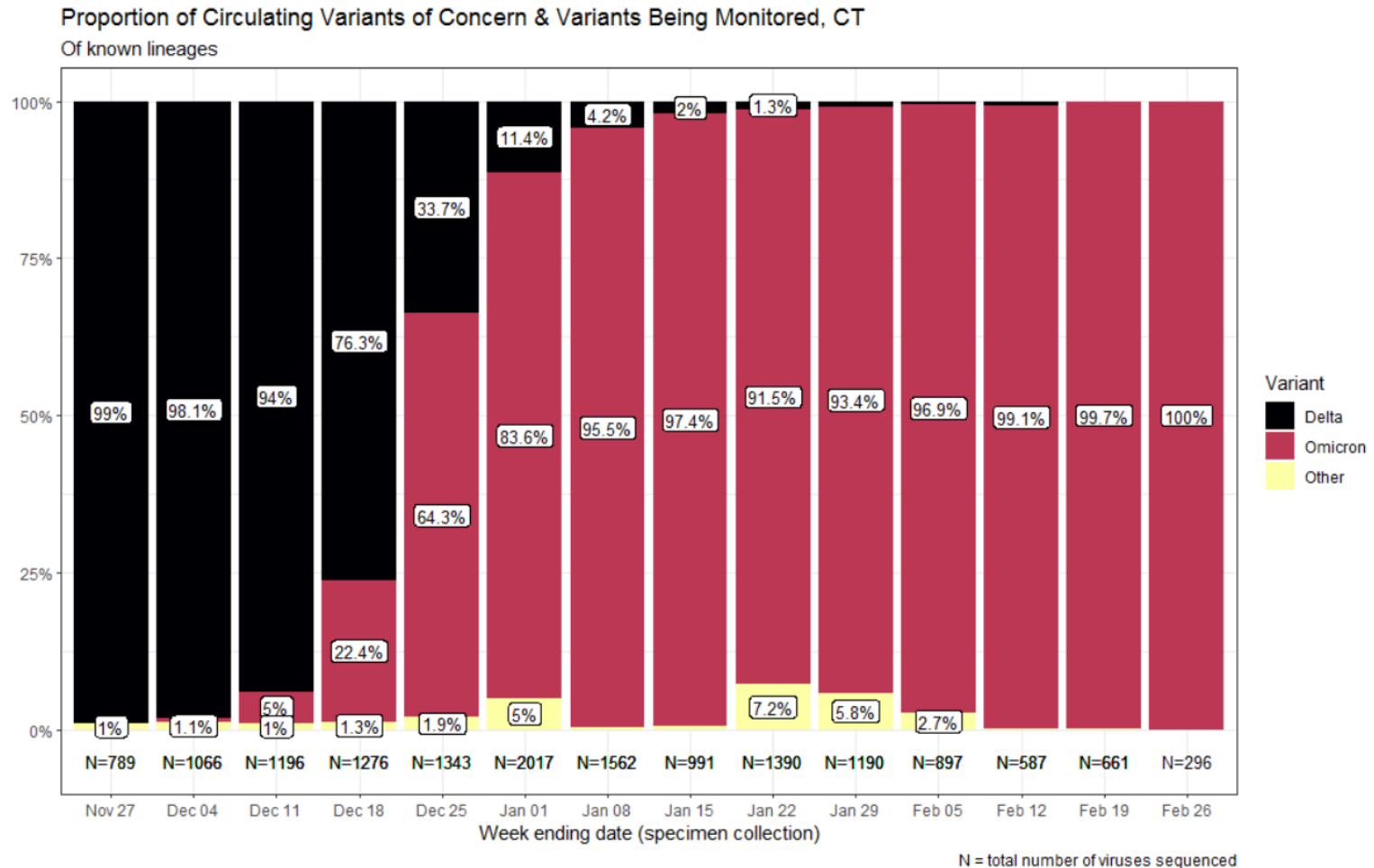
