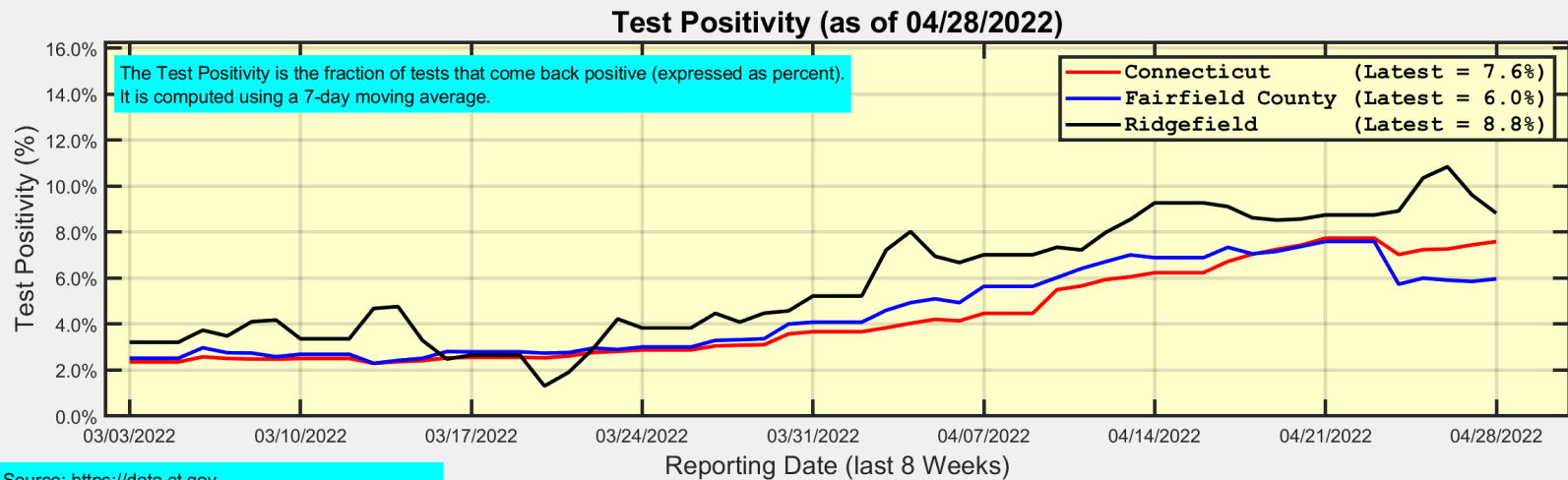
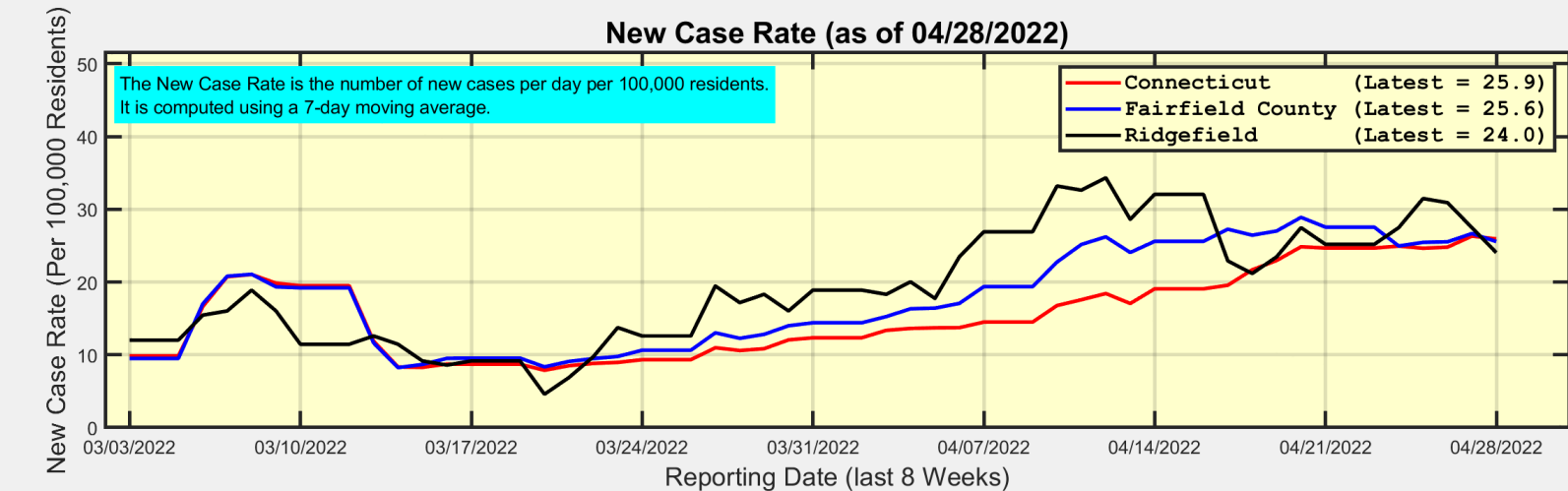

New Case Rates and Test Positivity for Connecticut, Fairfield County, and Ridgefield



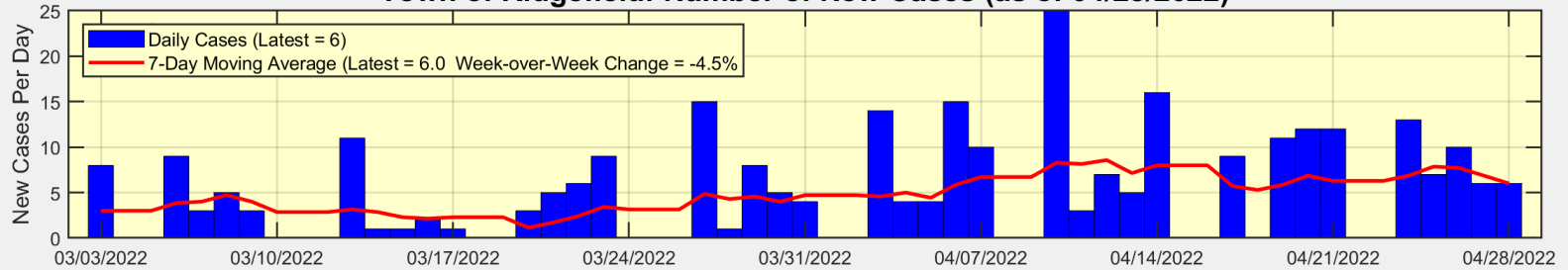

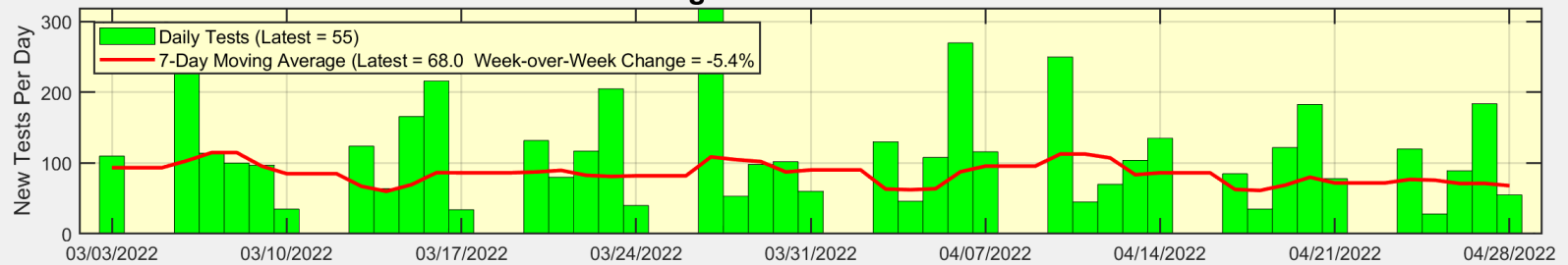

New Cases, New Tests, and Test Positivity for Ridgefield

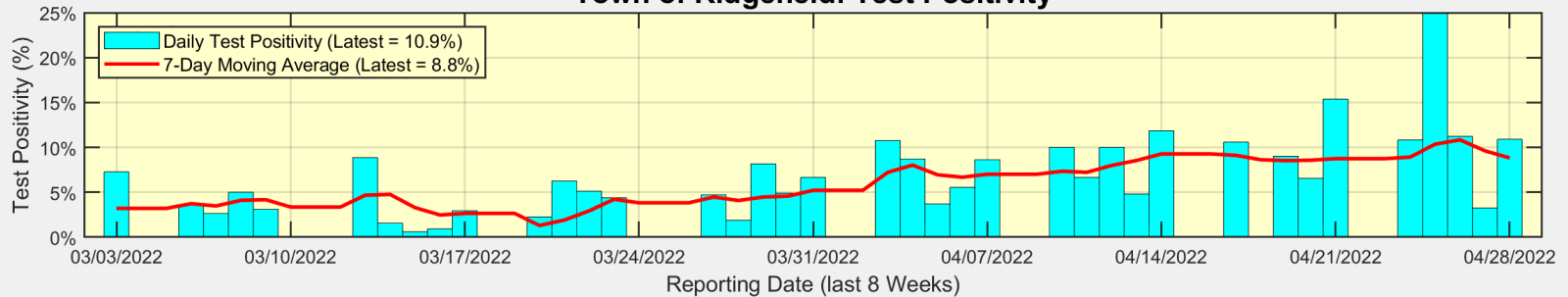
Town of Ridgefield: Number of New Cases (as of 04/28/2022)

Town of Ridgefield: Test Positivity



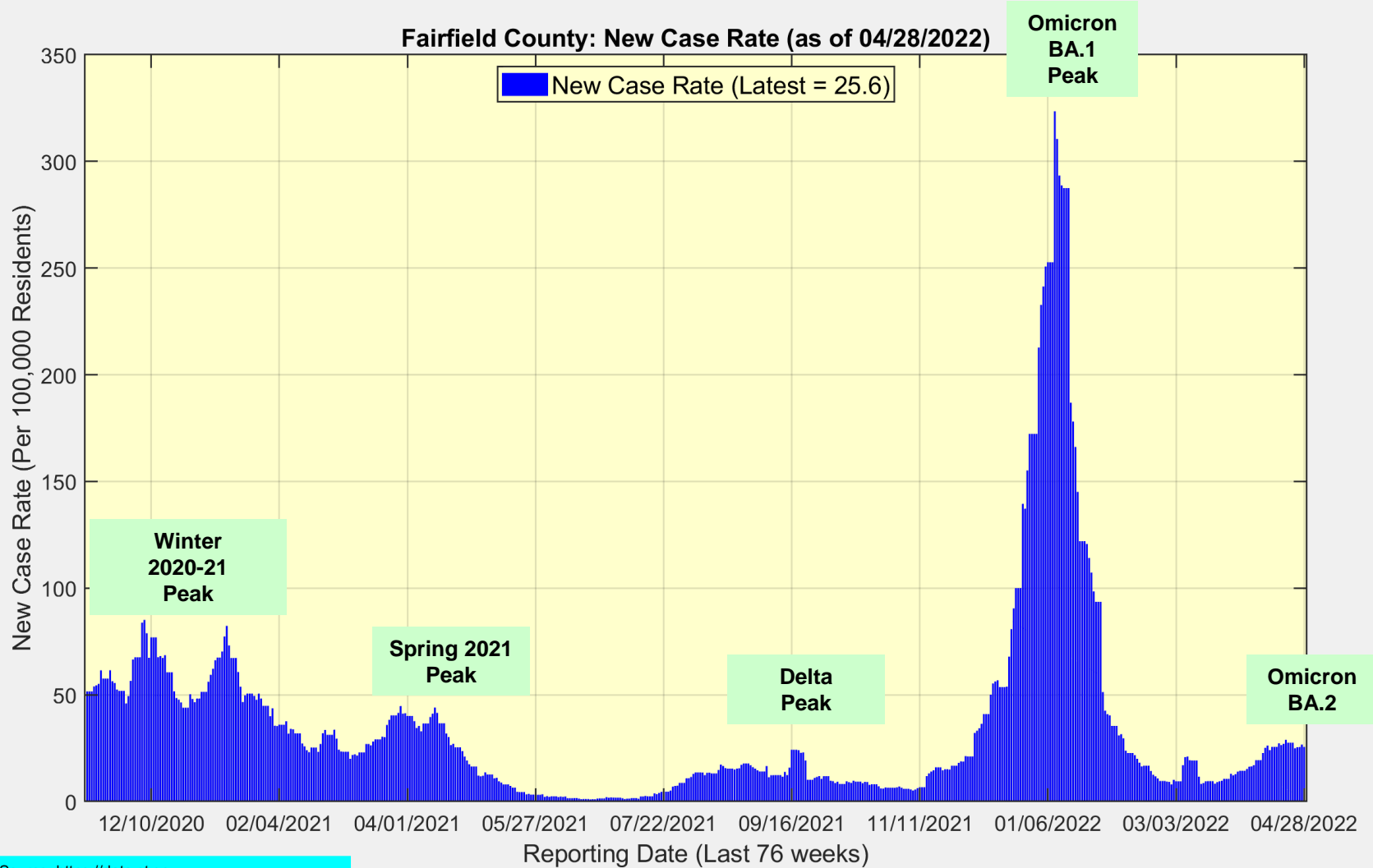

Fairfield County: New Case Rate



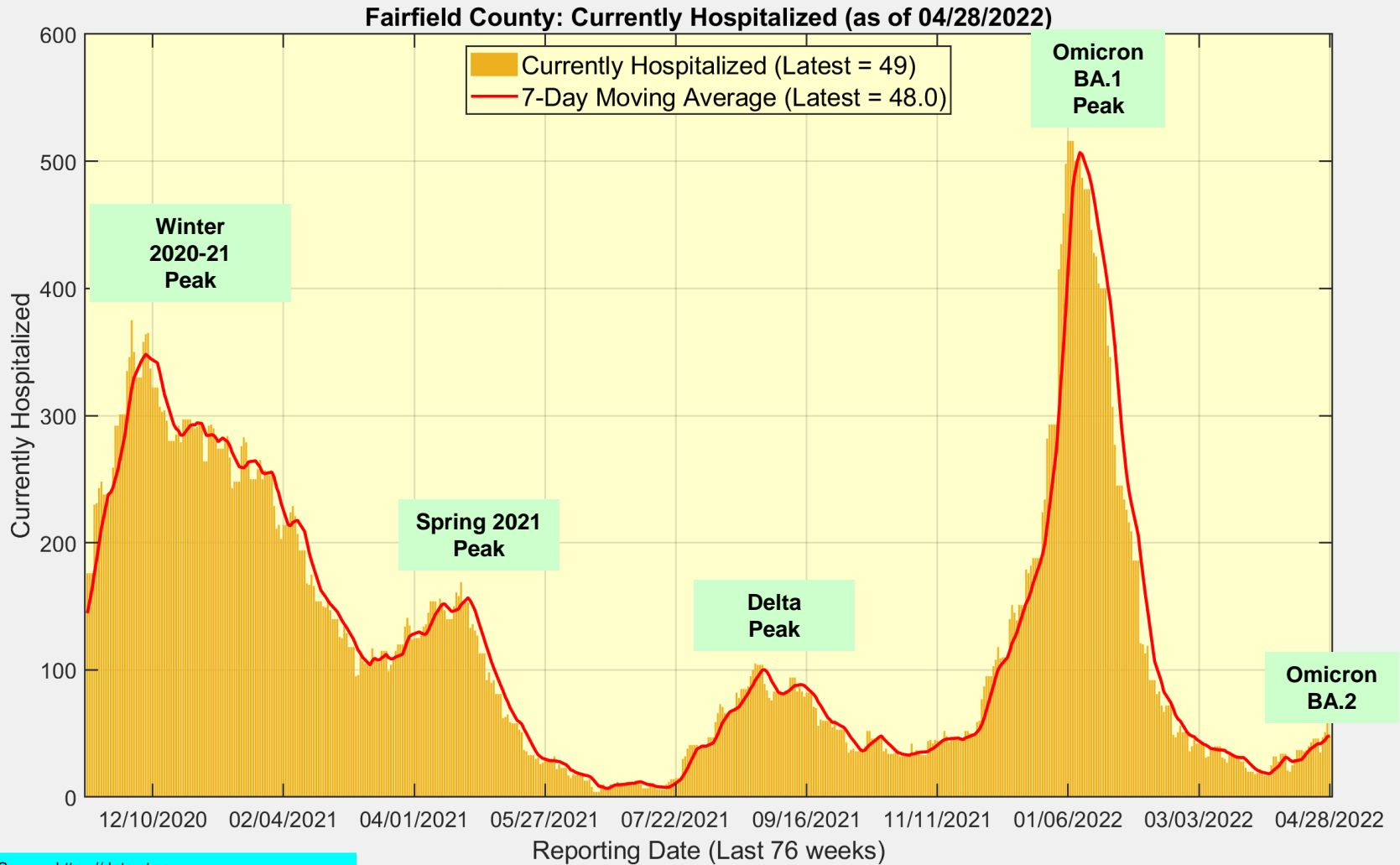

Fairfield County: Currently Hospitalized

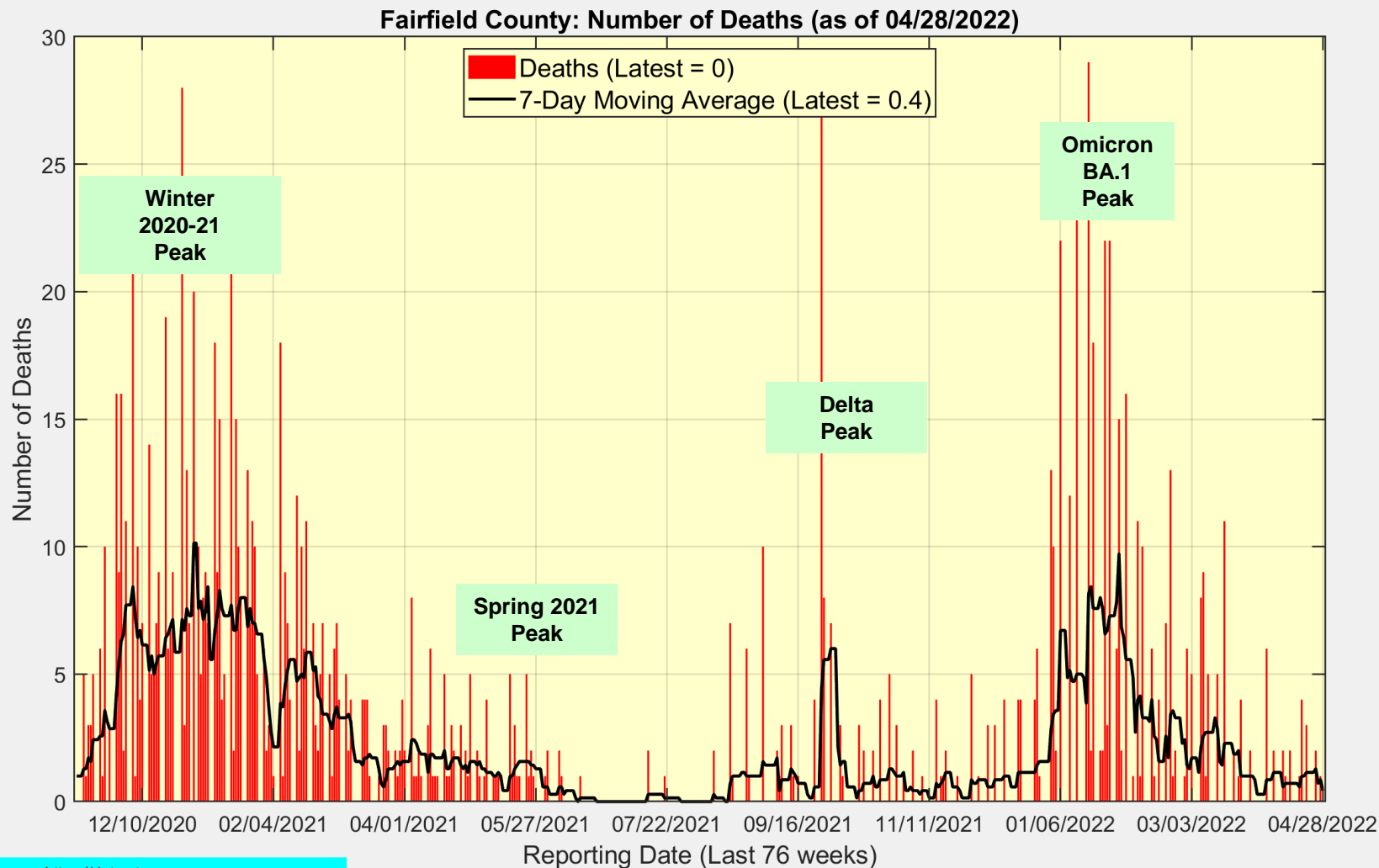

Fairfield County: Number of Deaths



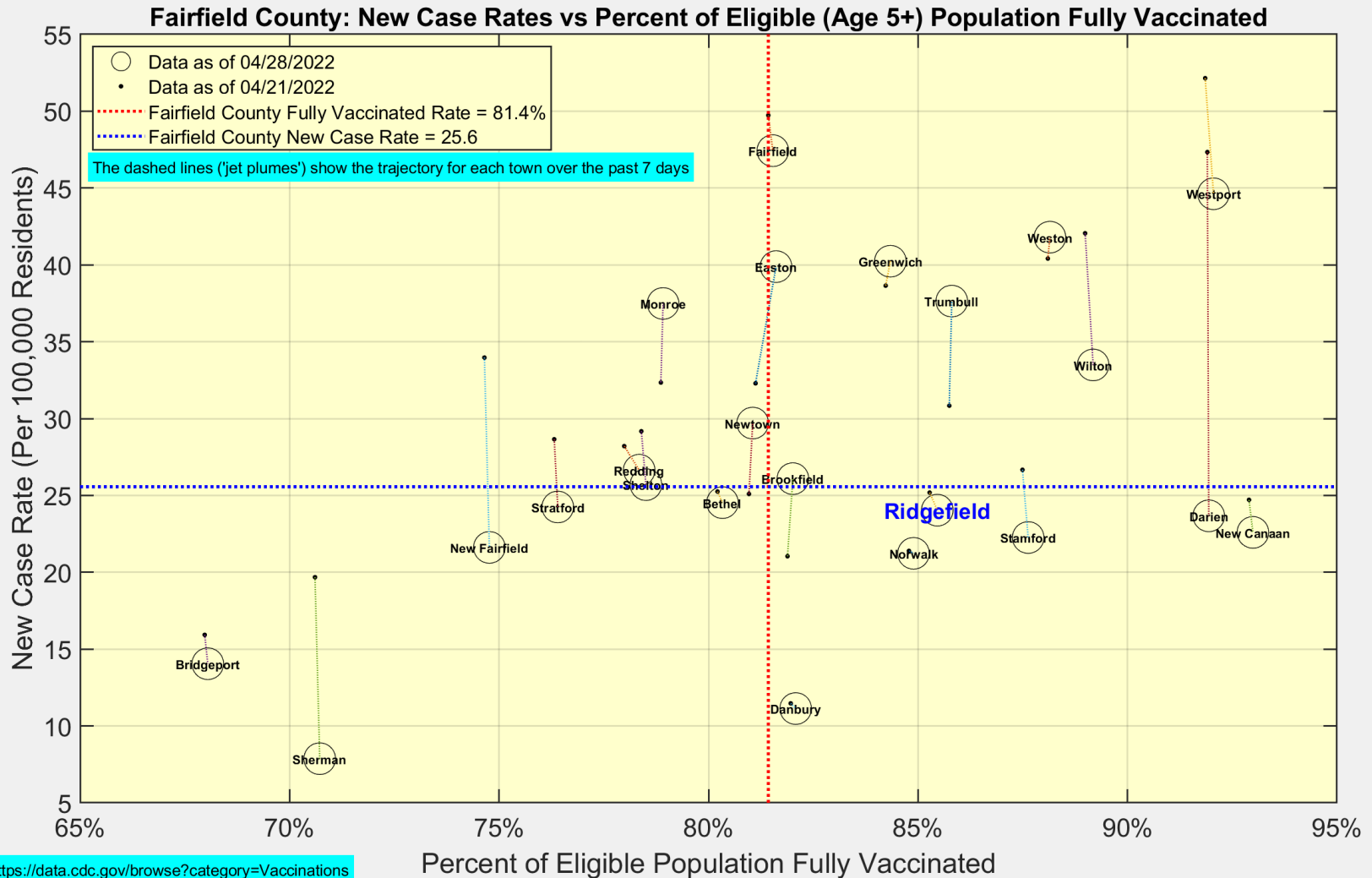

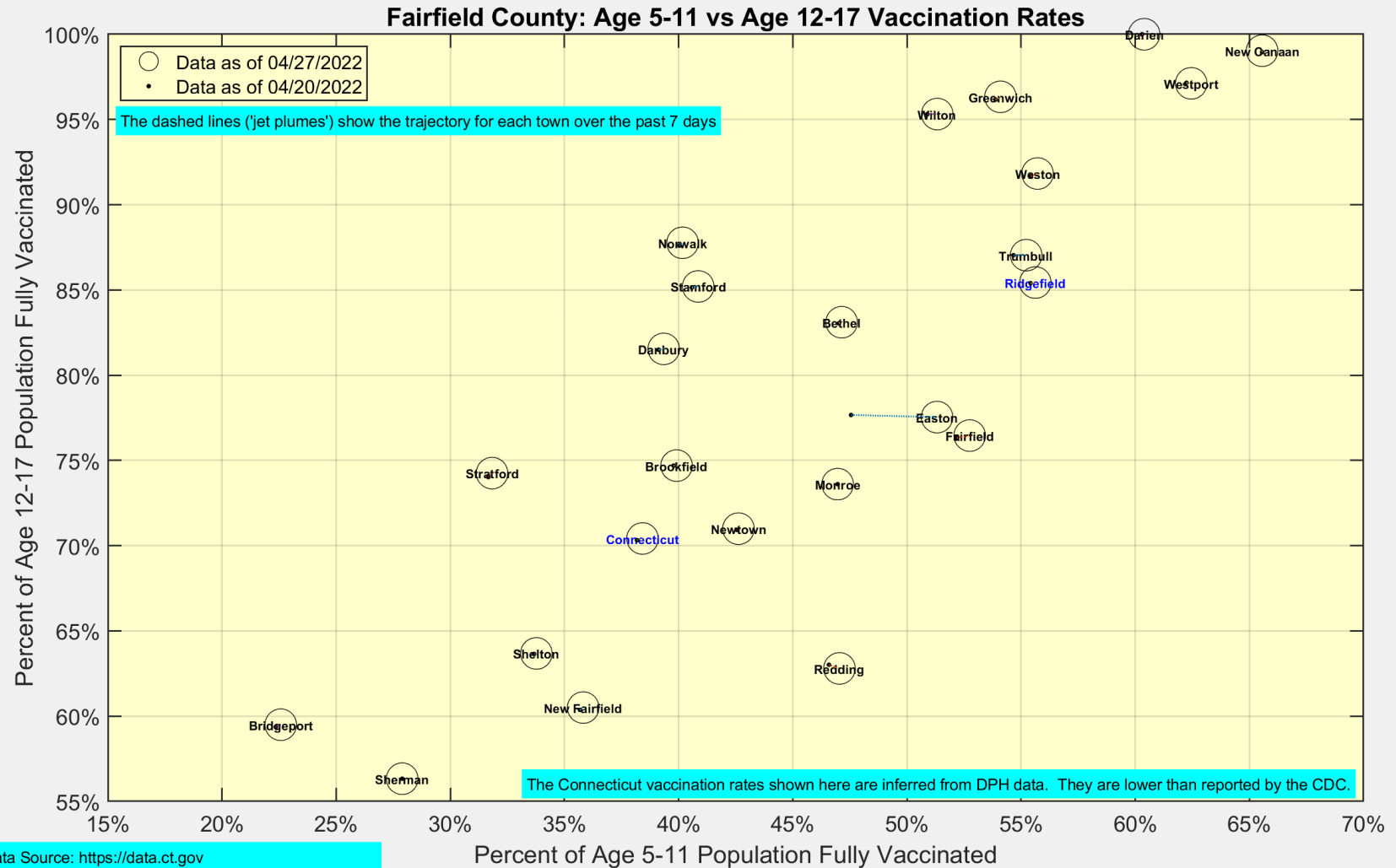

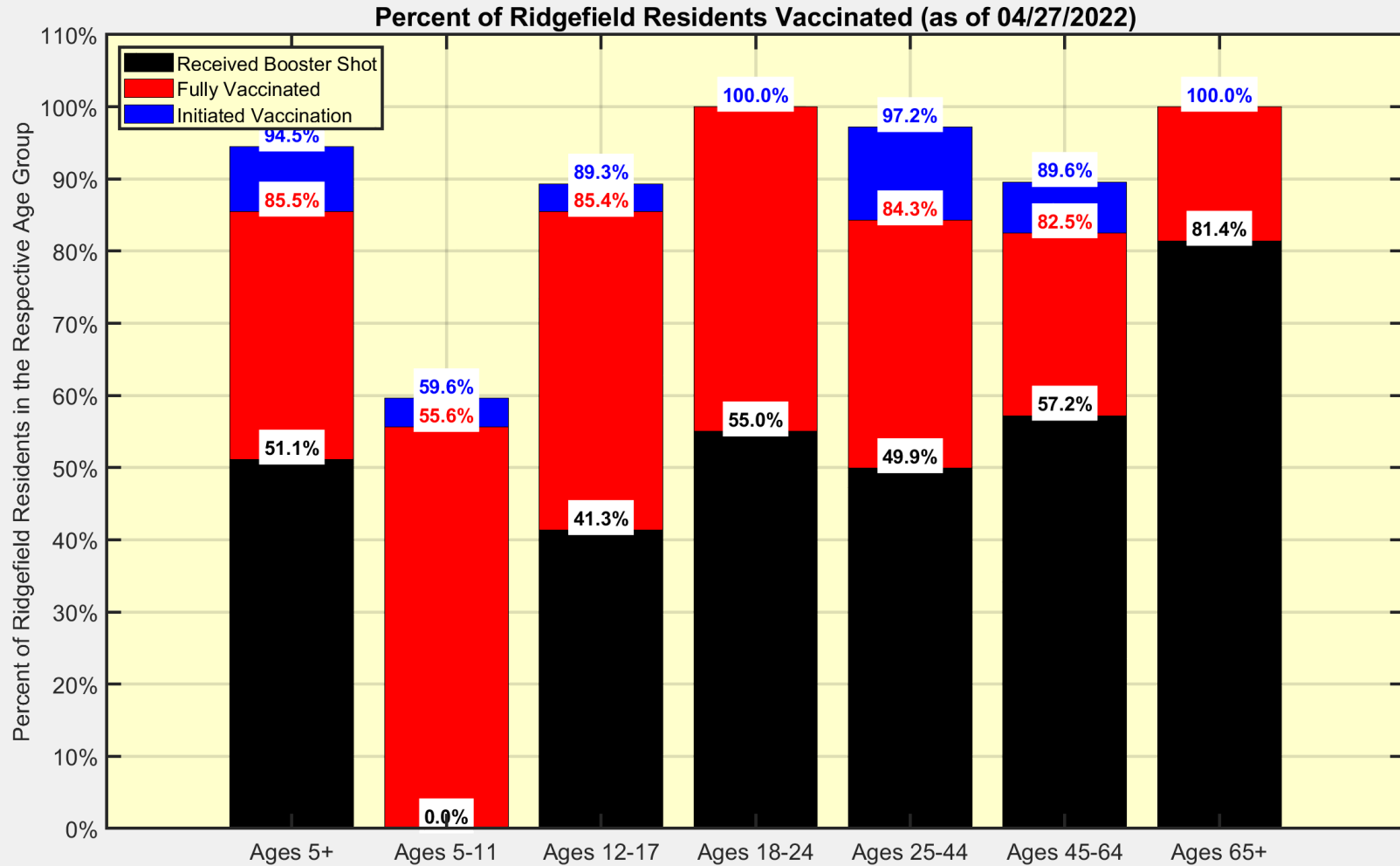

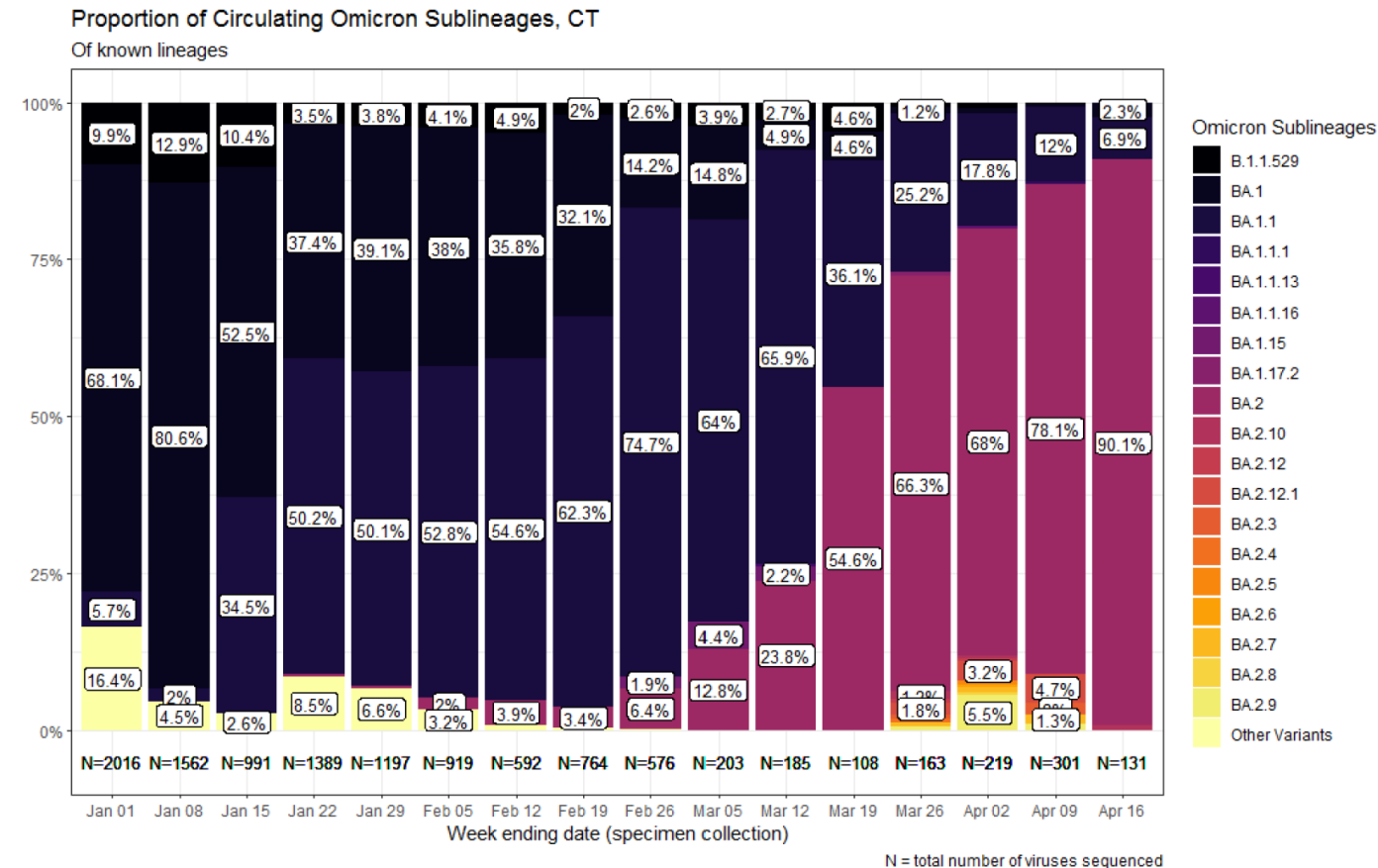

Latest Data for Connecticut shows over 90% prevalence of the BA.2 variant

The figure below shows the change in proportion of circulating variants of concern by week reported to DPH through April 27, 2022. Variants identified as Omicron are shown by sublineage and all other variants are included as "Other Variants". Data include sequences from specimens with dates of collection from 12/26/2021–04/18/2022.
