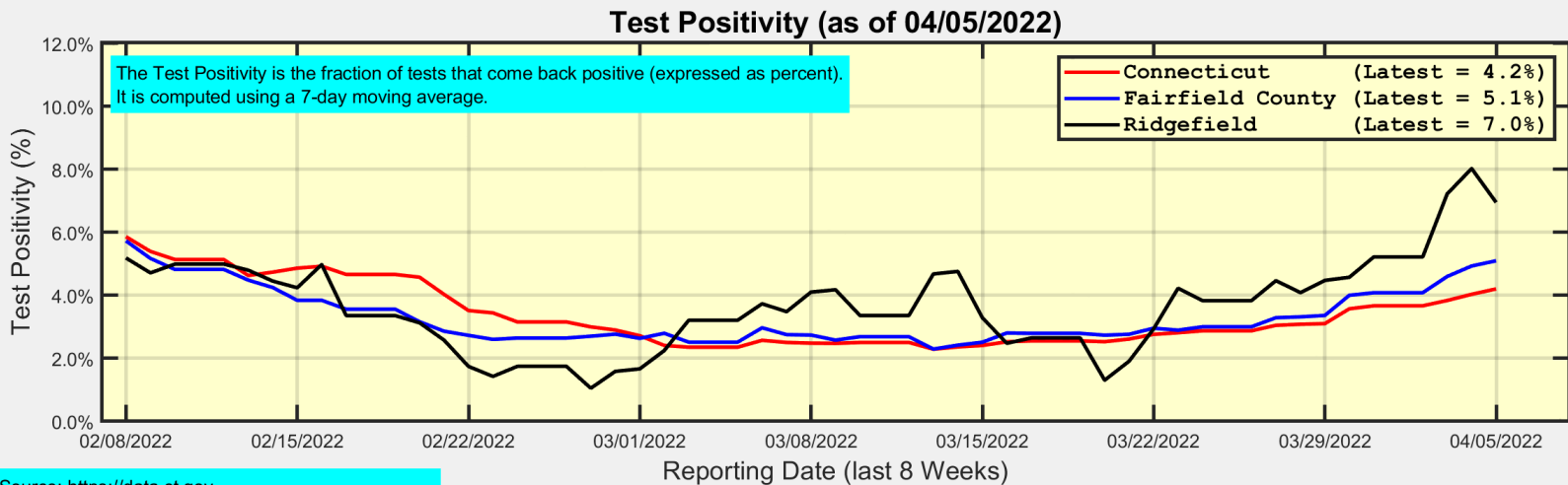
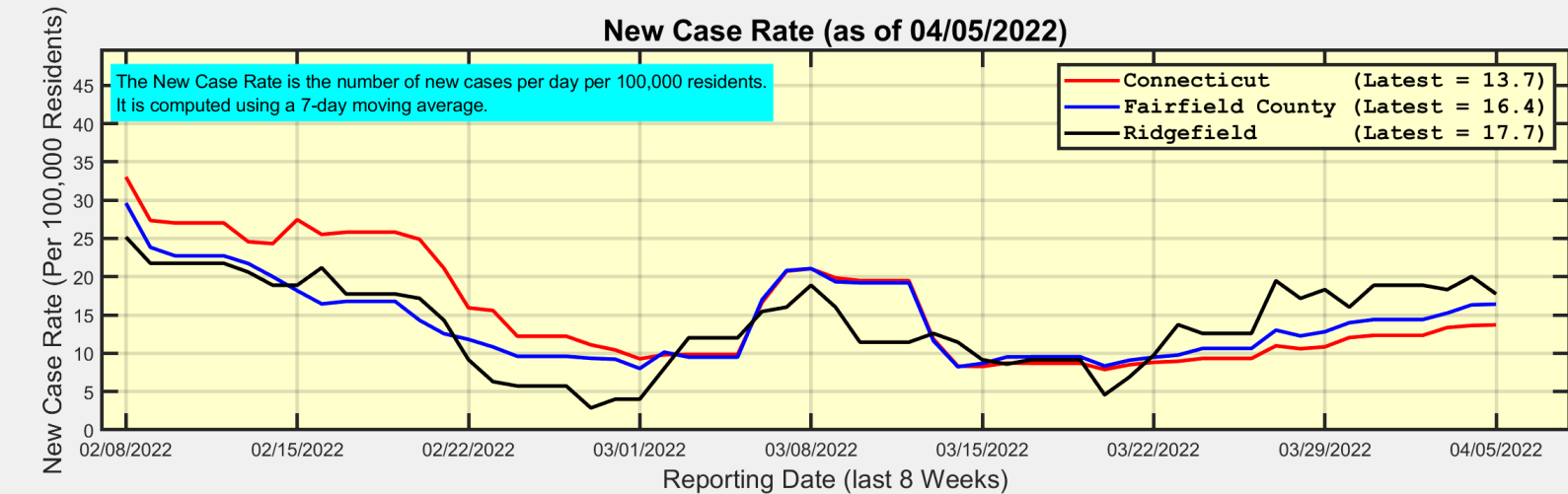

# New Case Rates and Test Positivity for Connecticut, Fairfield County, and Ridgefield



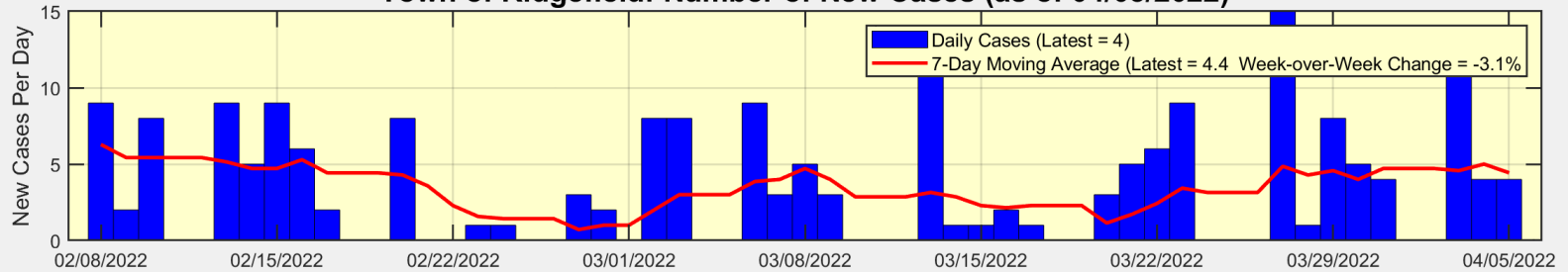

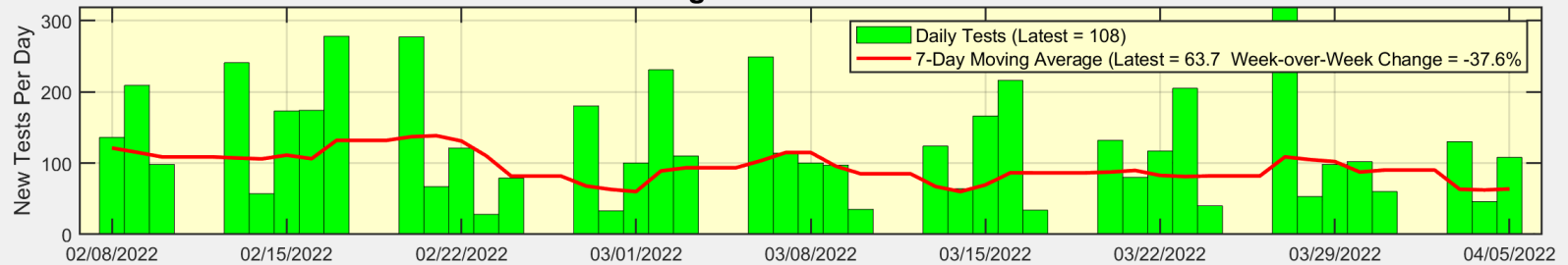

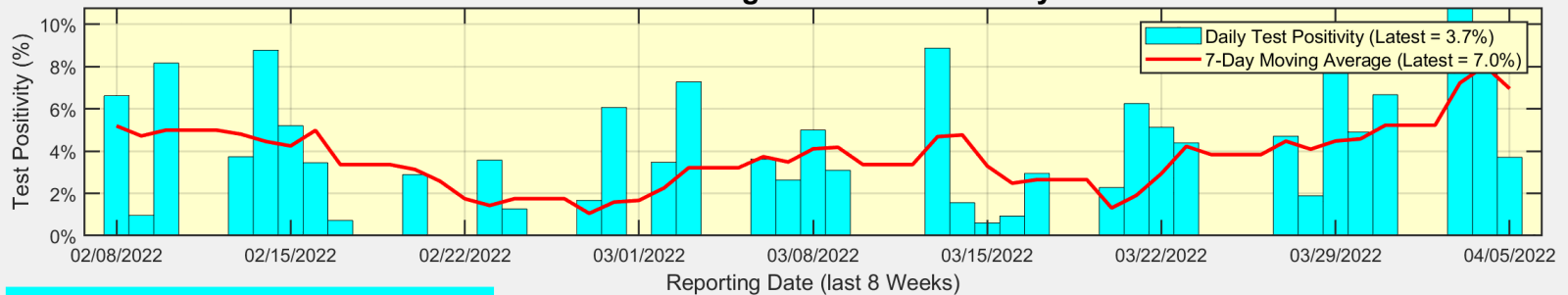
**Town of Ridgefield: Number of New Cases (as of 04/05/2022)**

**Town of Ridgefield: Test Positivity**

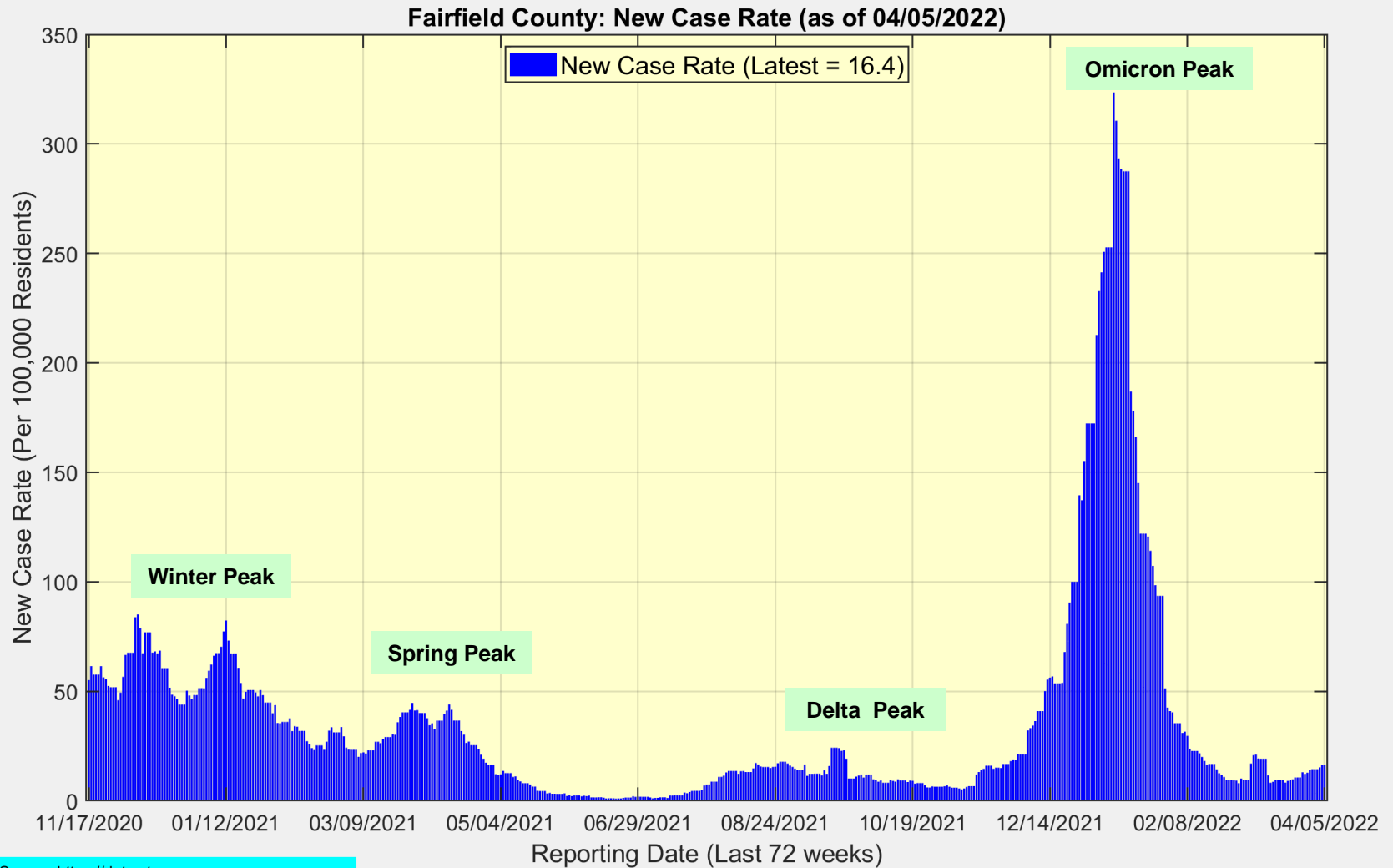

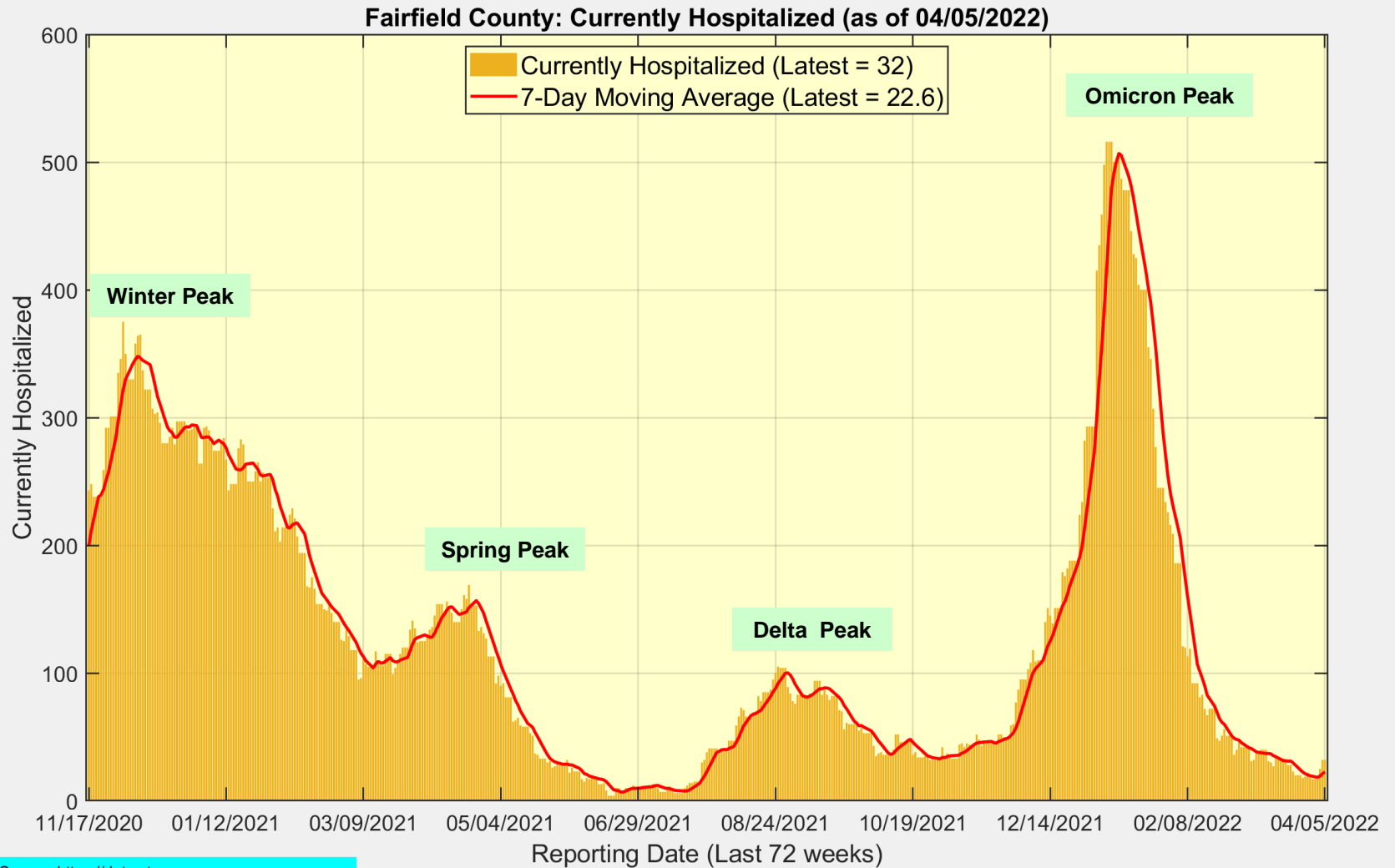

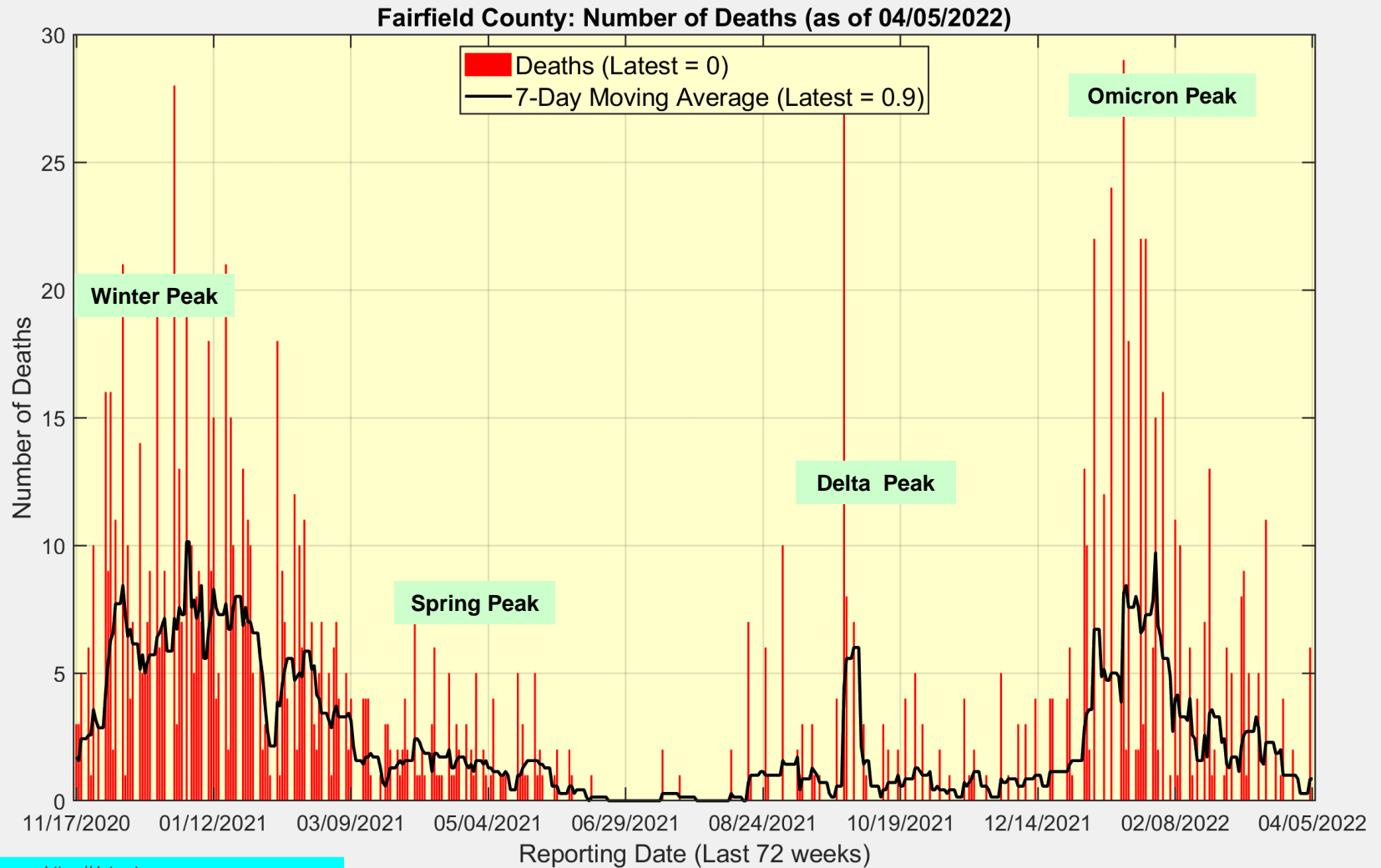
# Fairfield County: New Case Rate

# Fairfield County: Number of Deaths



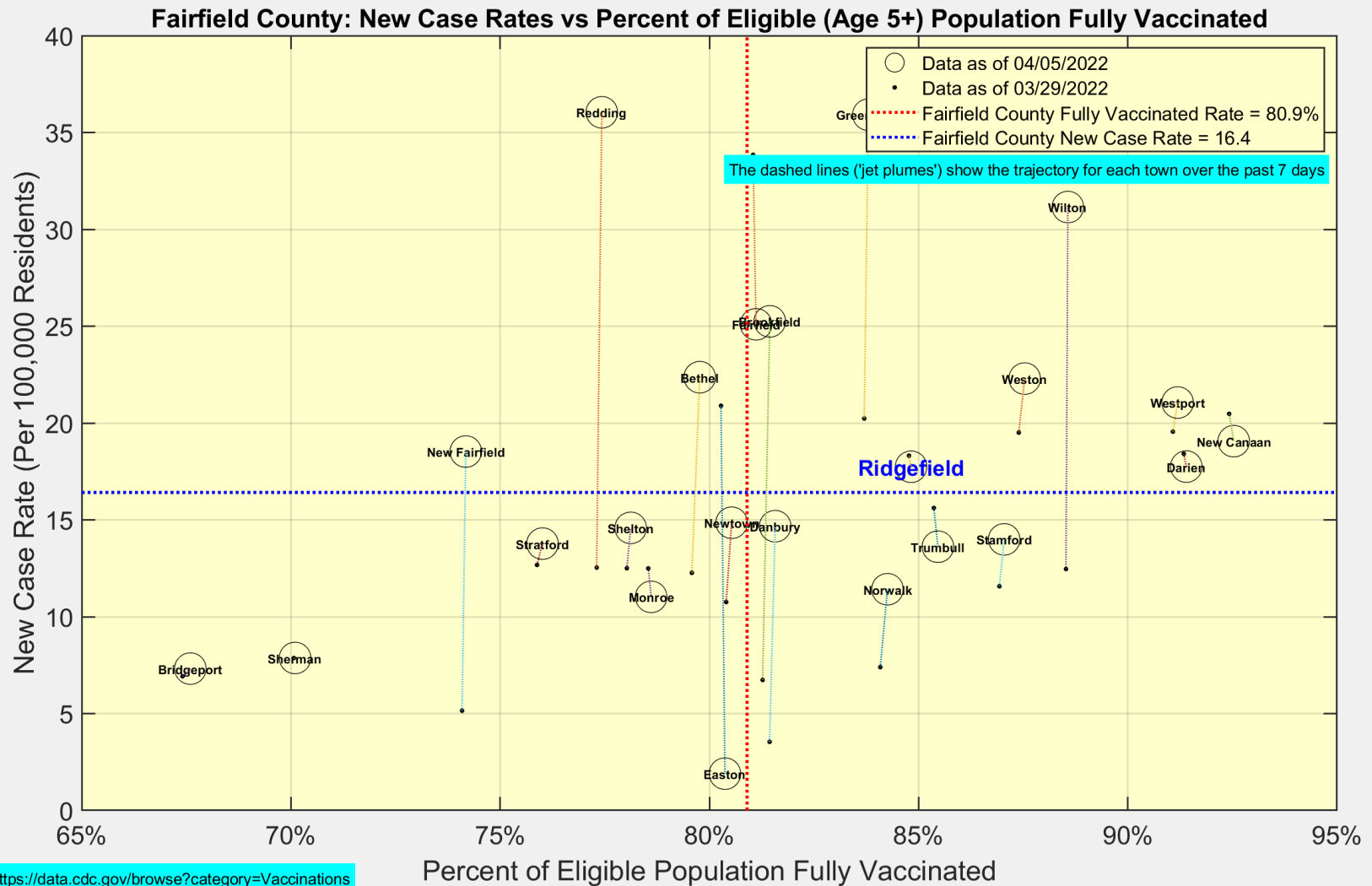

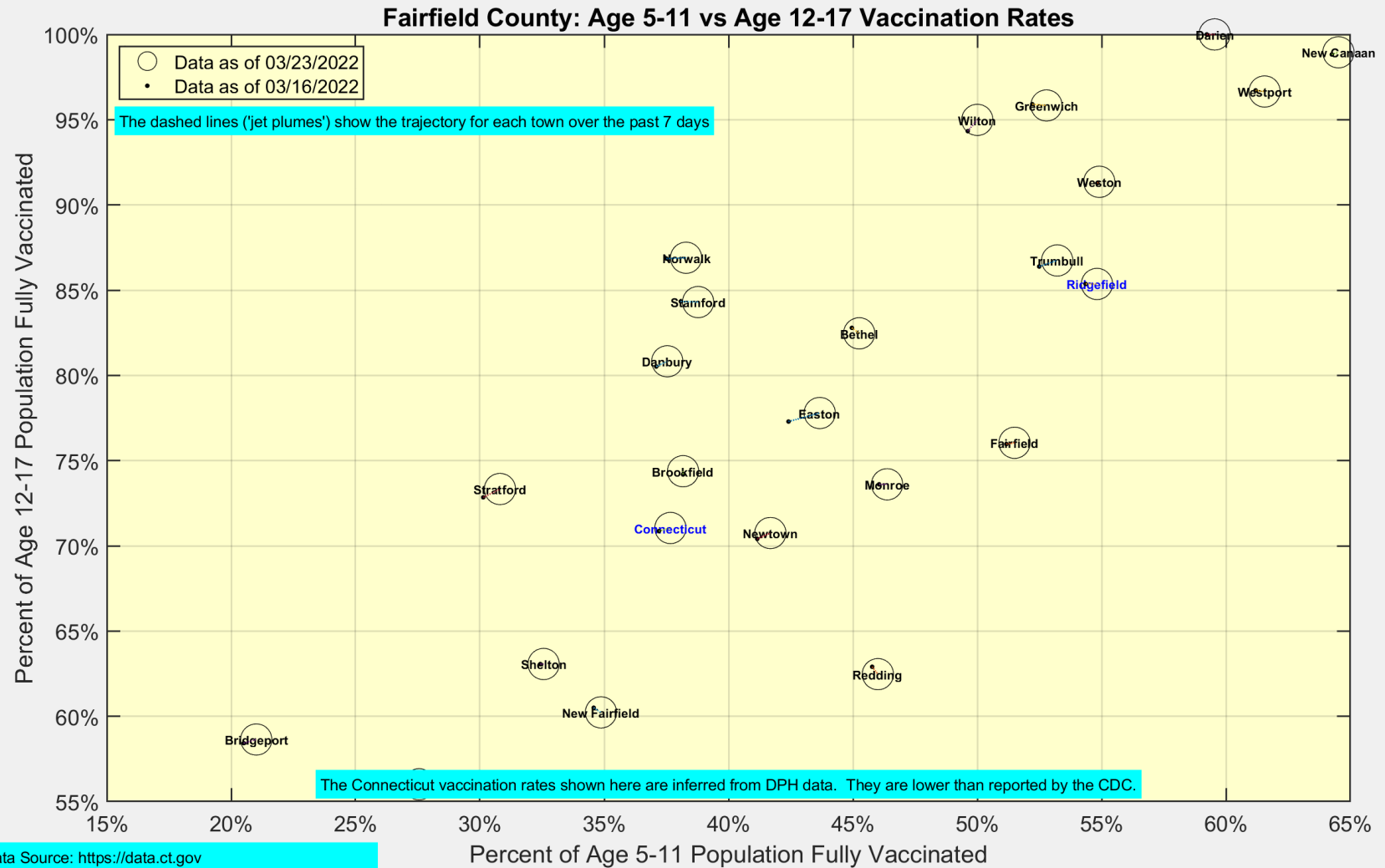

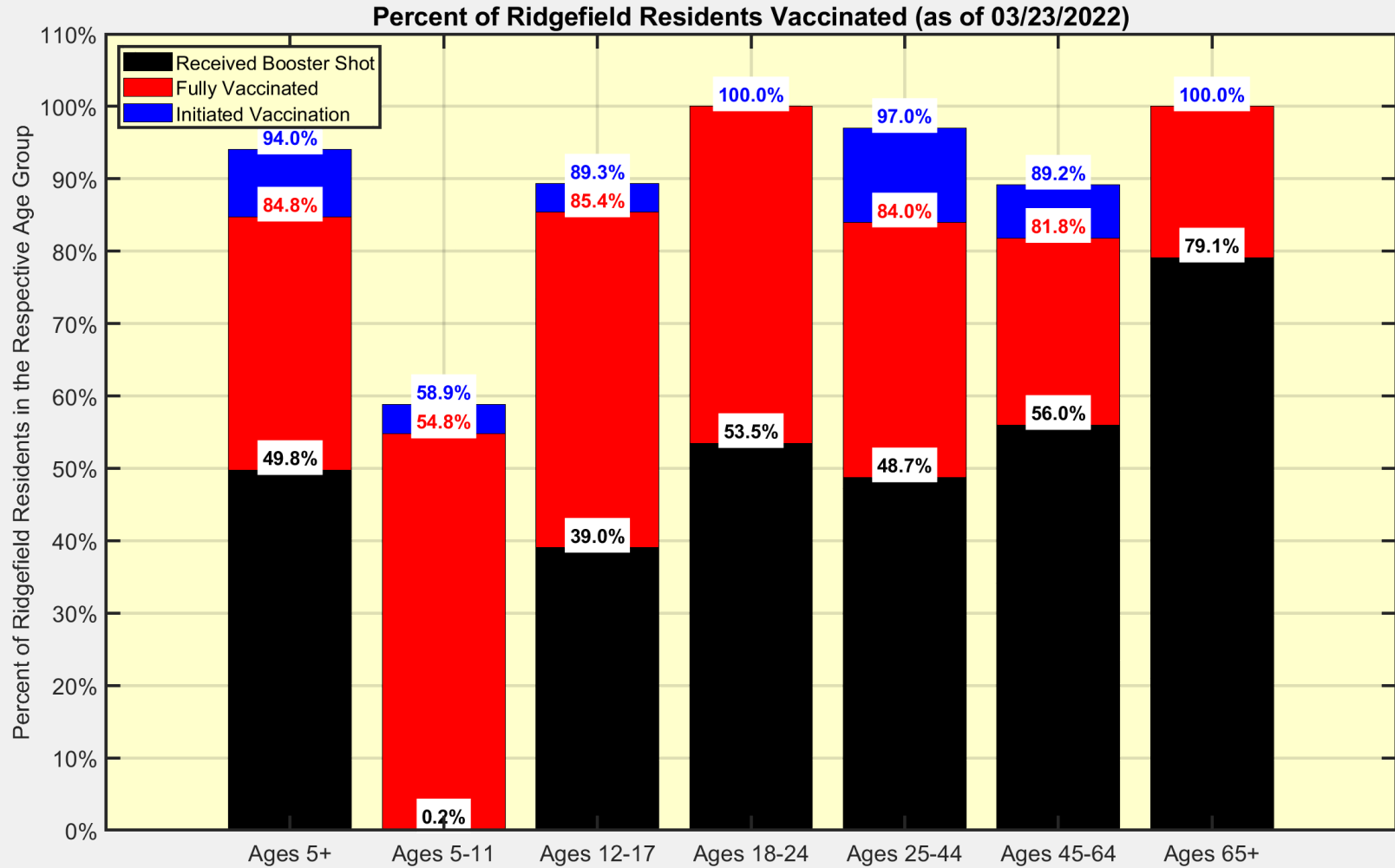

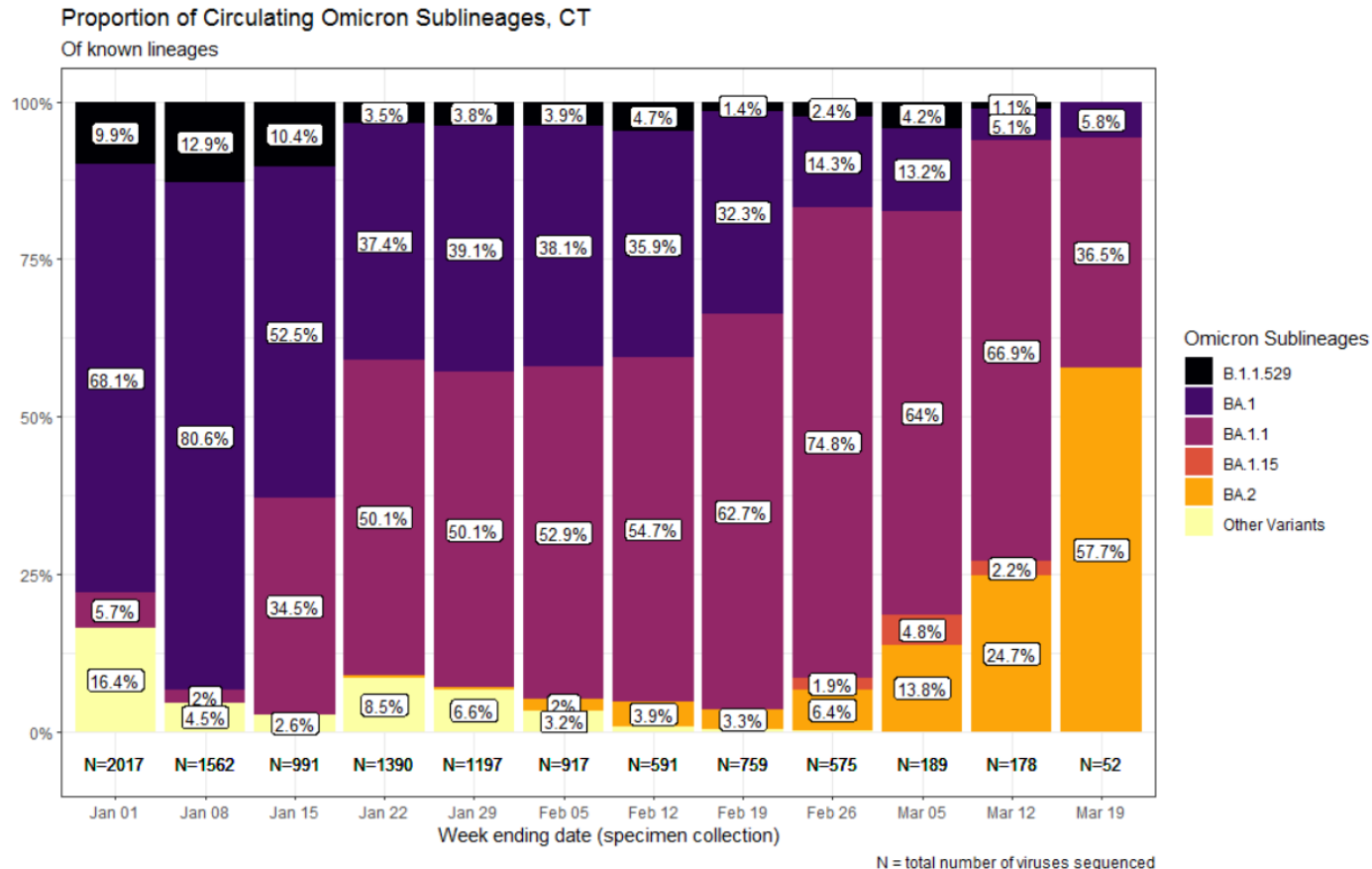

## Latest Data for Connecticut shows increasing incidence of BA.2 variant

The figure below shows the change in proportion of circulating variants of concern by week reported to DPH through March 30, 2022. Variants identified as Omicron are shown by sublineage and all other variants are included as "Other Variants".
