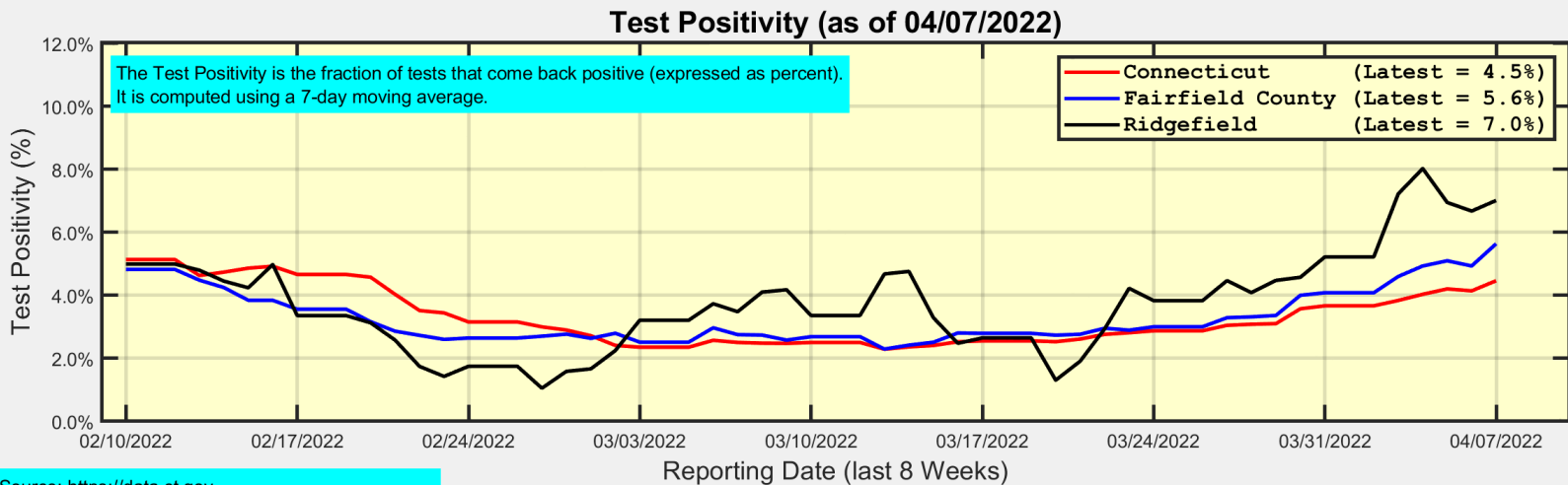
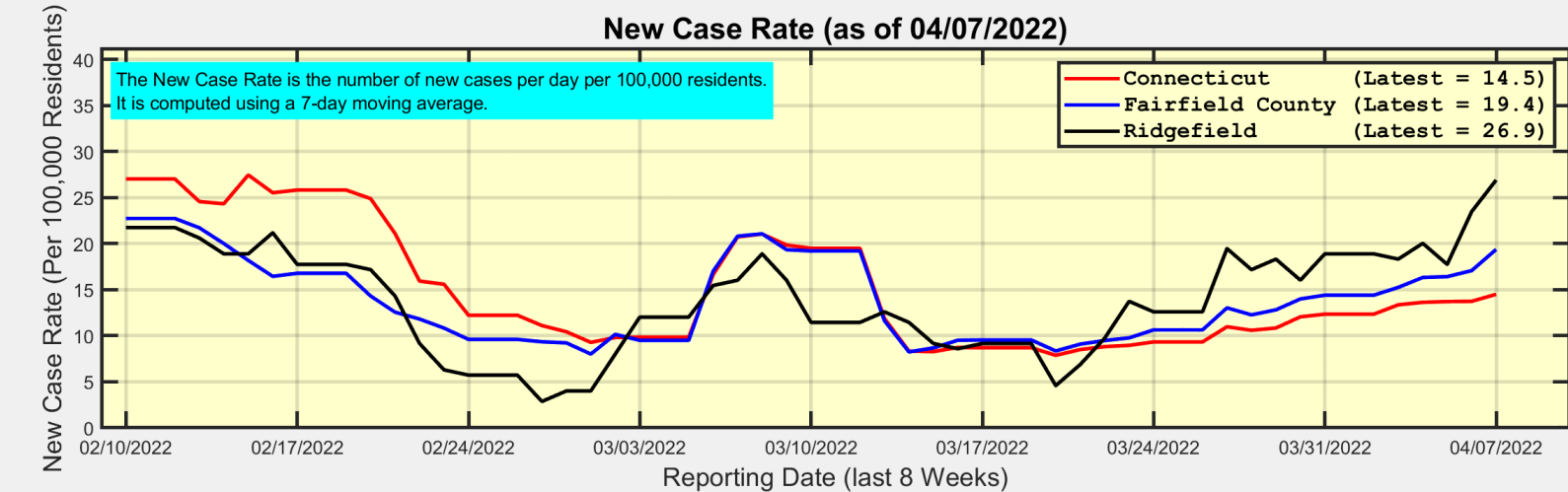

# New Case Rates and Test Positivity for Connecticut, Fairfield County, and Ridgefield

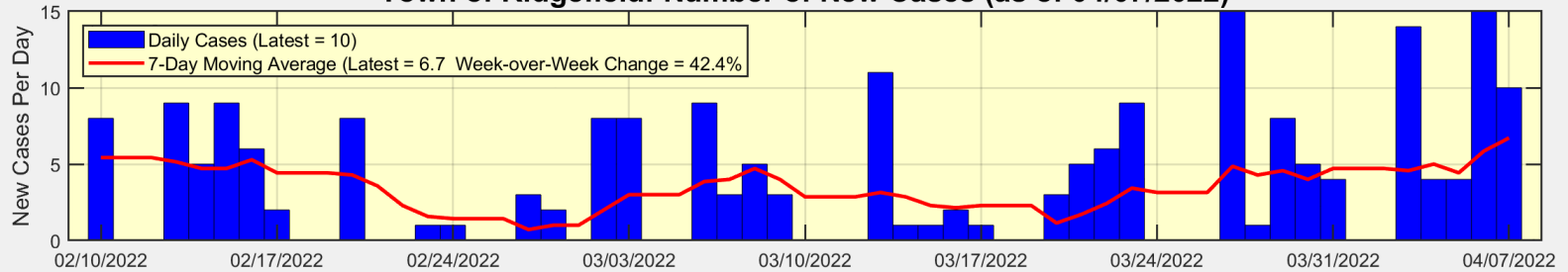

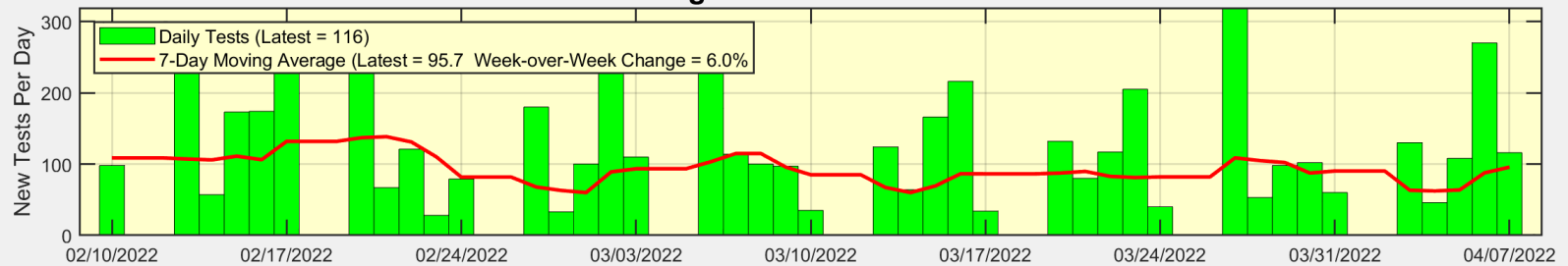

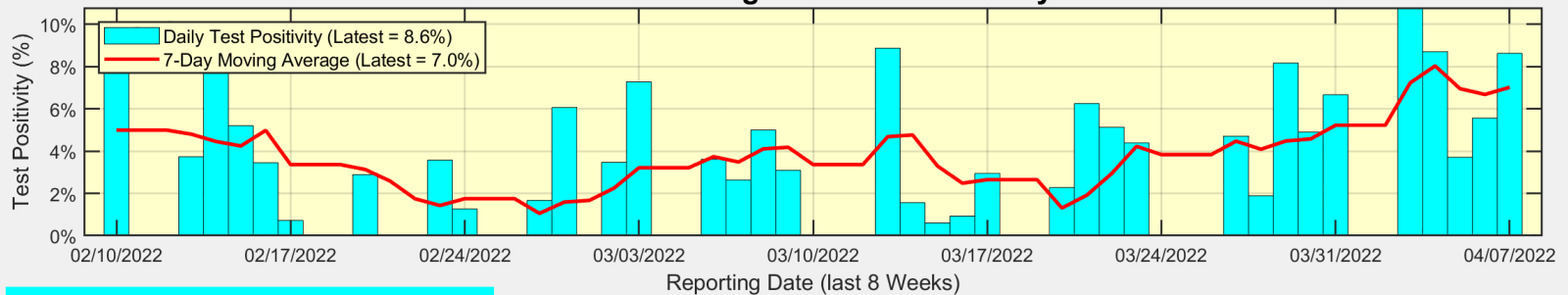
**Town of Ridgefield: Number of New Cases (as of 04/07/2022)**

**Town of Ridgefield: Test Positivity**

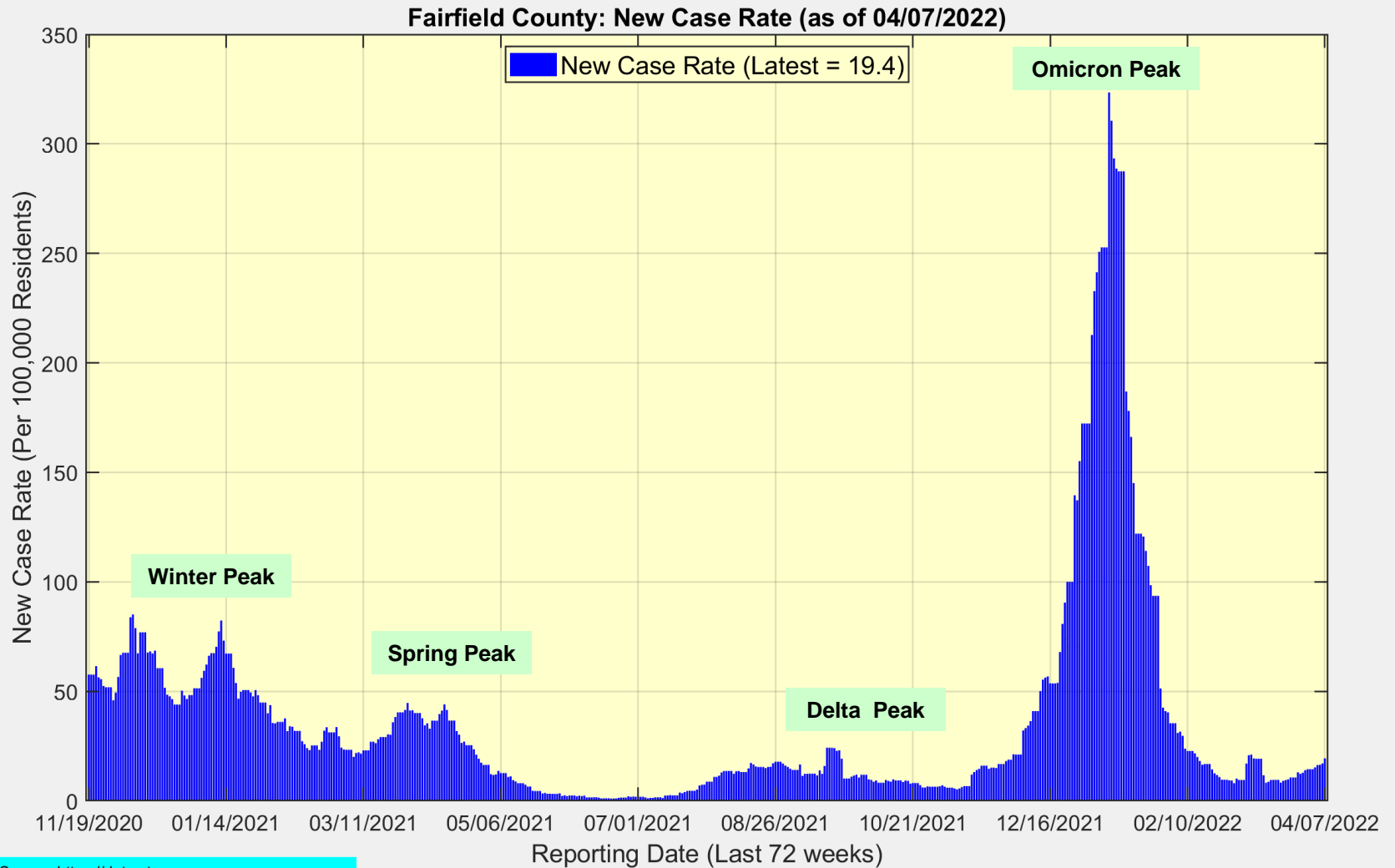

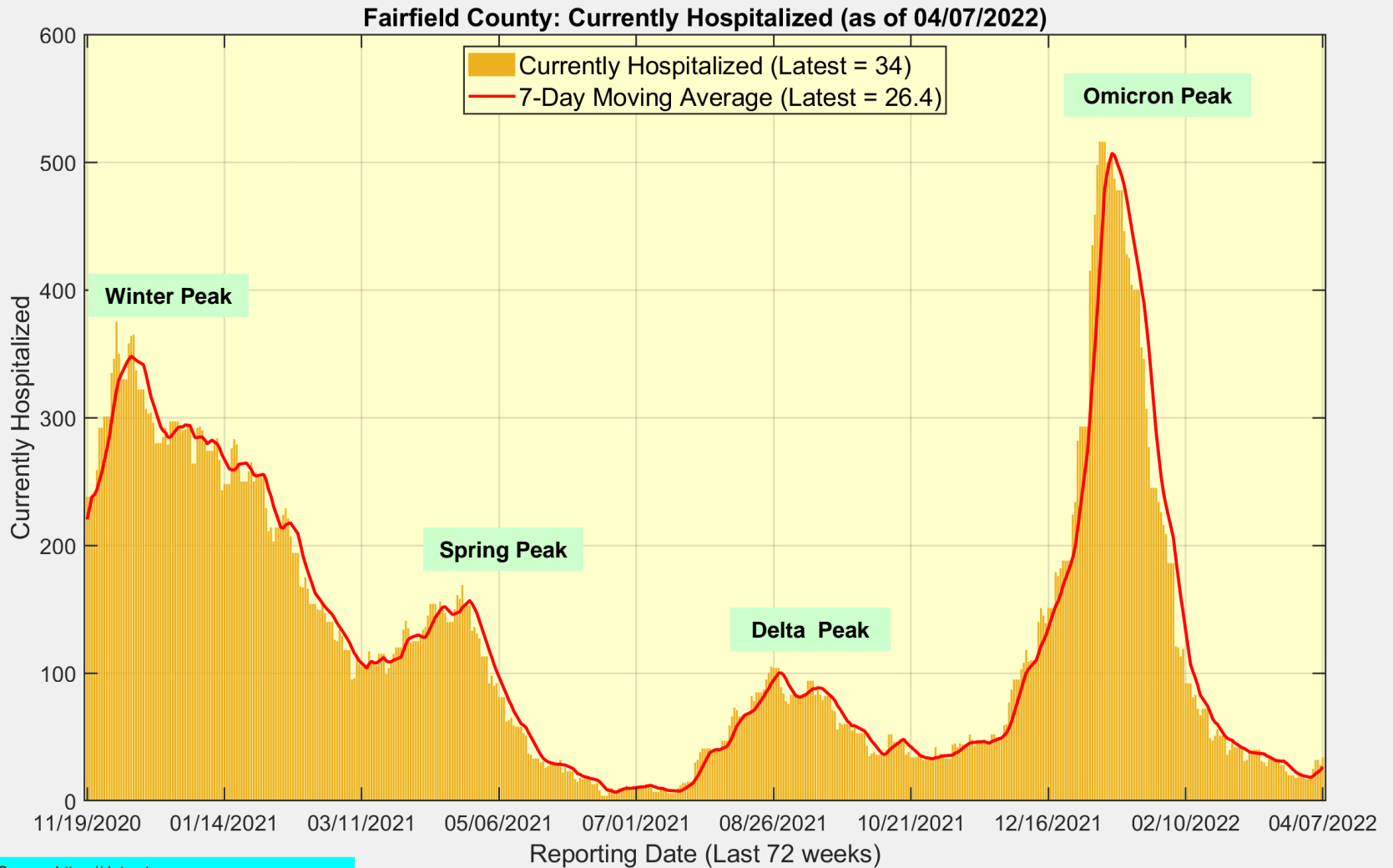

# Fairfield County: Currently Hospitalized



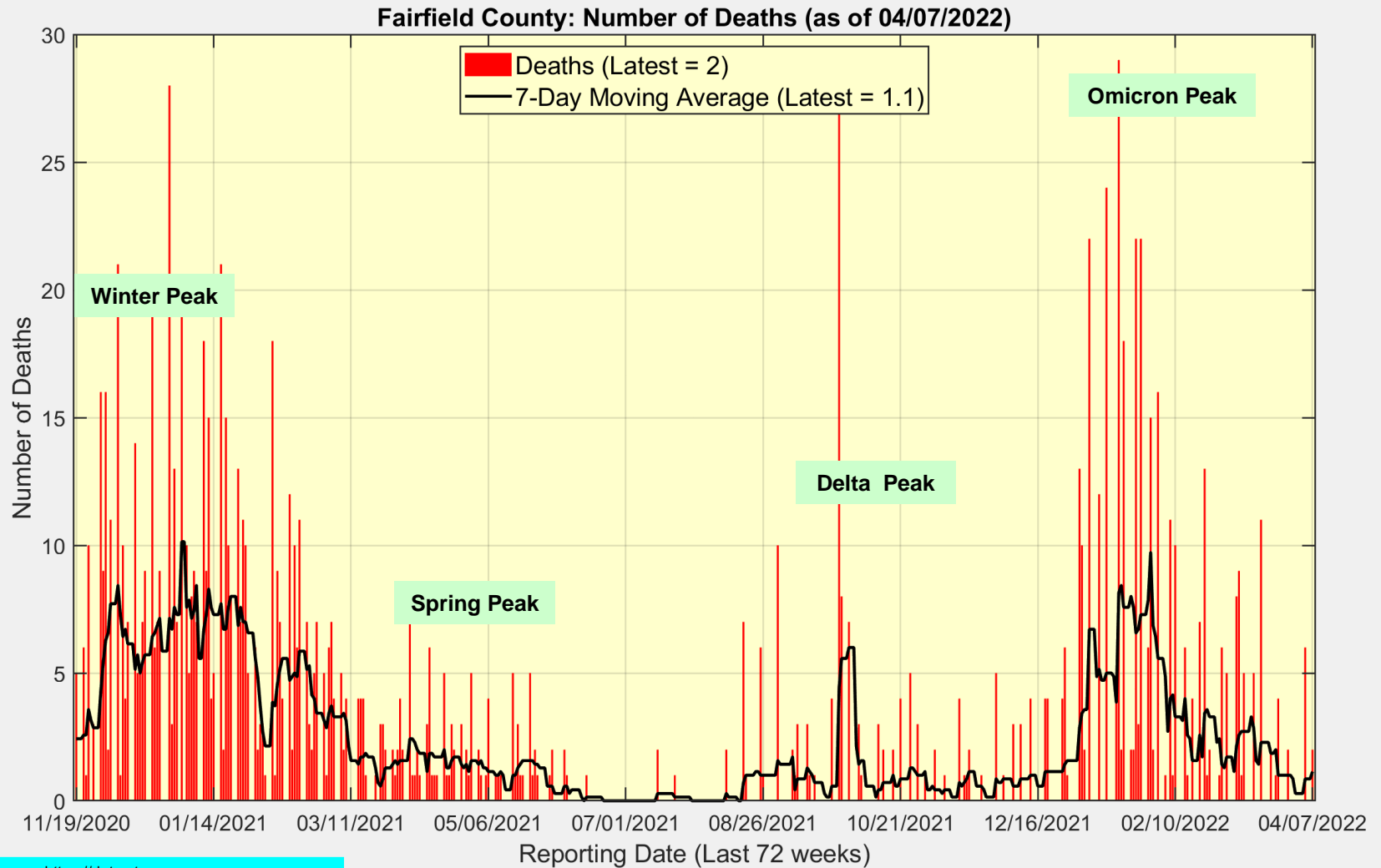

# Fairfield County: Number of Deaths



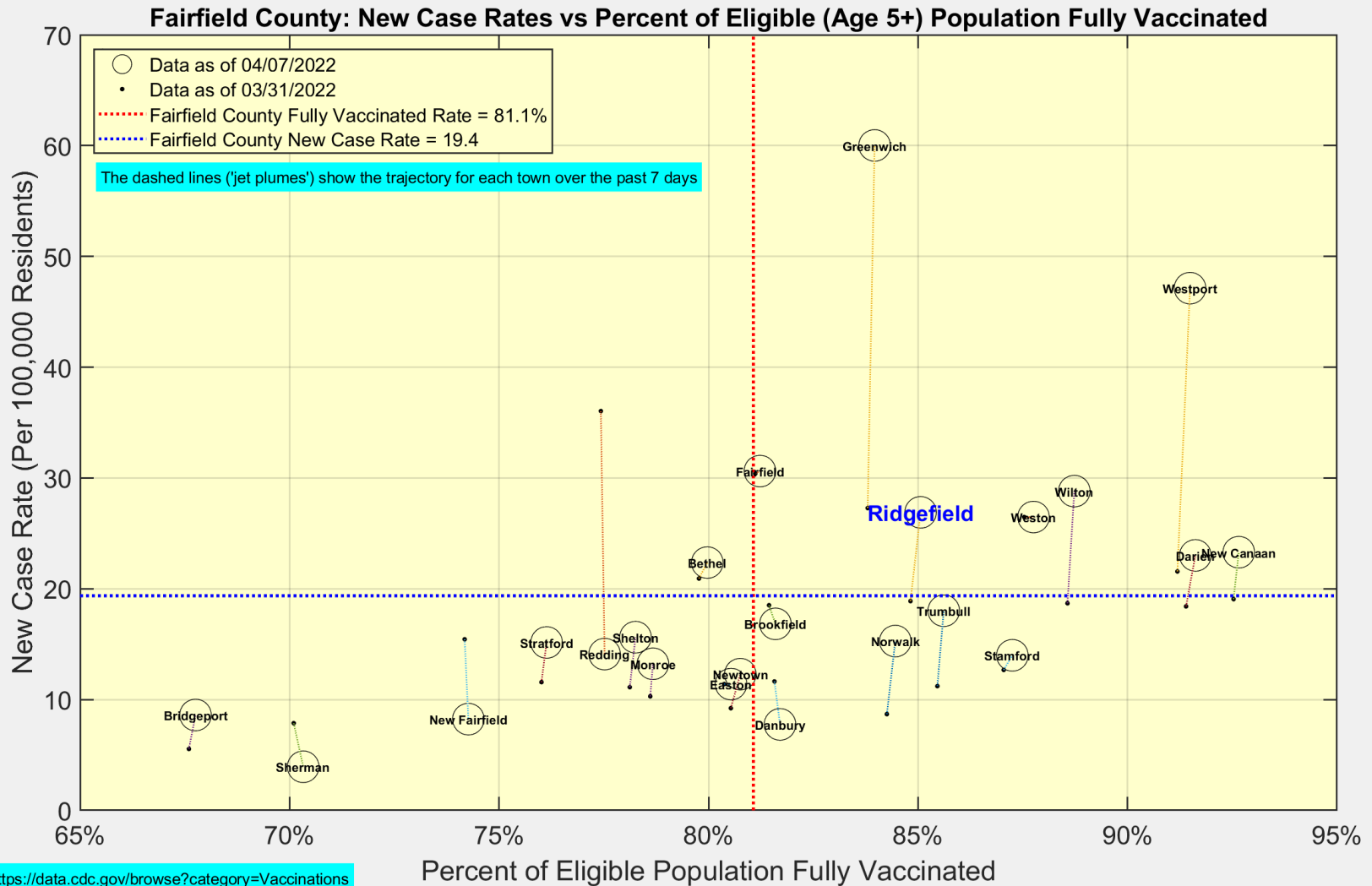

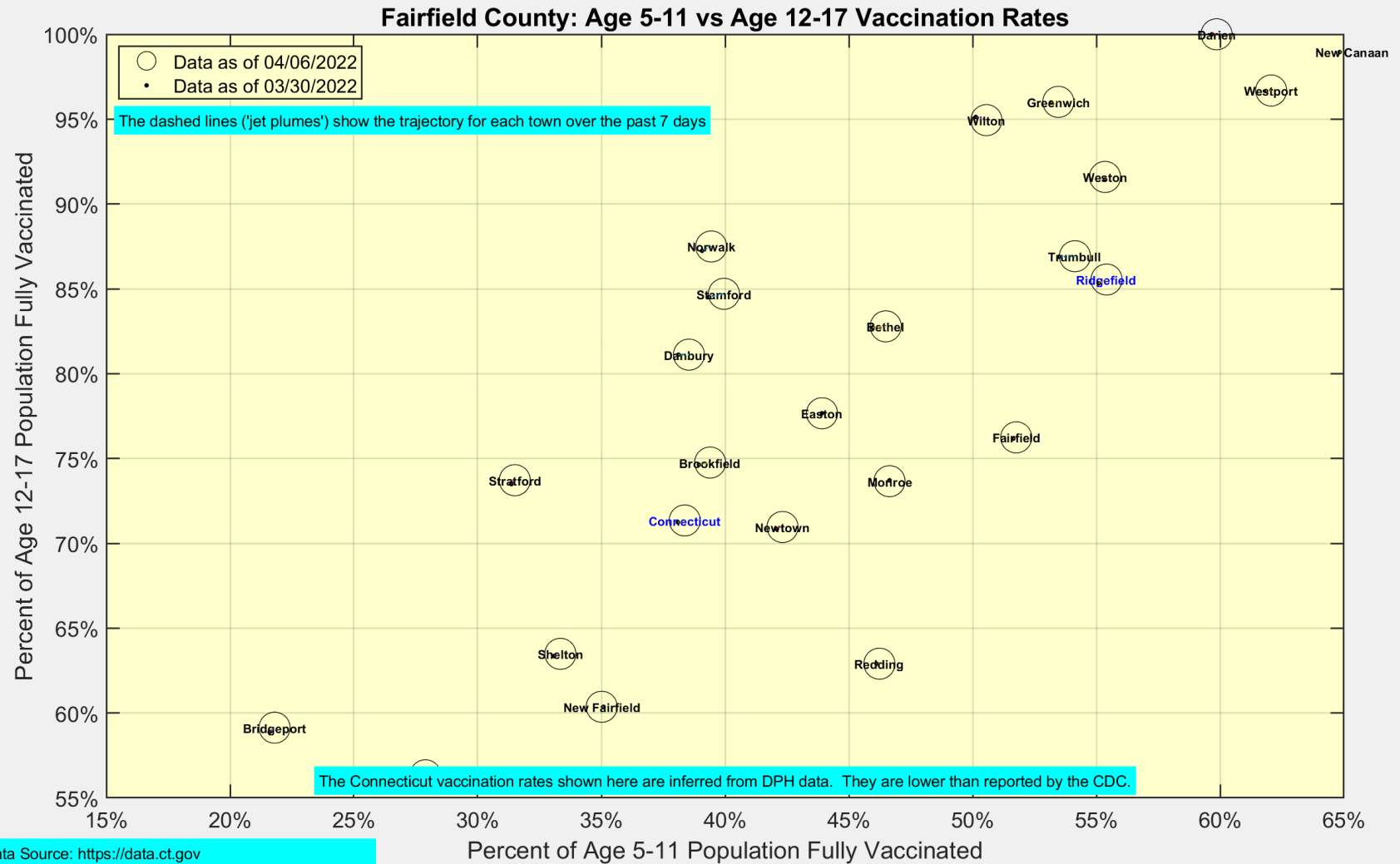

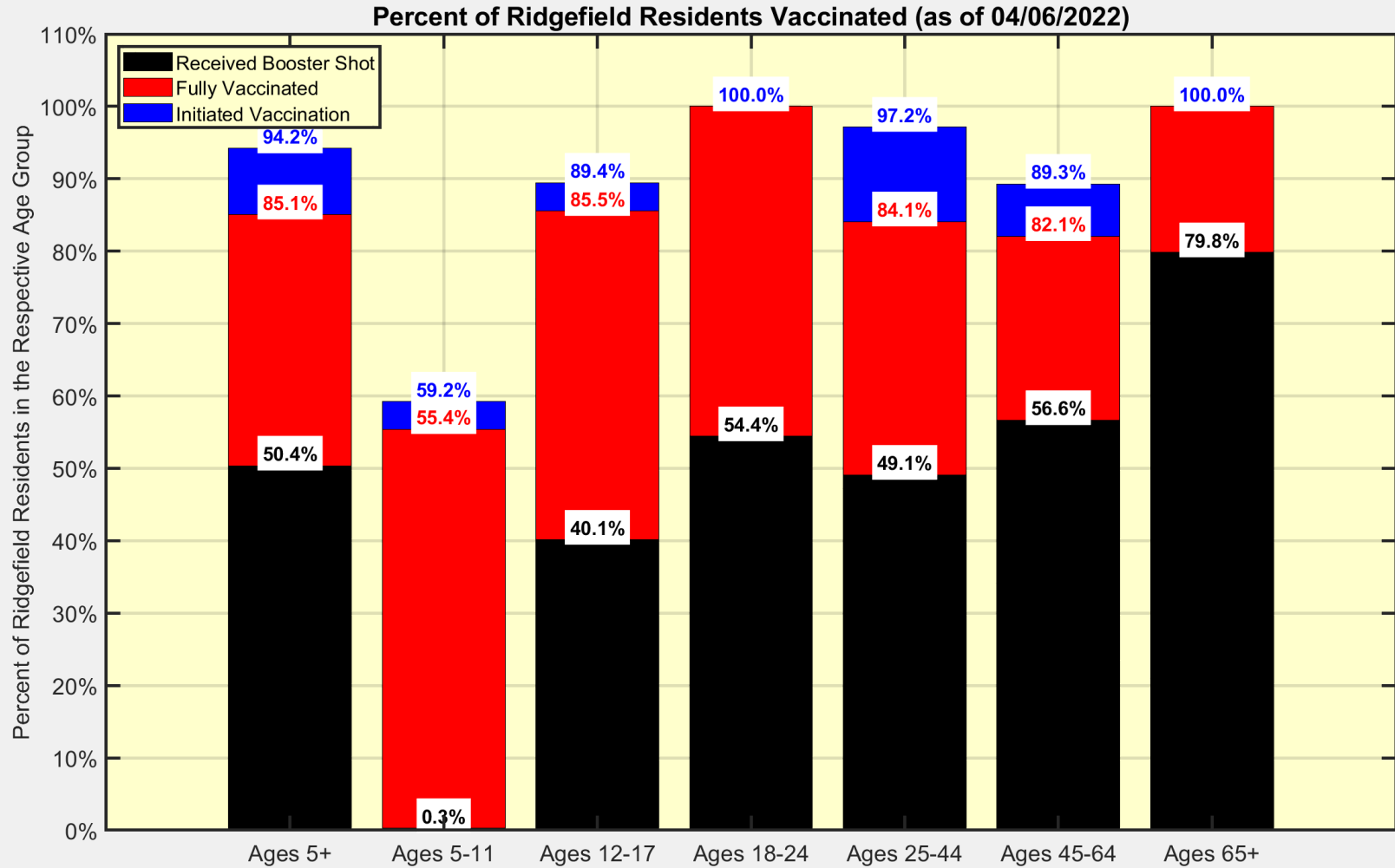

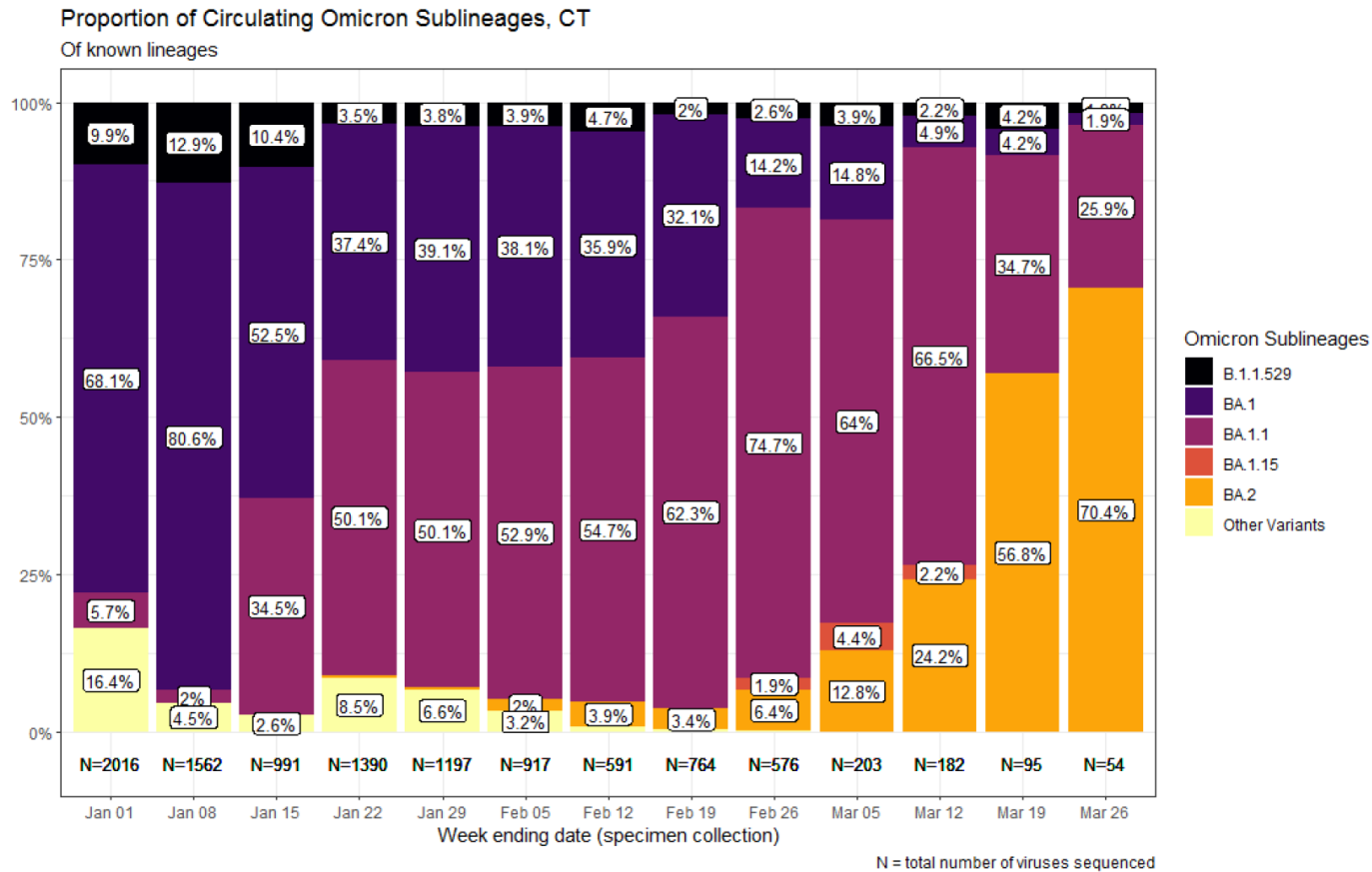
