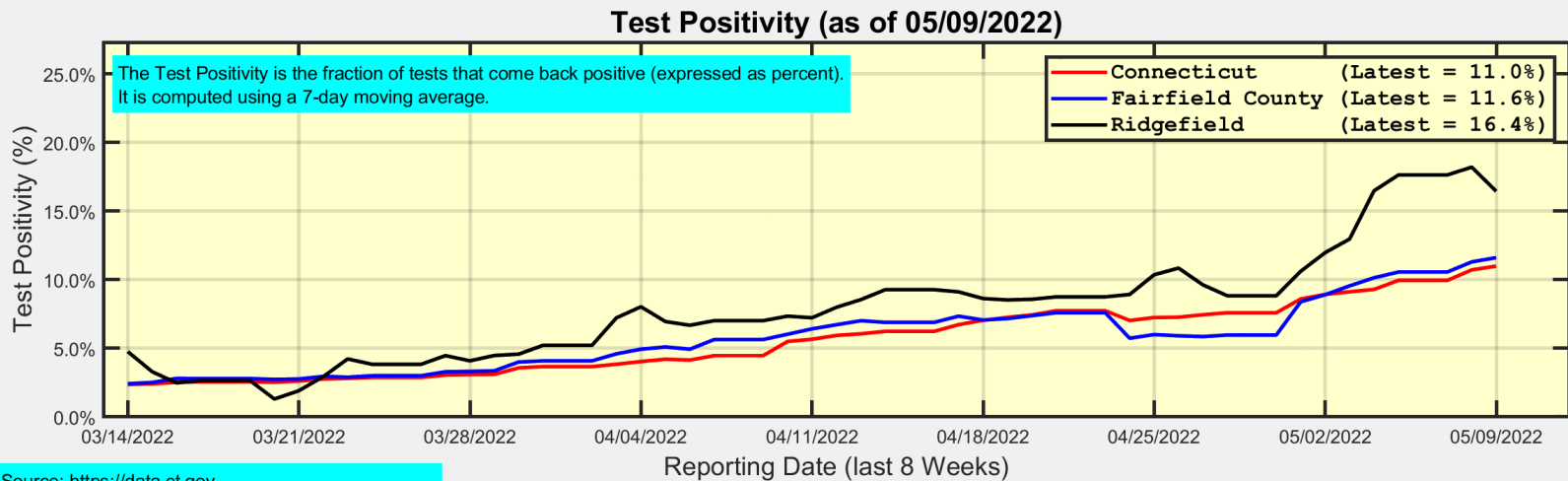
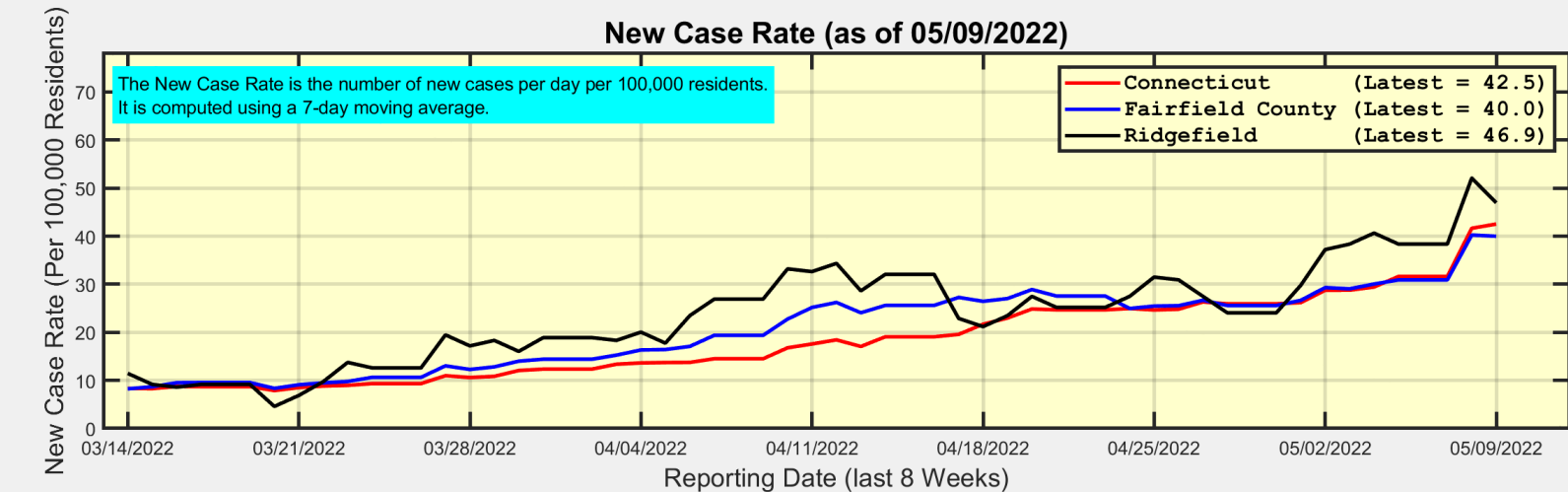

New Case Rates and Test Positivity for Connecticut, Fairfield County, and Ridgefield



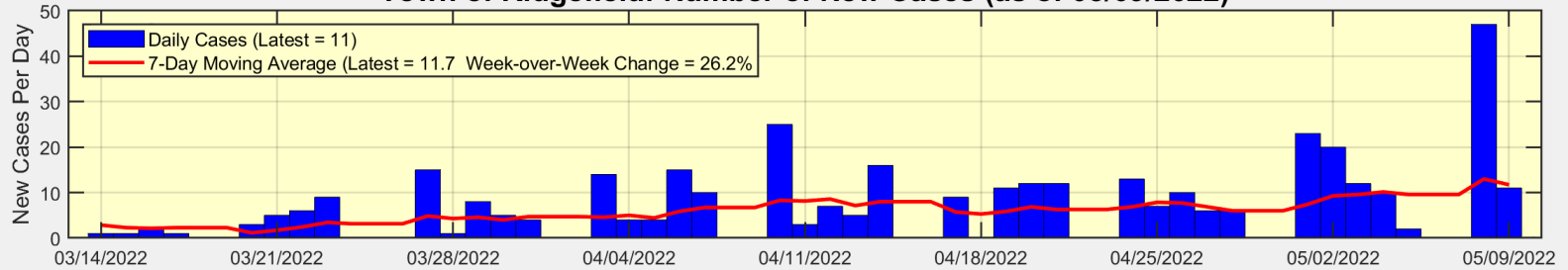

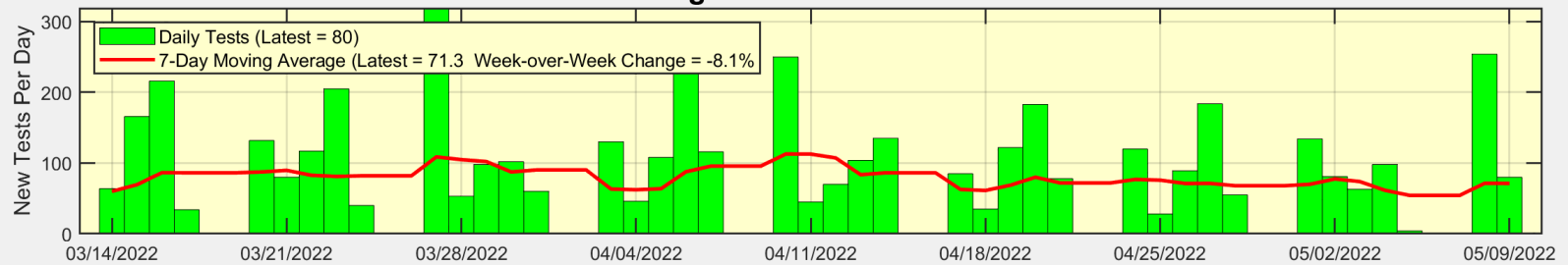

New Cases, New Tests, and Test Positivity for Ridgefield

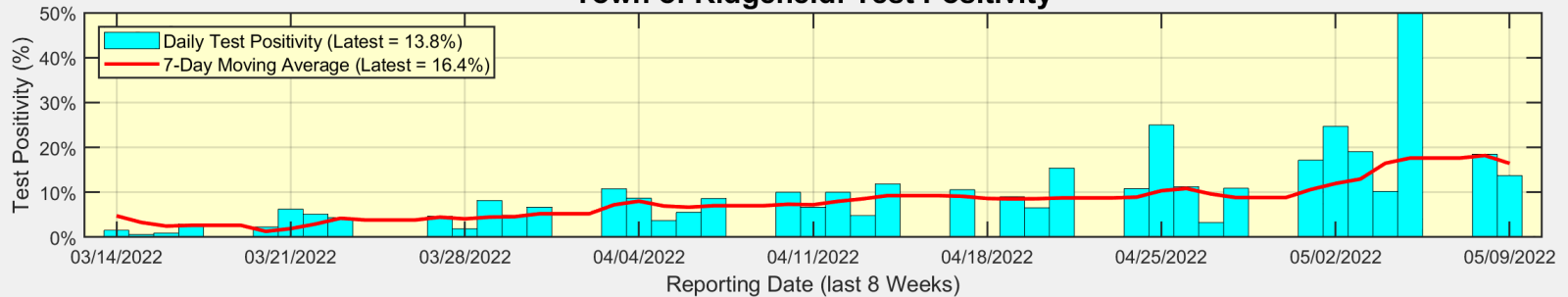
Town of Ridgefield: Number of New Cases (as of 05/09/2022)

Town of Ridgefield: Test Positivity



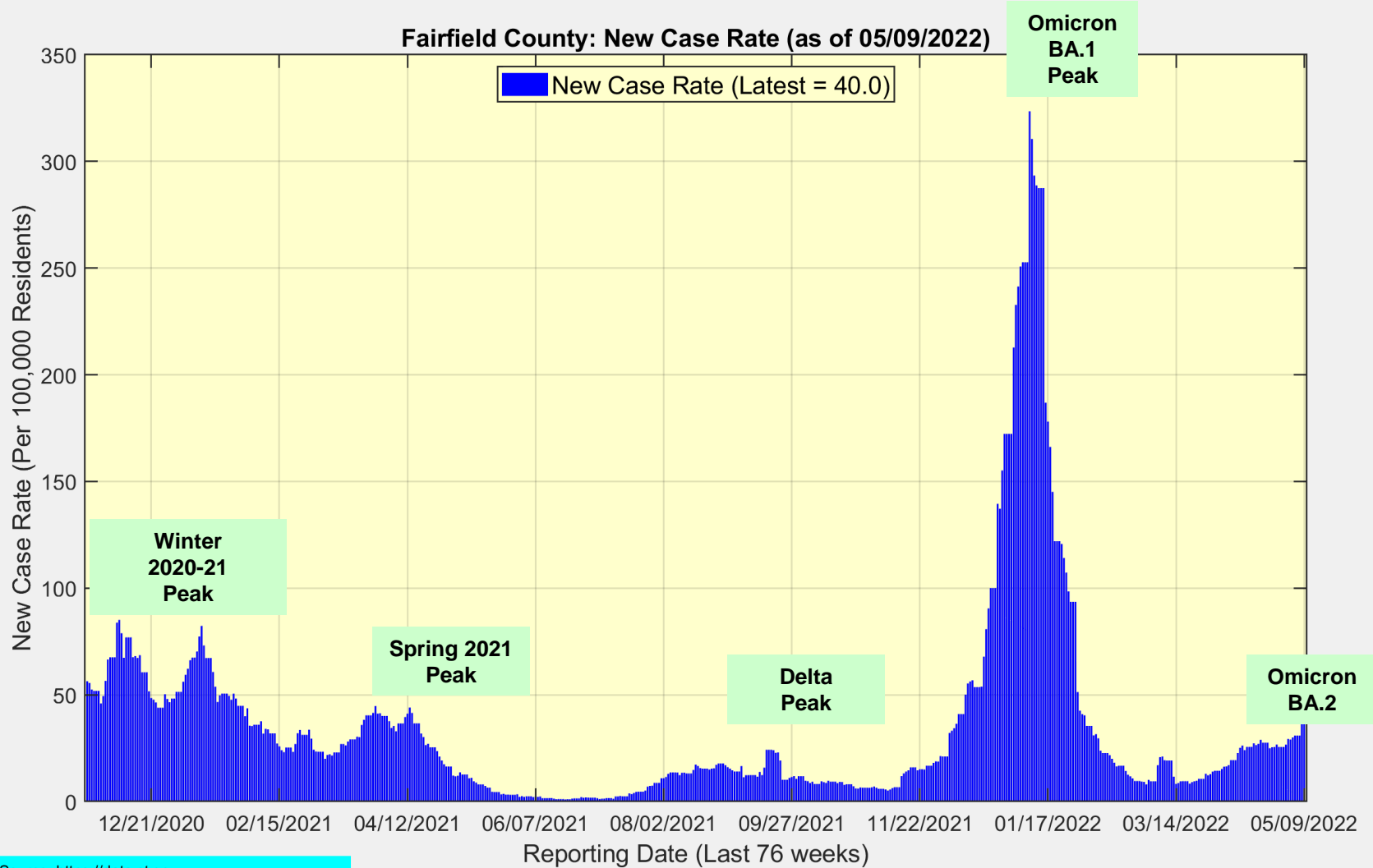

Fairfield County: New Case Rate



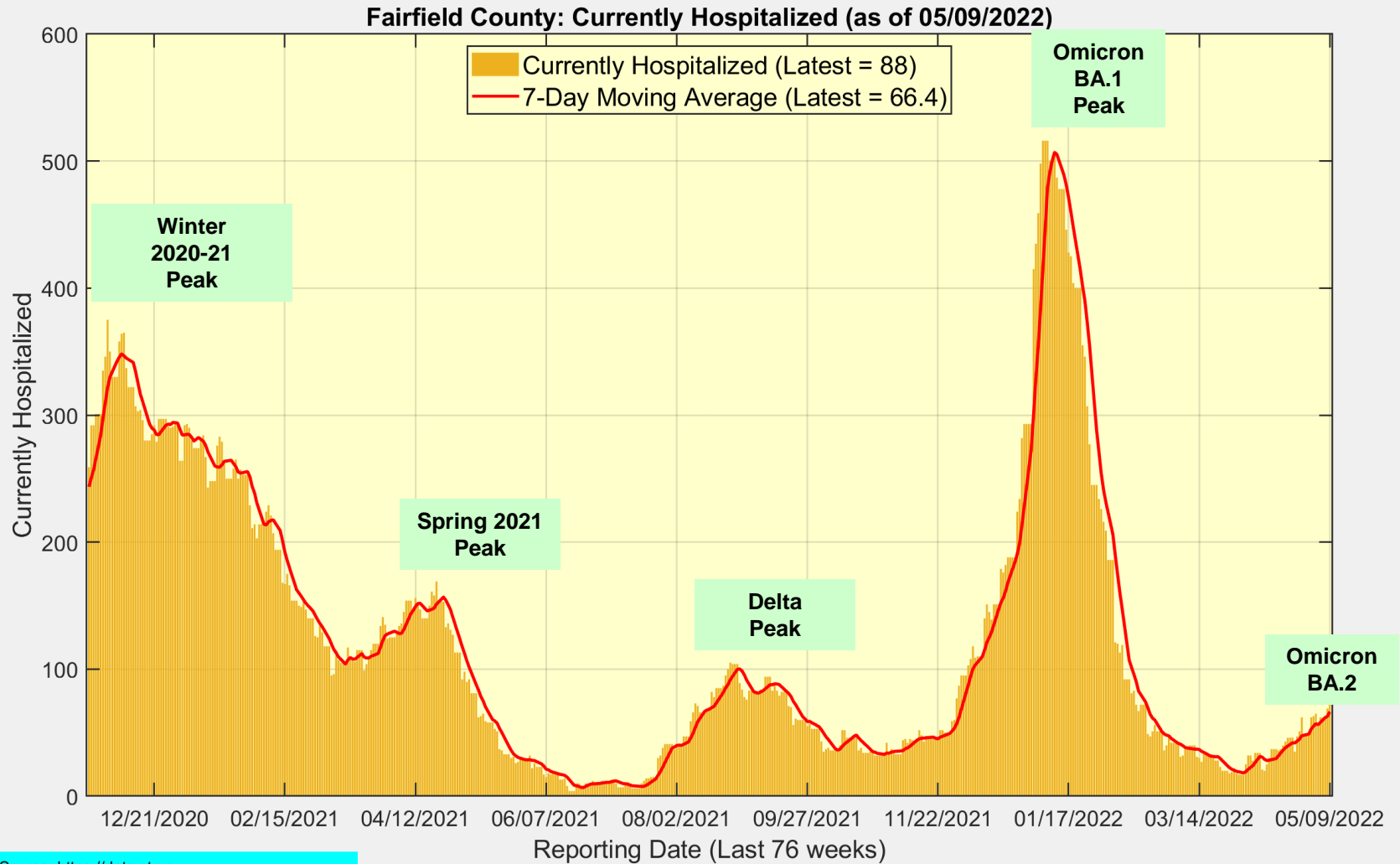

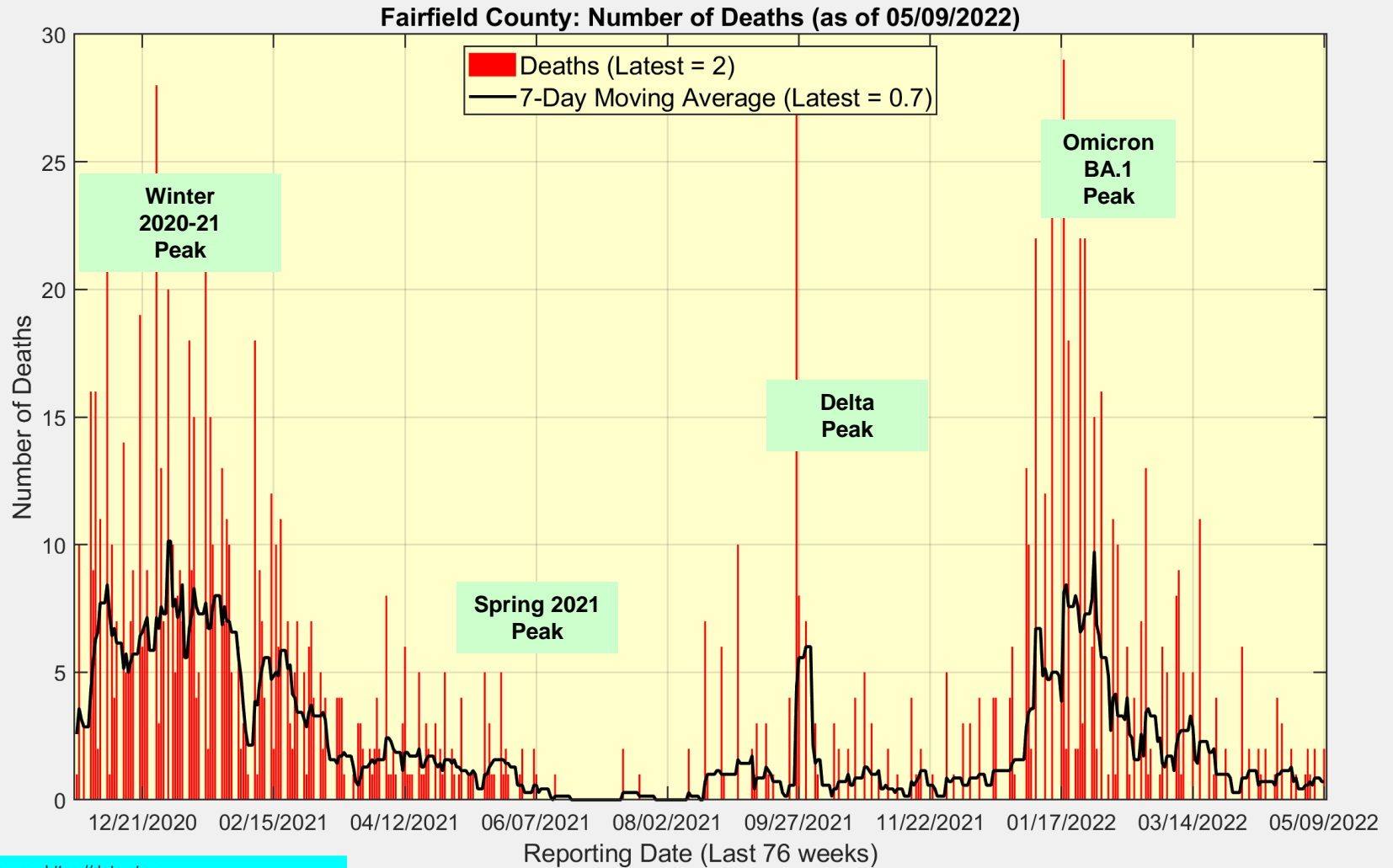

Fairfield County: Number of Deaths



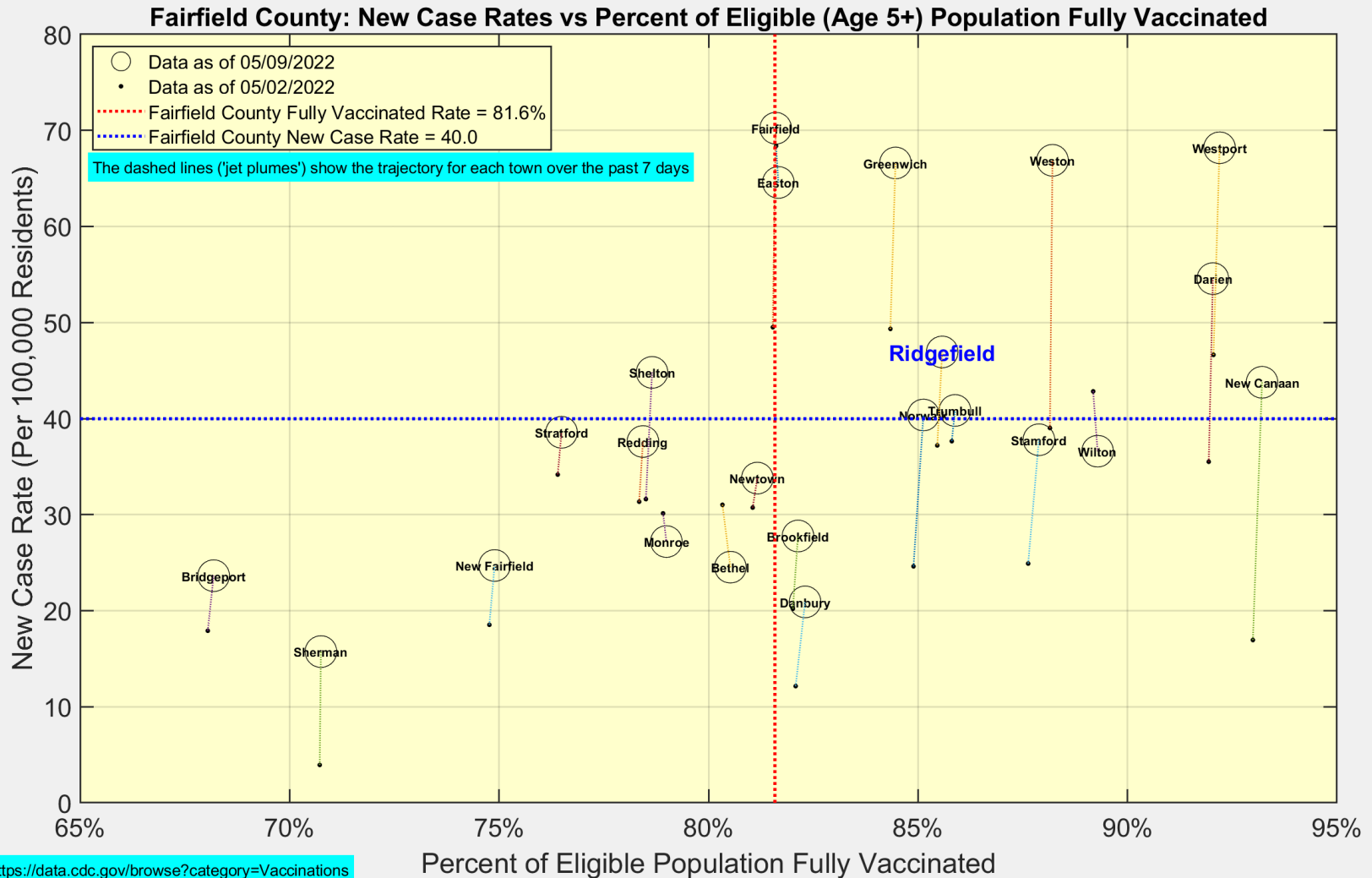

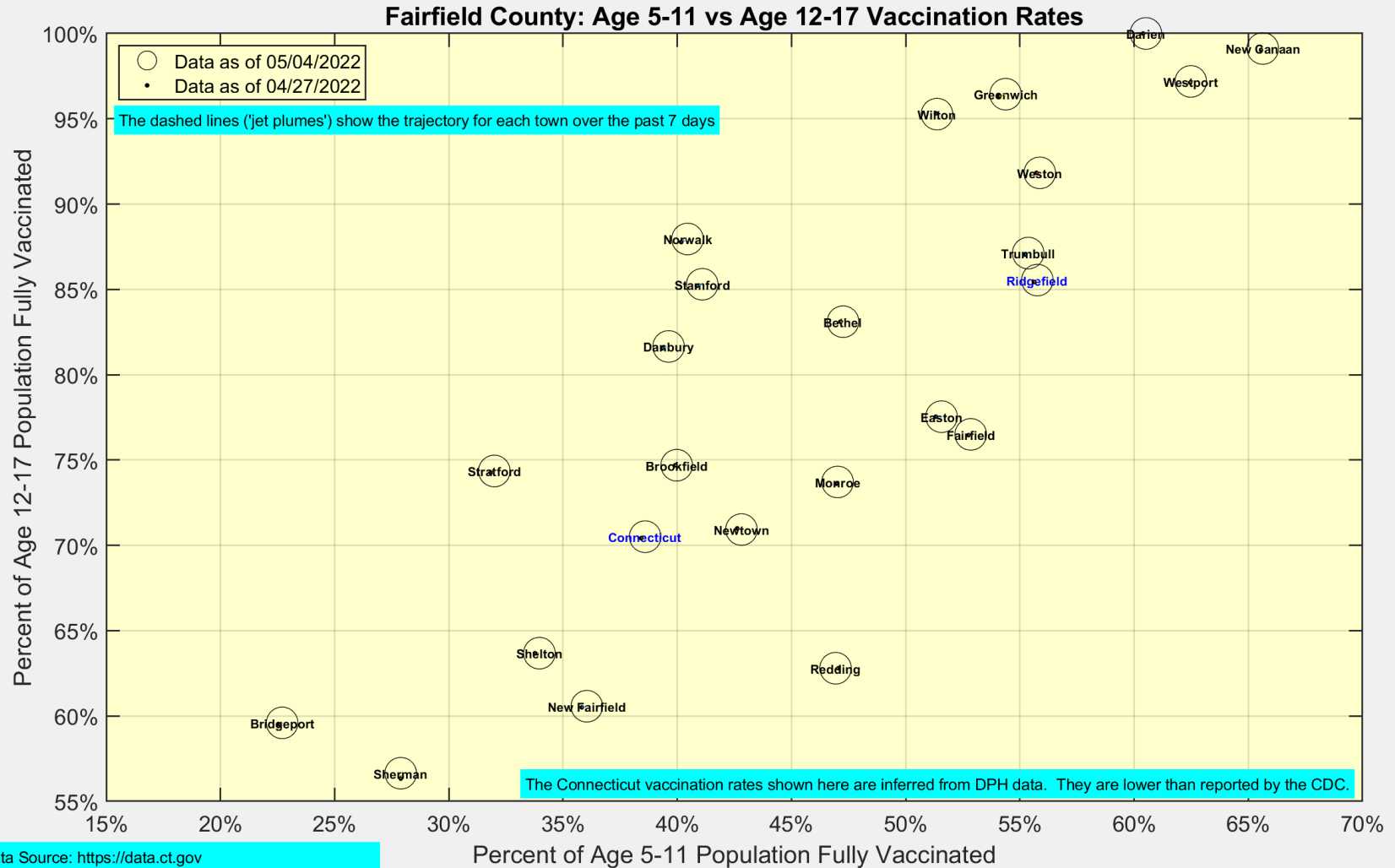

School-Age Vaccination Rates for Towns in Fairfield County



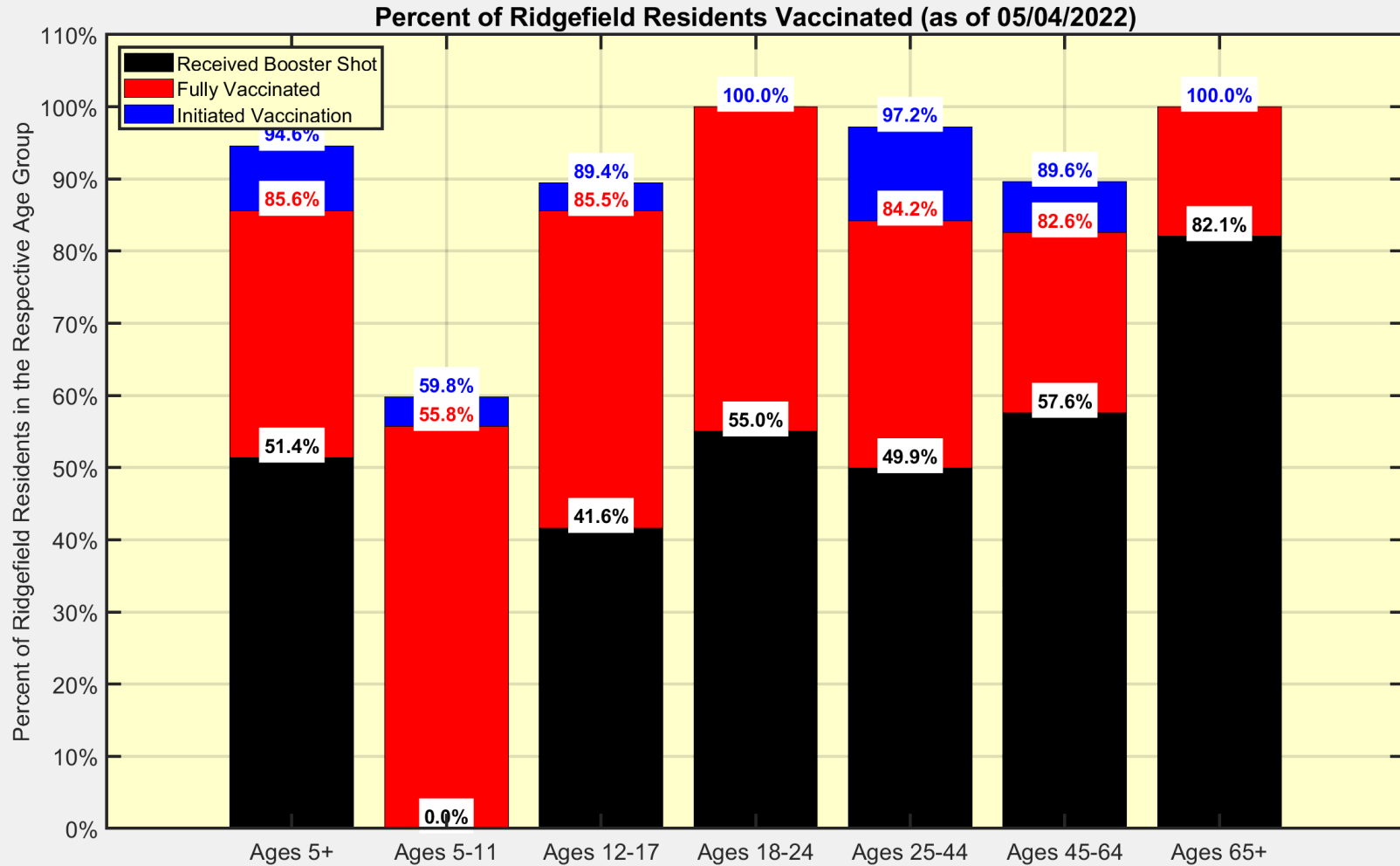

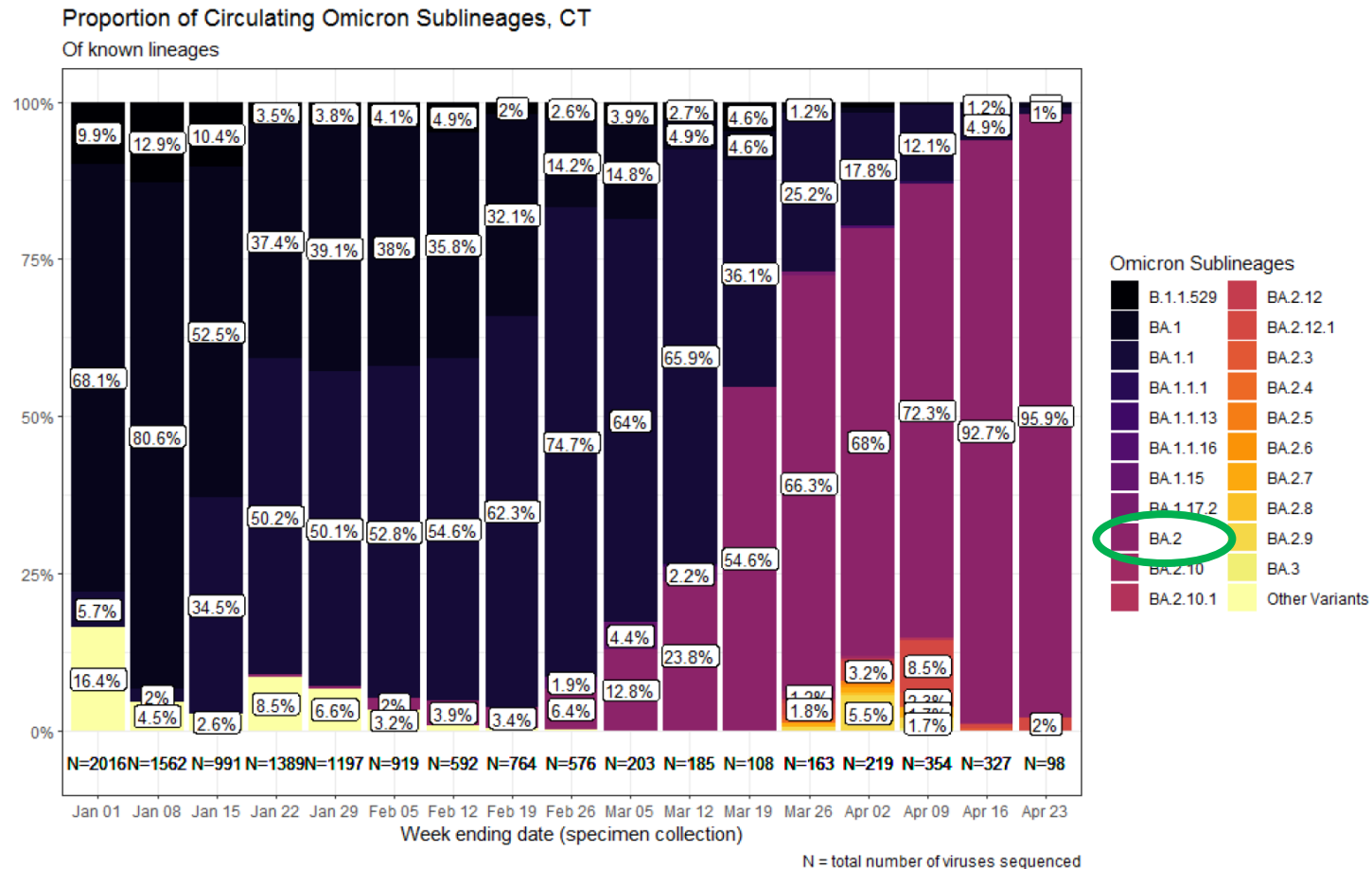
