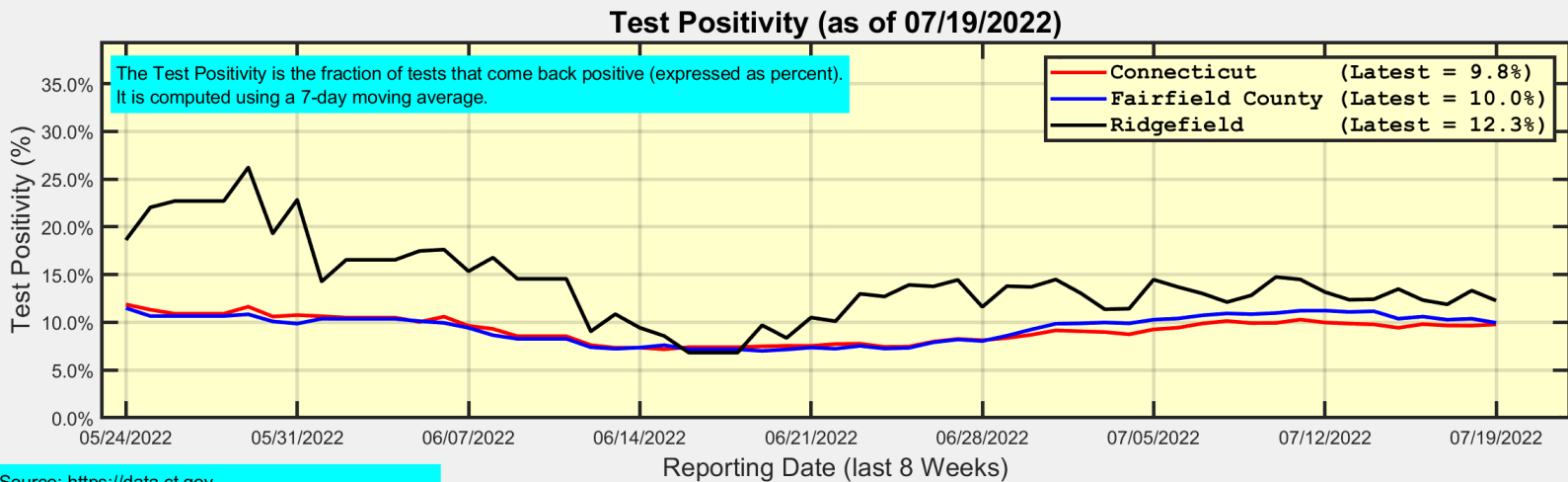
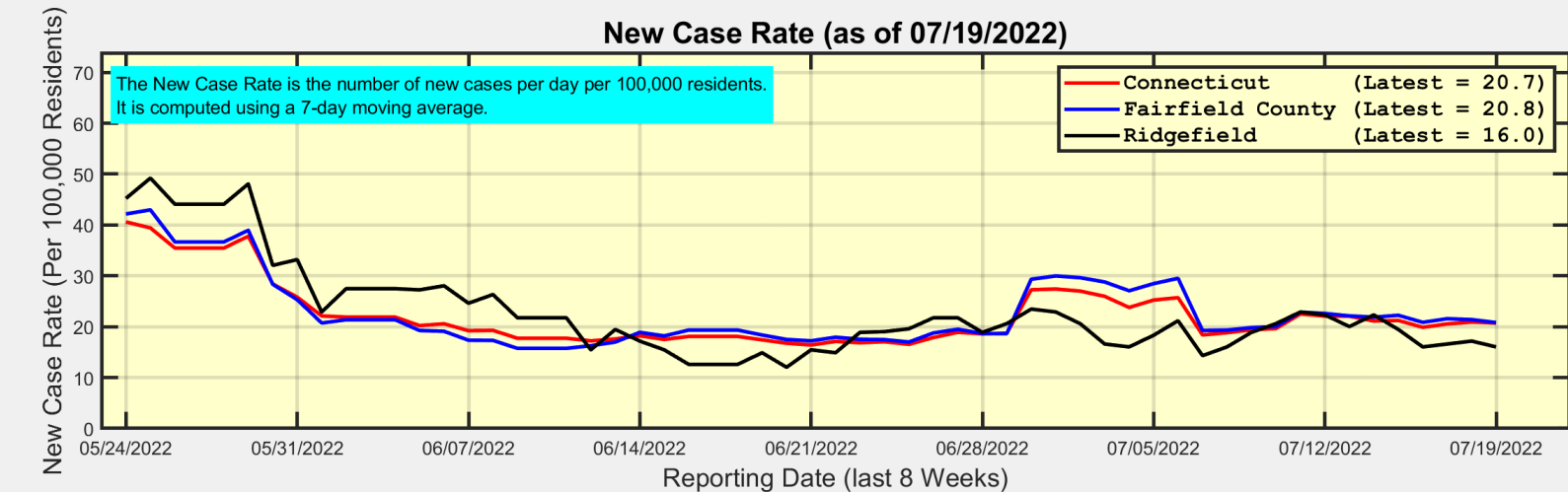

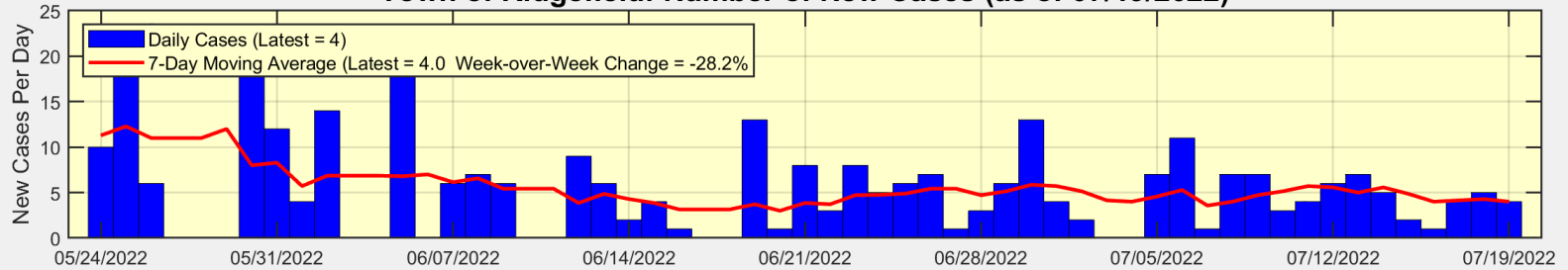

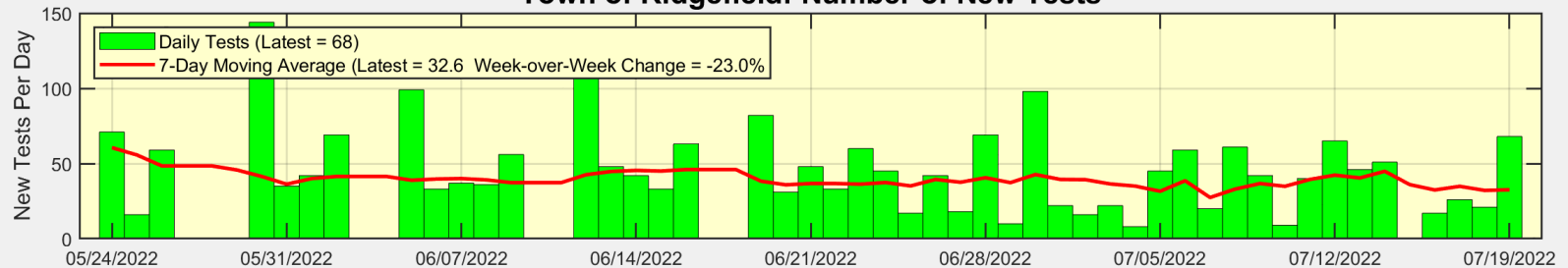

New Cases, New Tests, and Test Positivity for Ridgefield

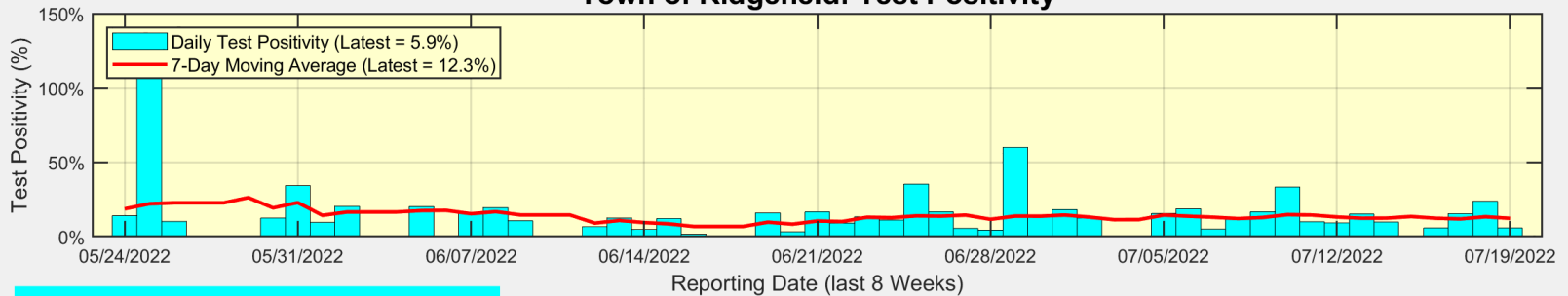
Town of Ridgefield: Number of New Cases (as of 07/19/2022)

Town of Ridgefield: Test Positivity



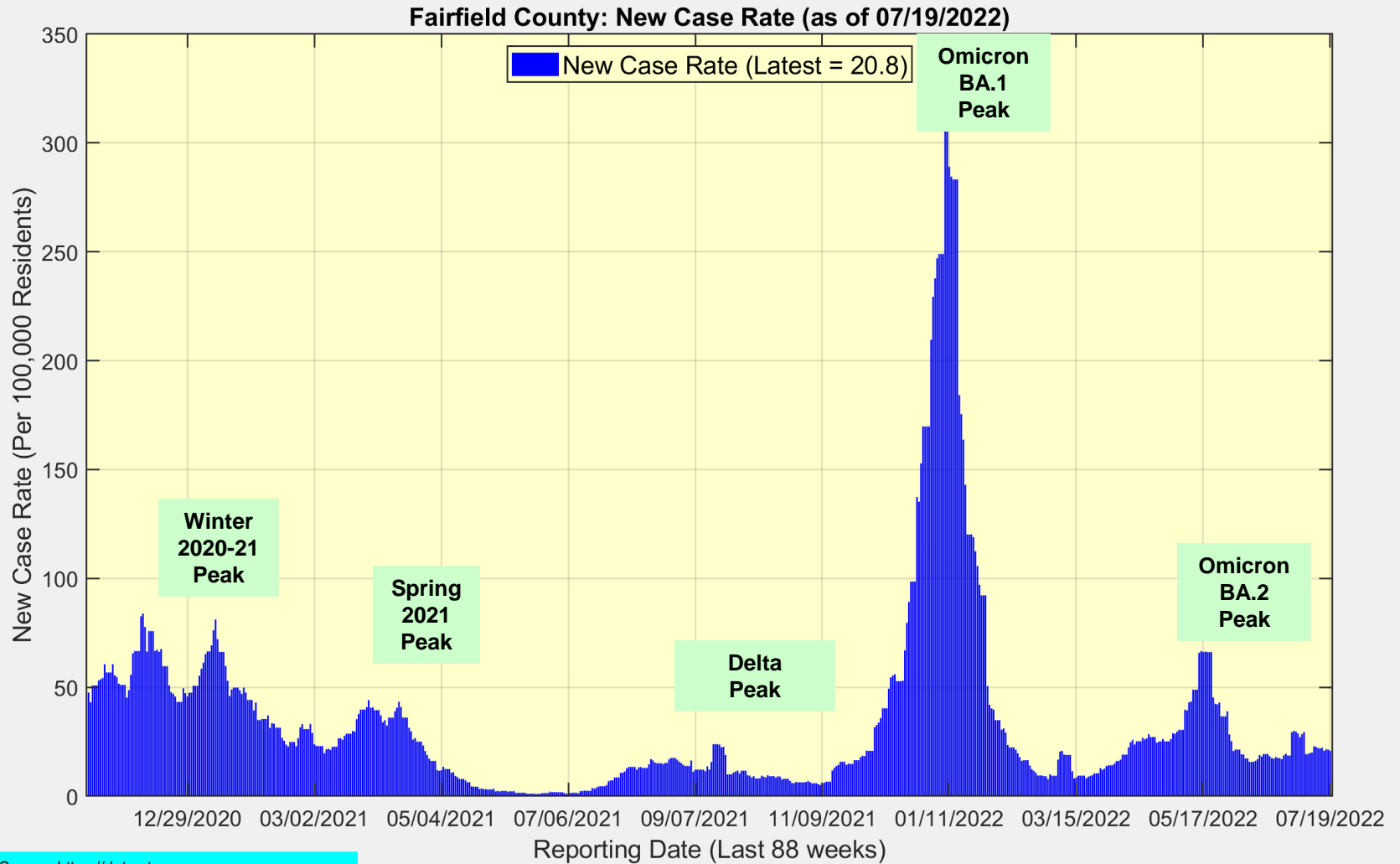

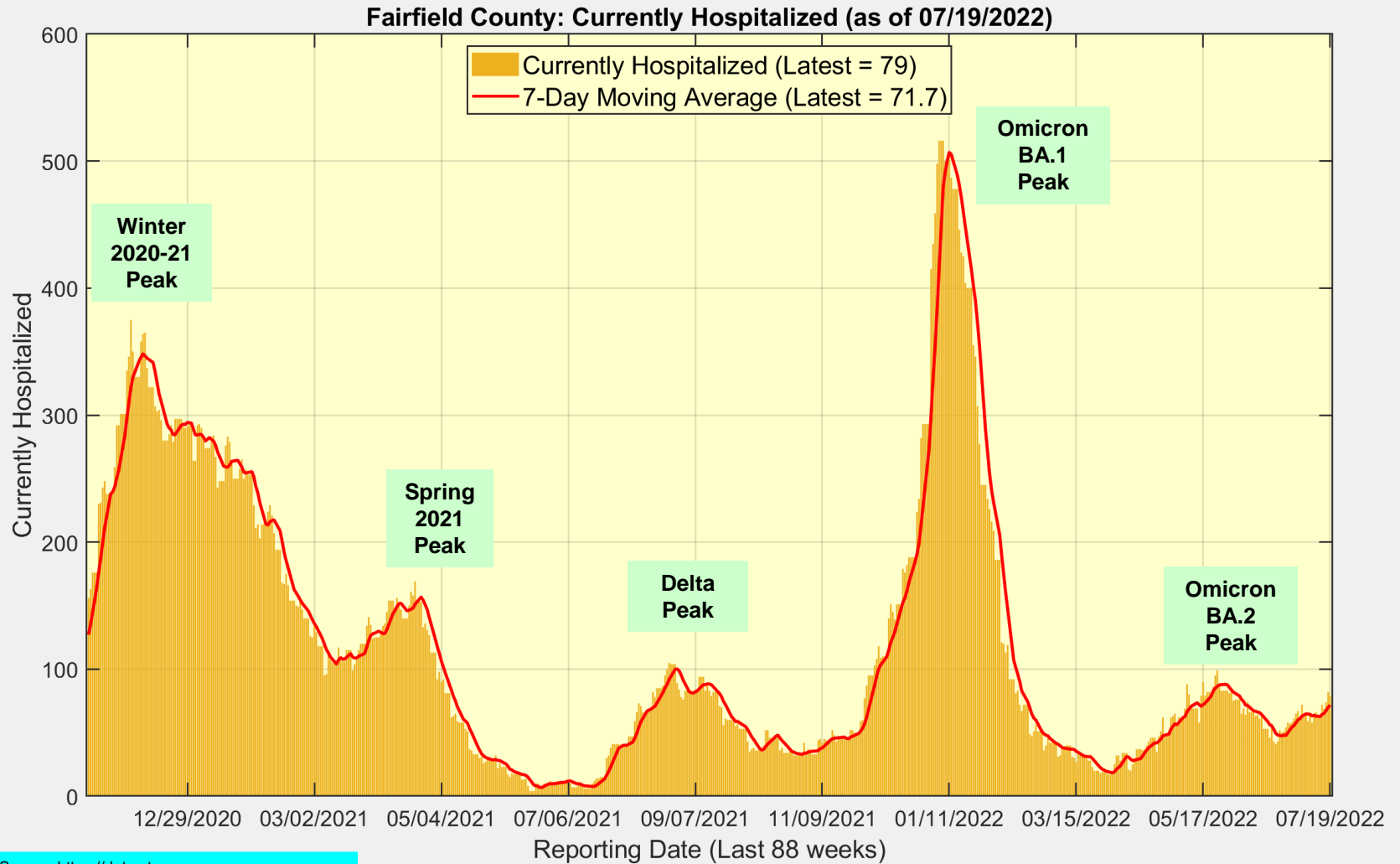

Fairfield County: Currently Hospitalized

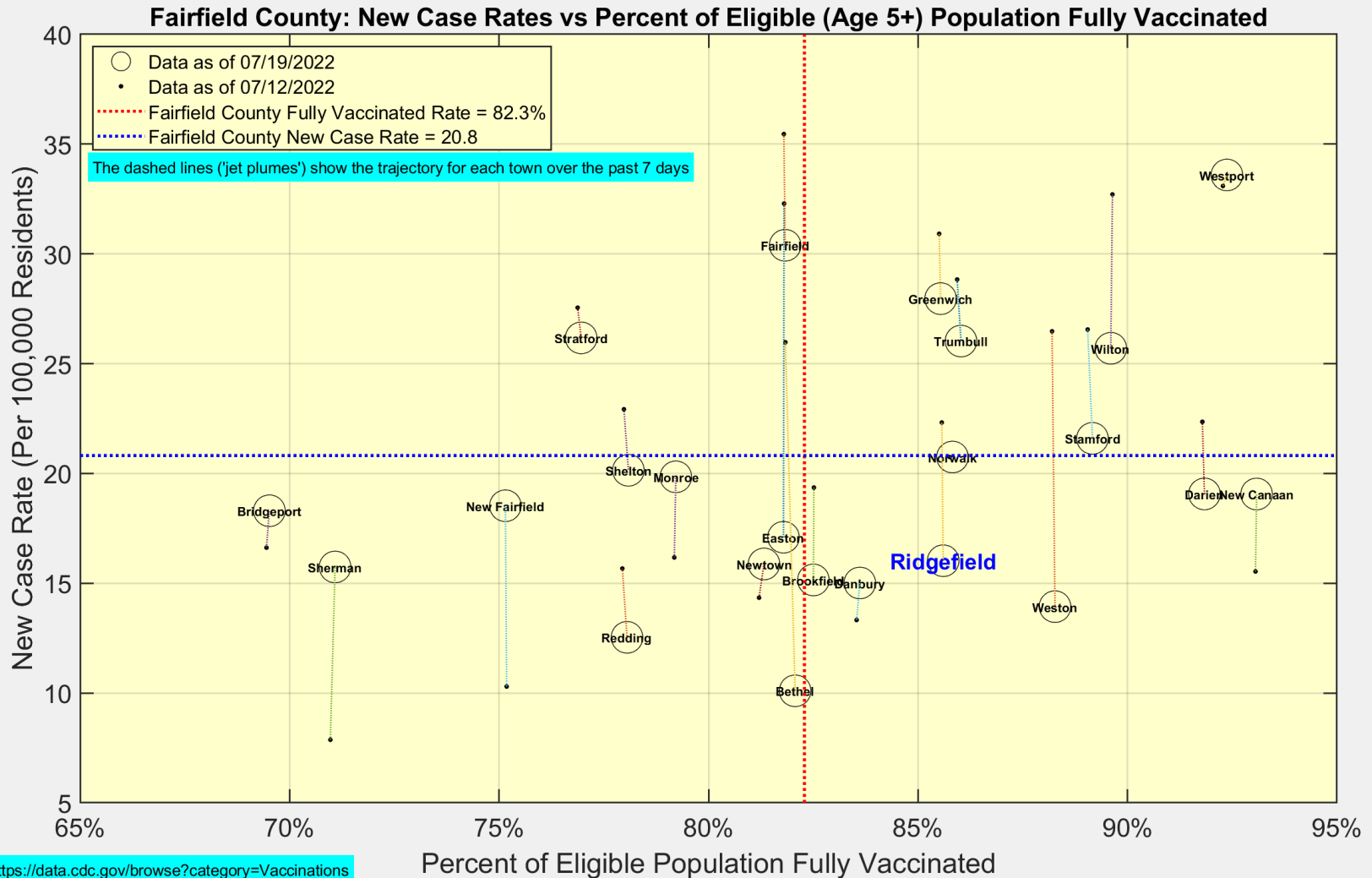

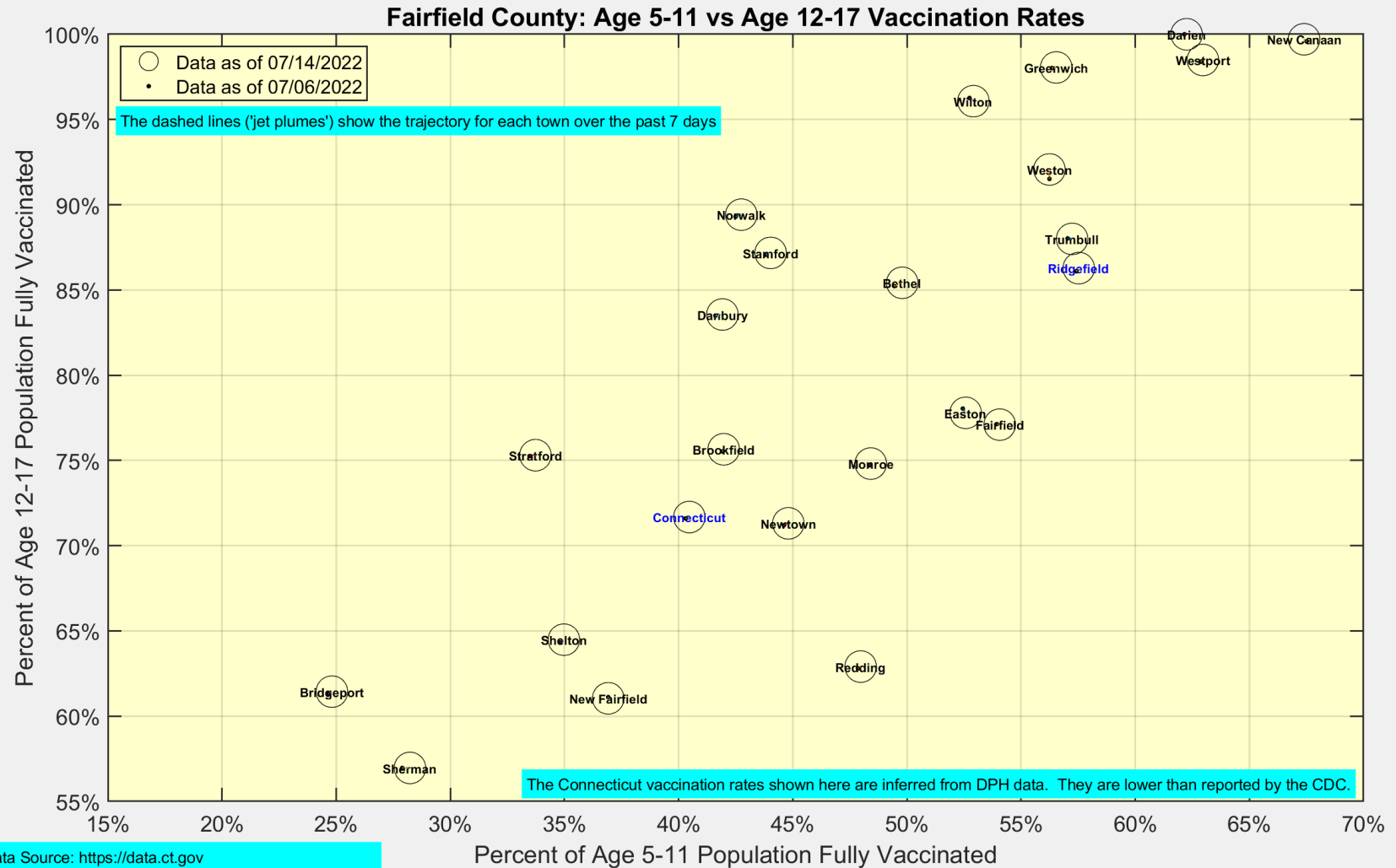

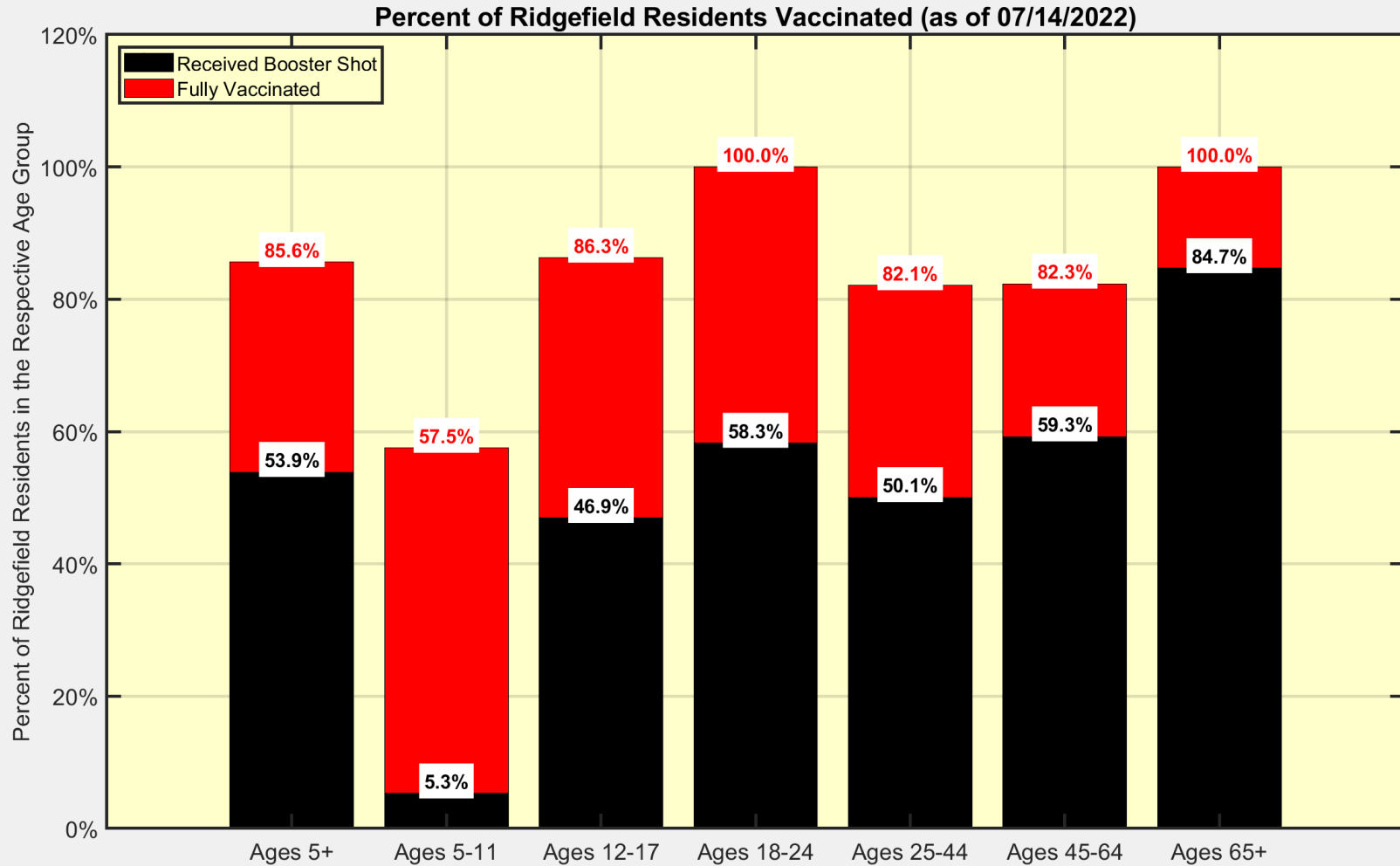

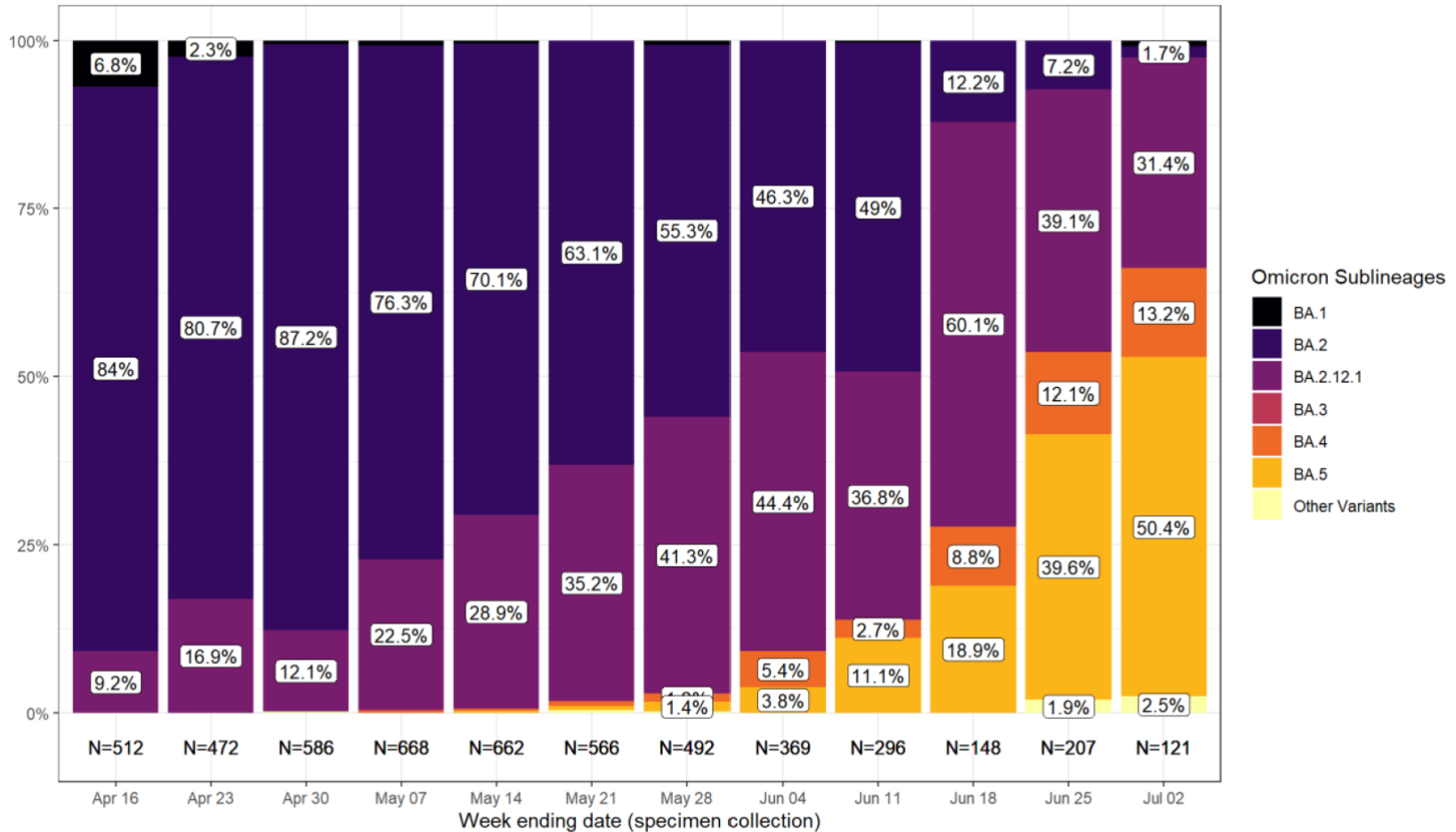

Of known lineages



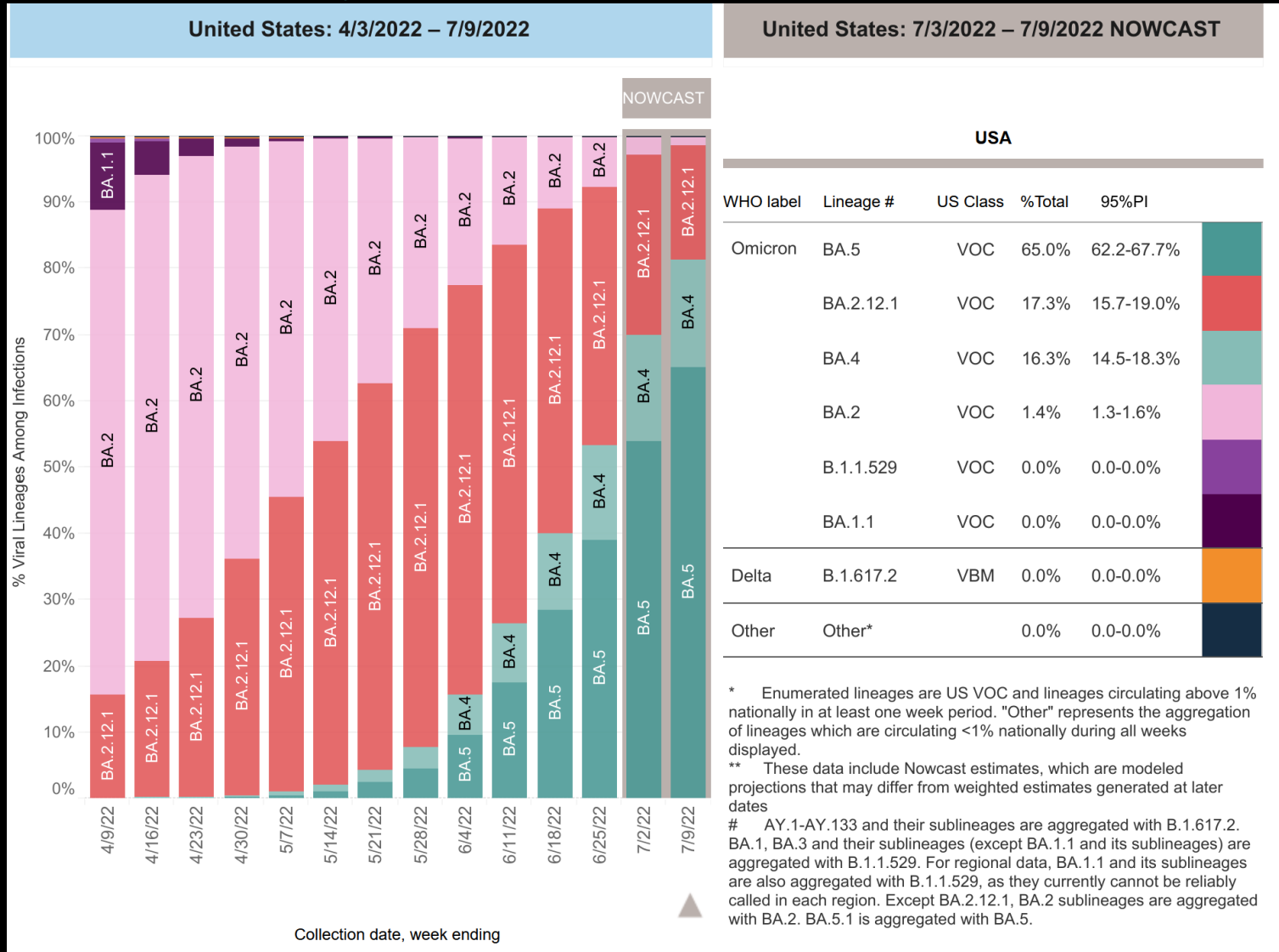
