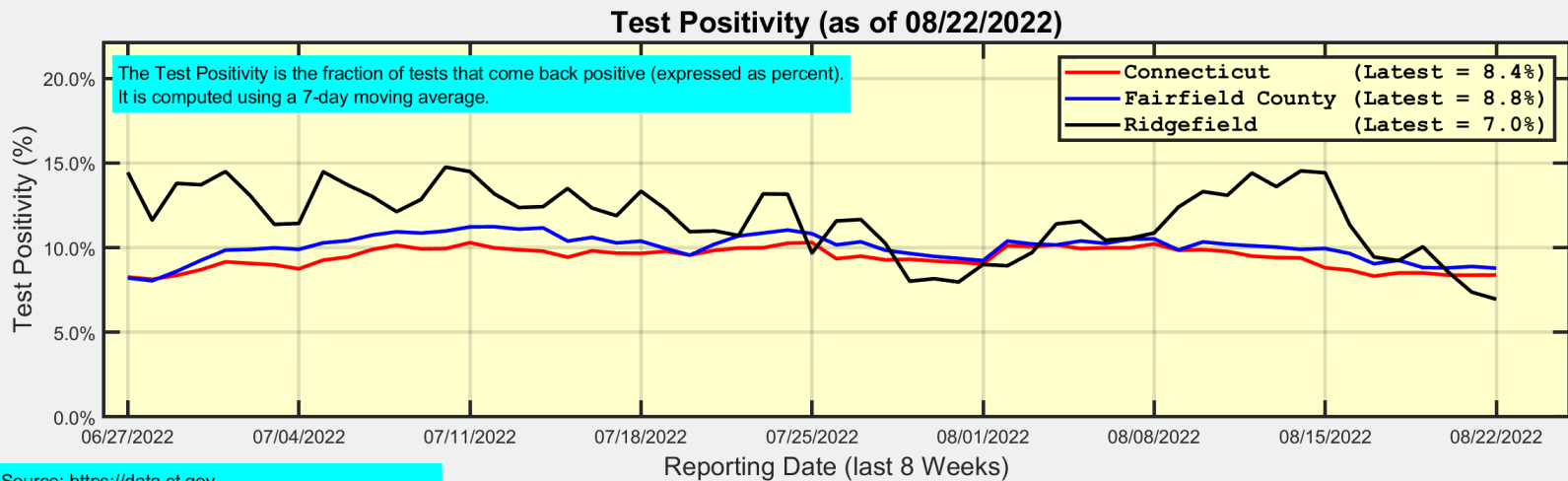
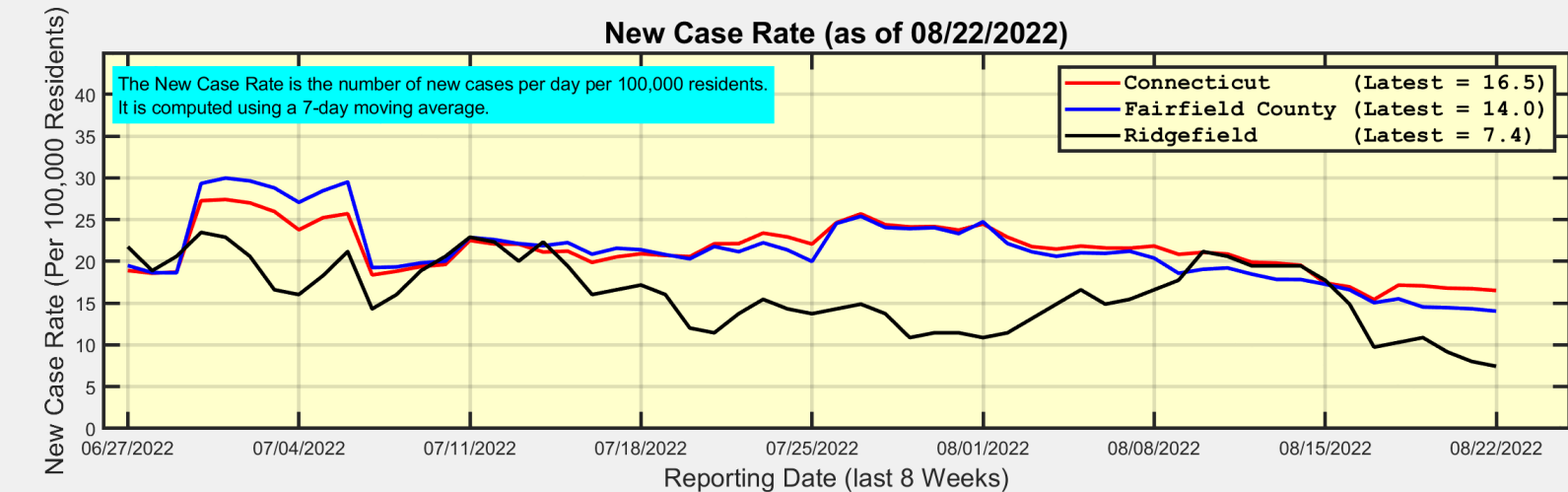

# New Case Rates and Test Positivity for Connecticut, Fairfield County, and Ridgefield



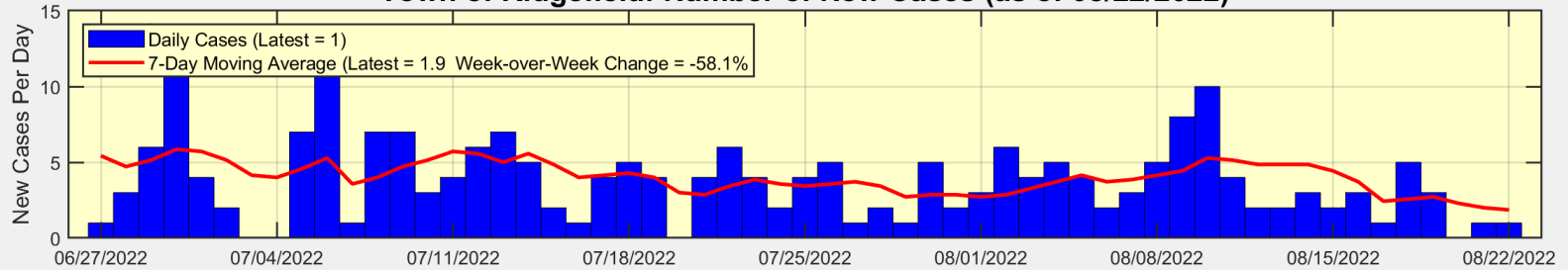

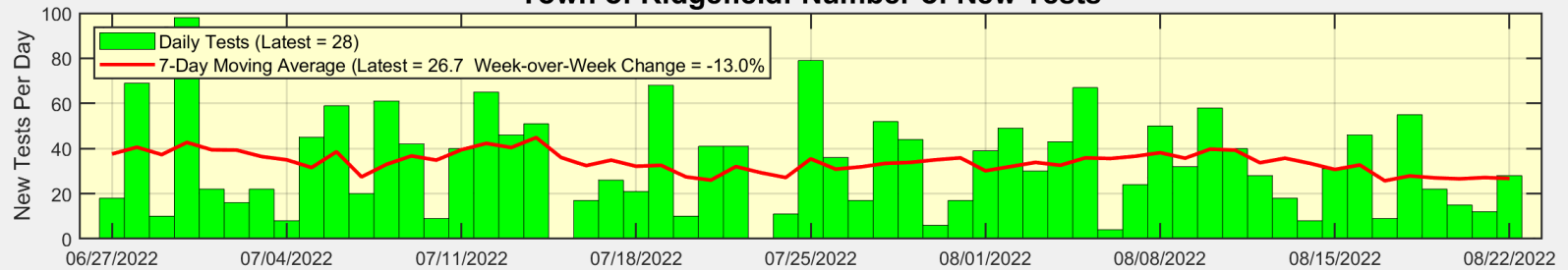

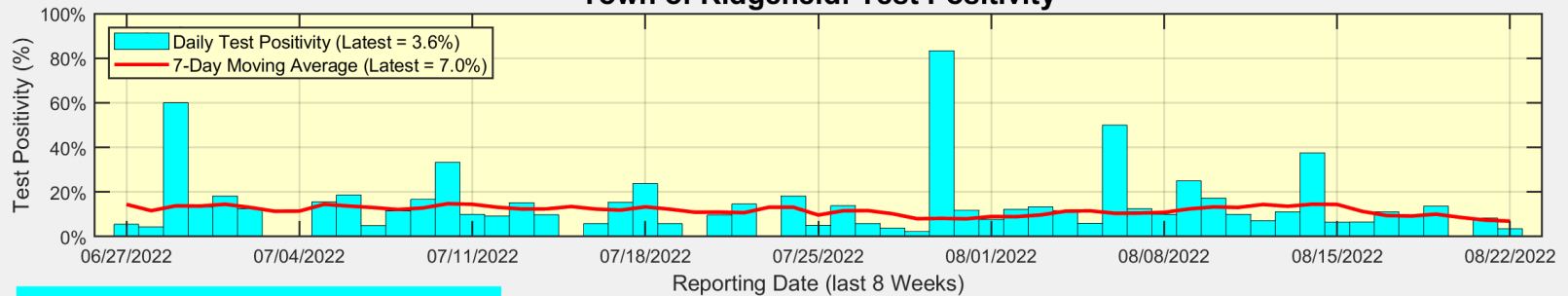
**Town of Ridgefield: Number of New Cases (as of 08/22/2022)**

**Town of Ridgefield: Test Positivity**



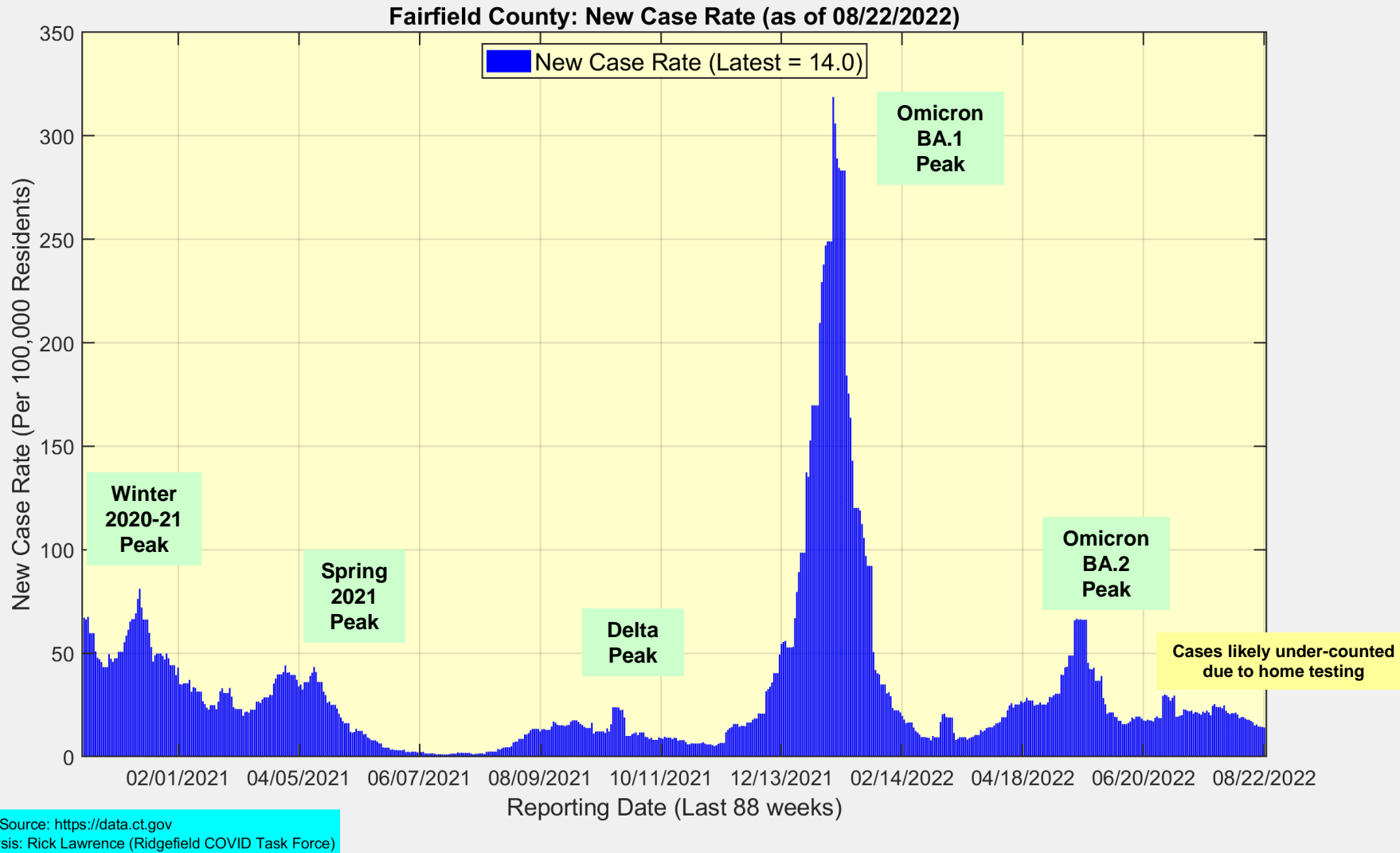

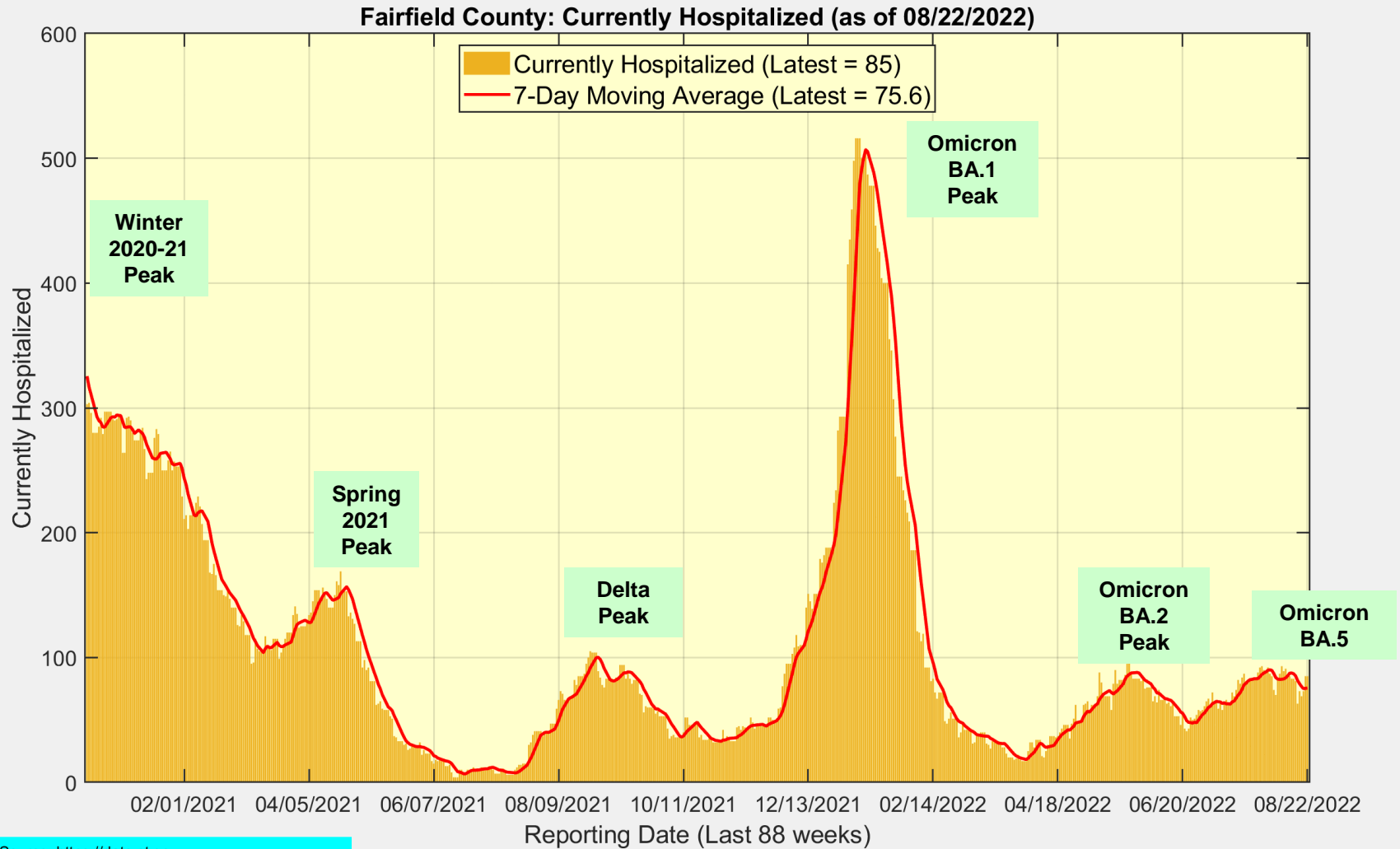

# Fairfield County: Currently Hospitalized



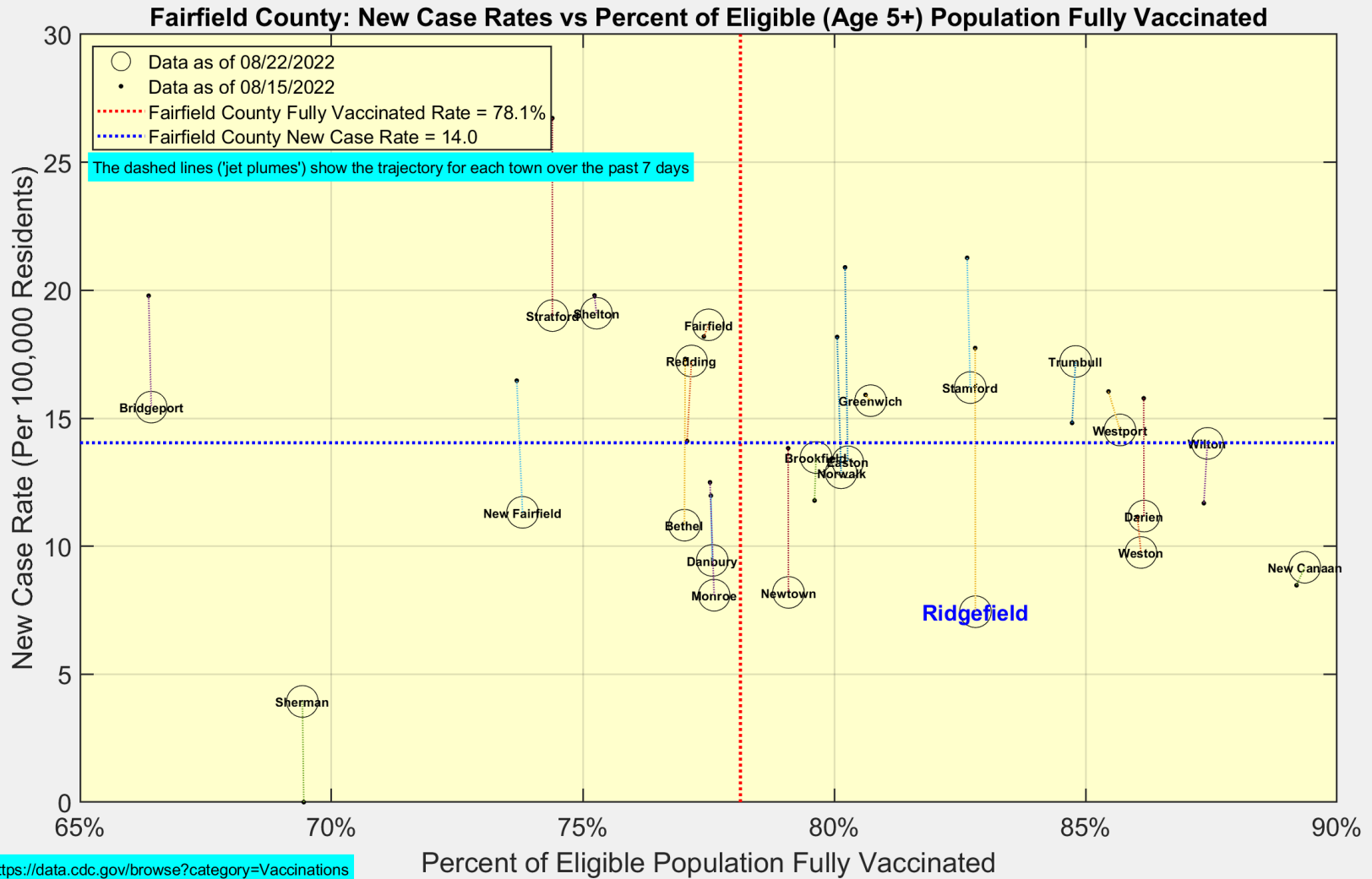

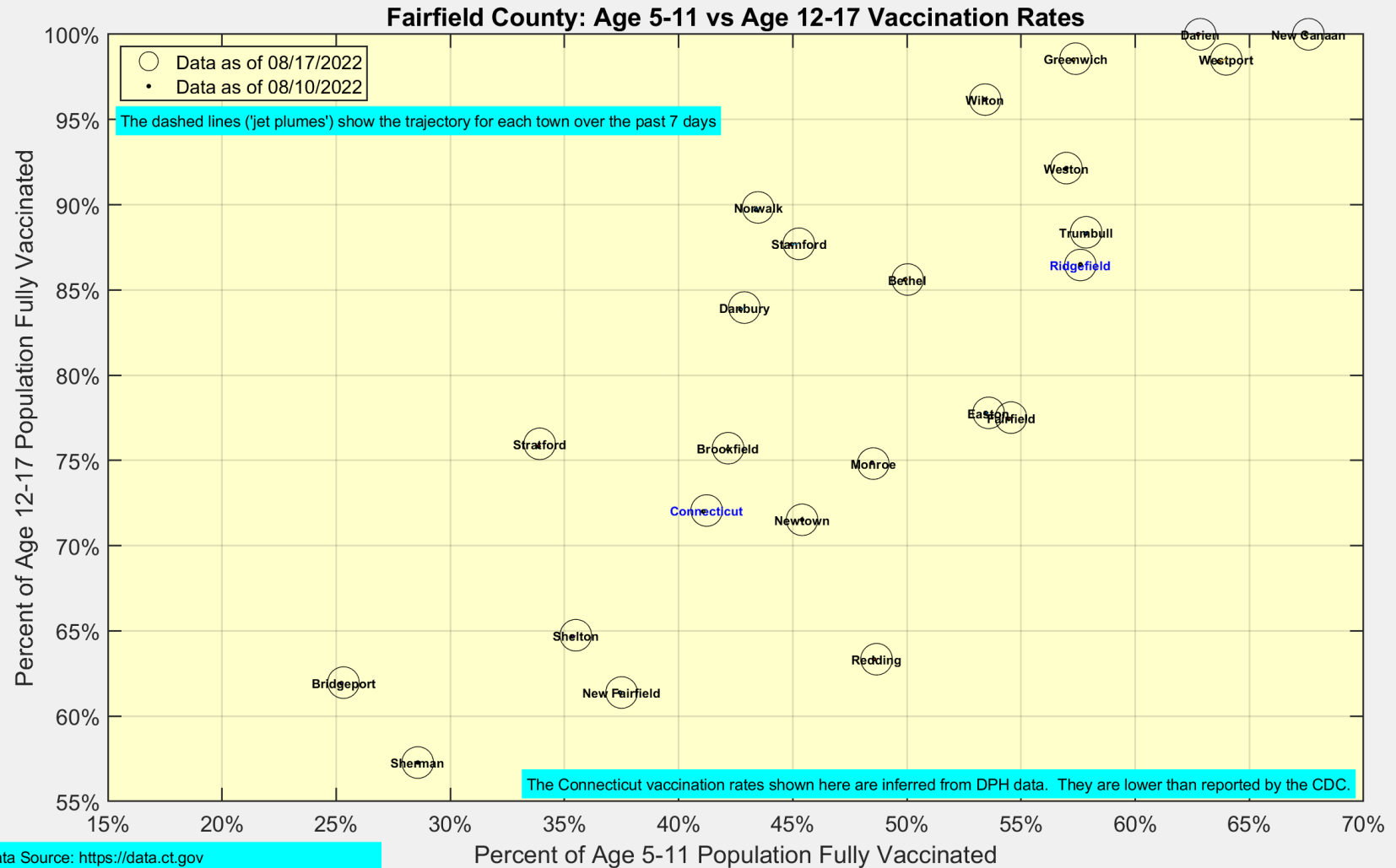

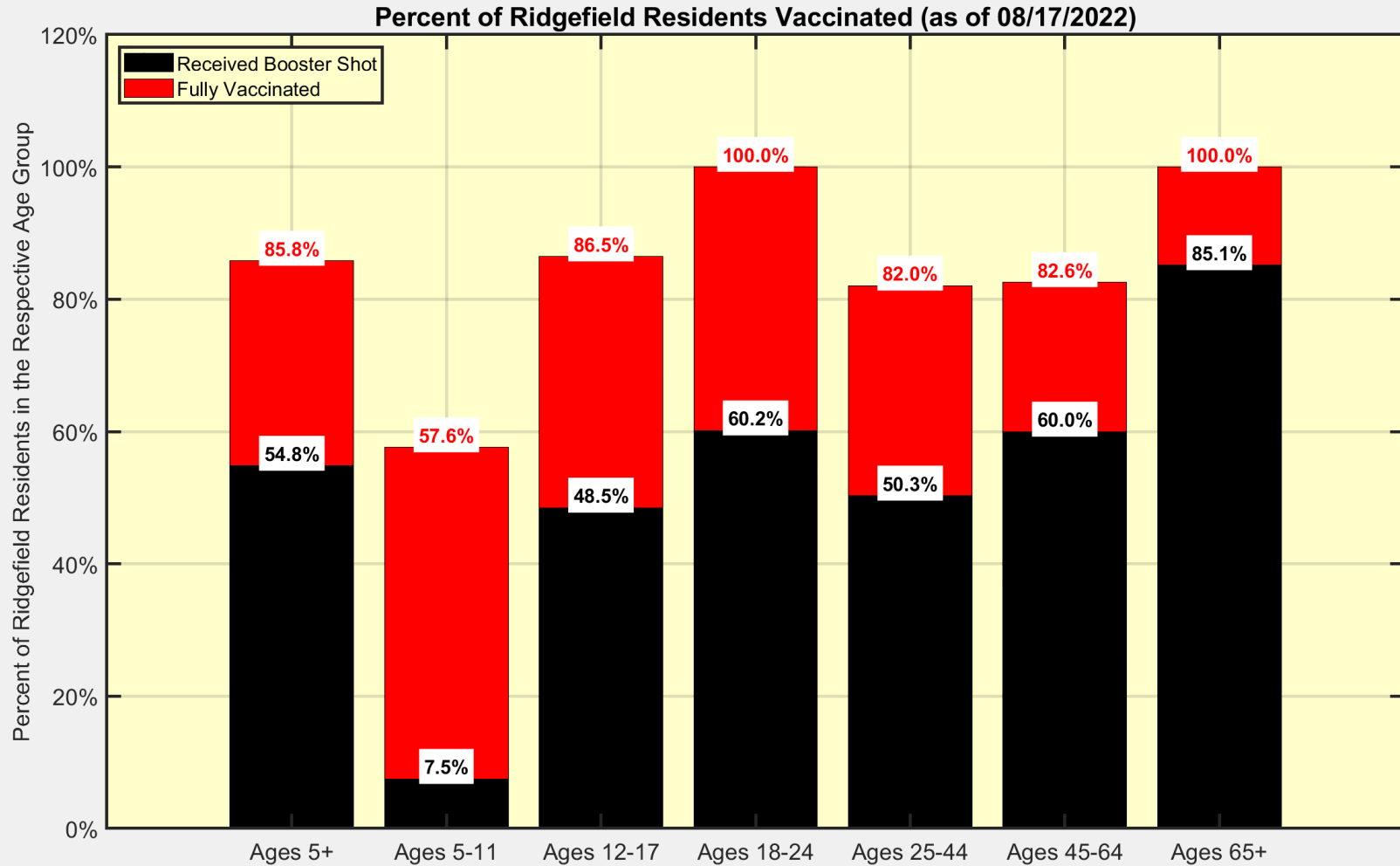




# School-Age Vaccination Rates for Towns in Fairfield County



# Latest Vaccination Rates for Ridgefield Residents



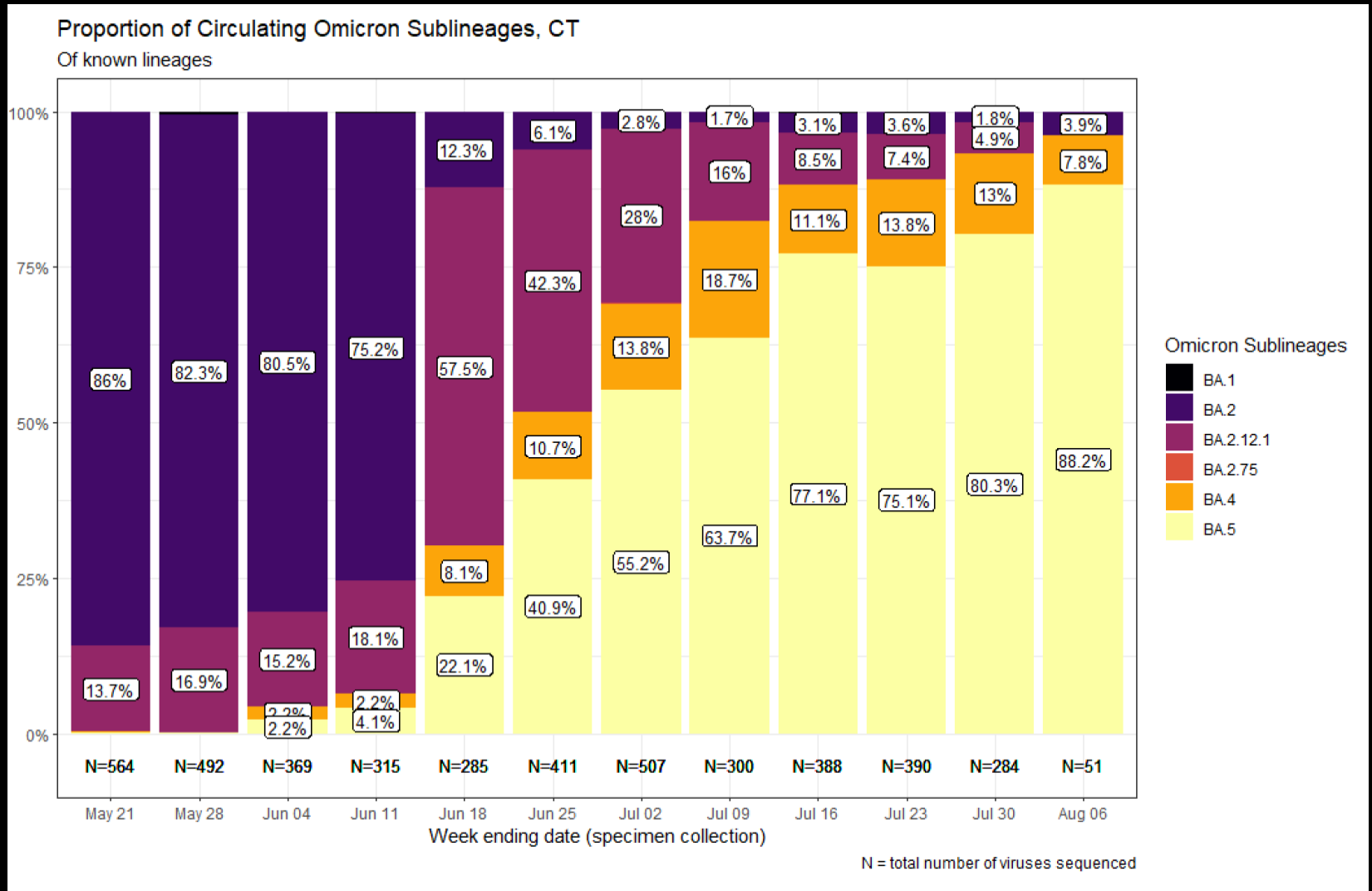

# Connecticut DPH analysis shows 88.2% BA.5 prevalence

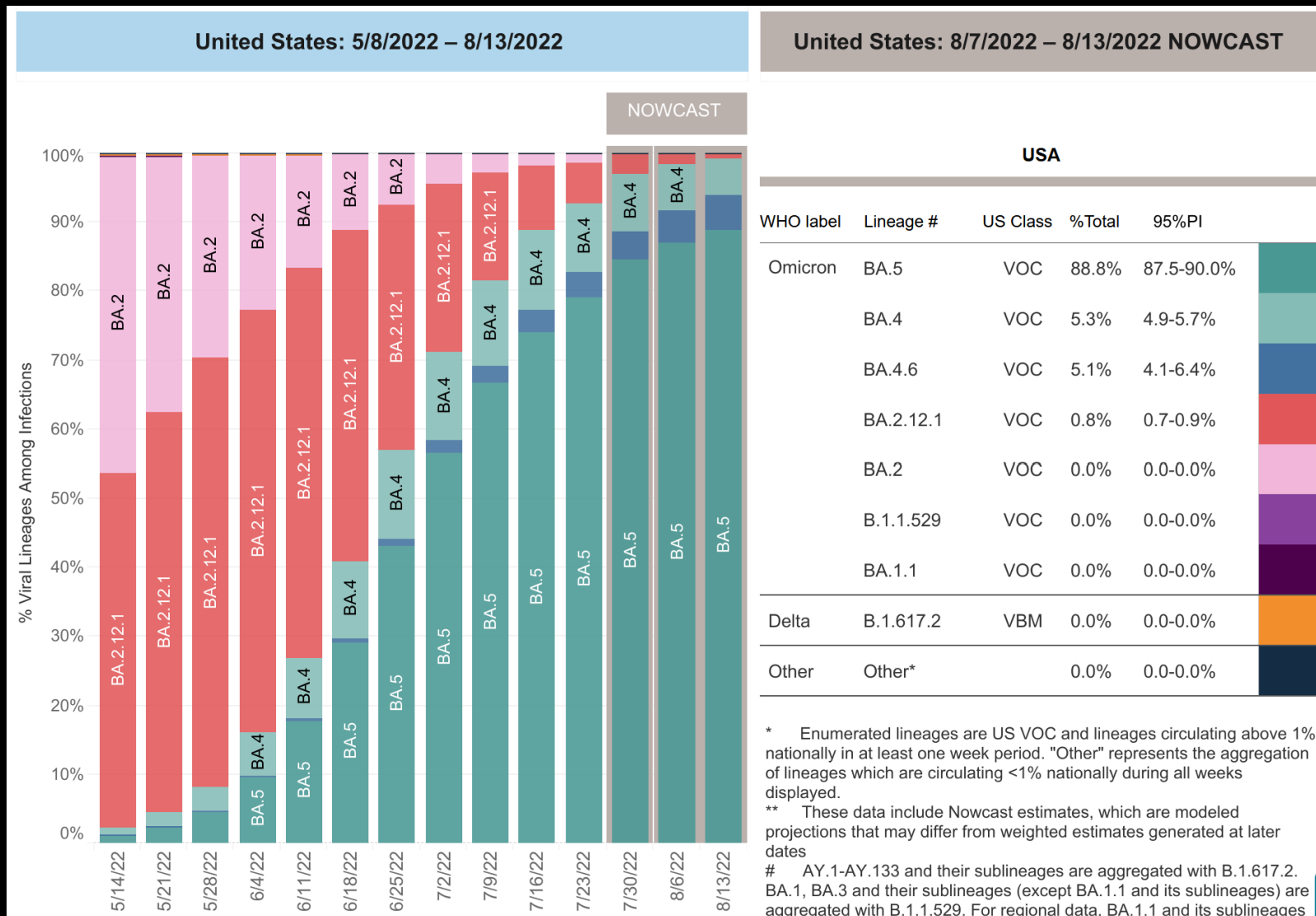
