





## New Case Rates and Test Positivity for Connecticut, Fairfield County, and Ridgefield






### New Cases, New Tests, and Test Positivity for Ridgefield






#### Town of Ridgefield: Test Positivity




## Fairfield County: New Case Rate






# **Fairfield County: Currently Hospitalized**






## **Child Vaccination Rates for Towns in Fairfield County**






## Latest Vaccination Rates for Ridgefield Residents





## **Connecticut DPH analysis shows 88.2% BA.5 prevalence**


