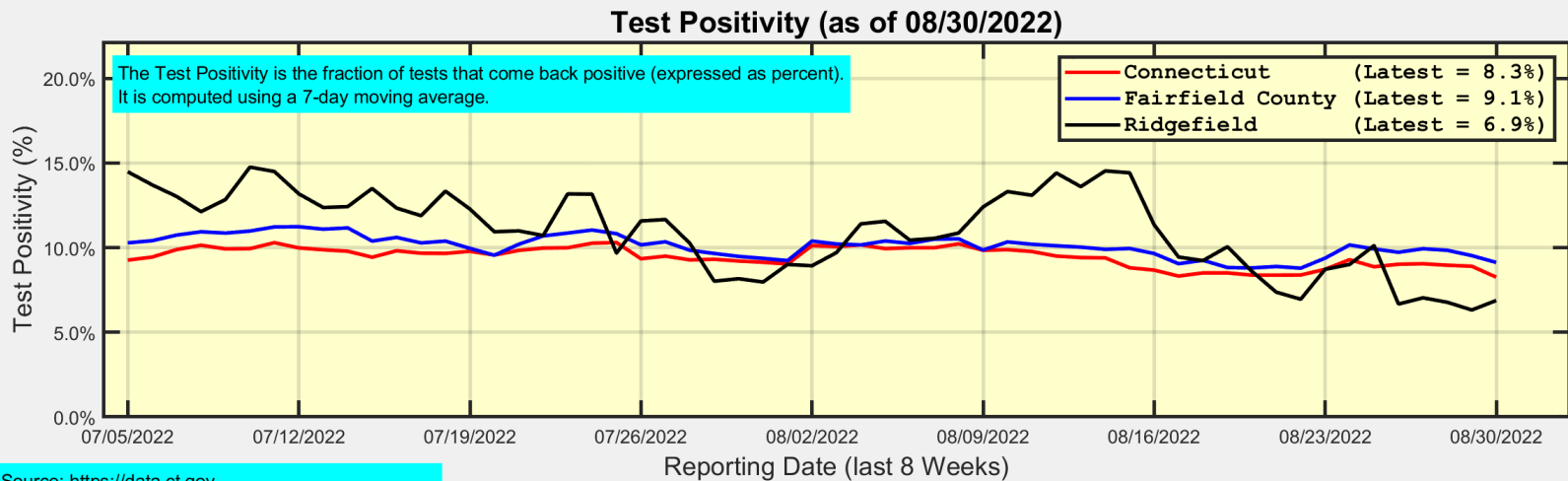
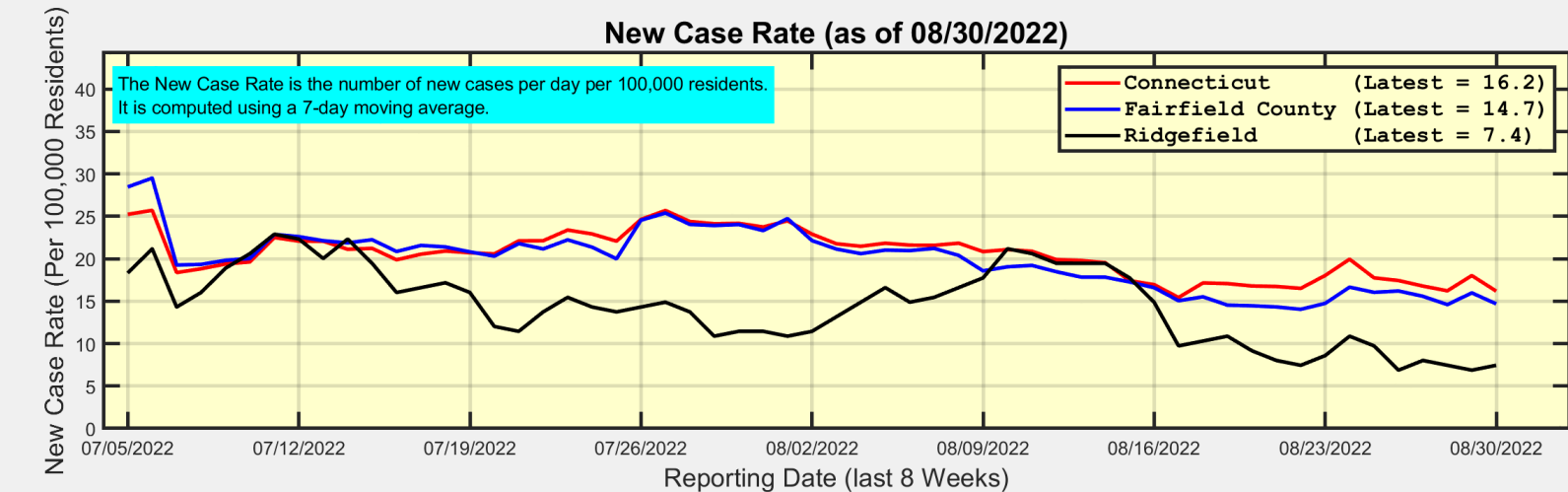

New Case Rates and Test Positivity for Connecticut, Fairfield County, and Ridgefield



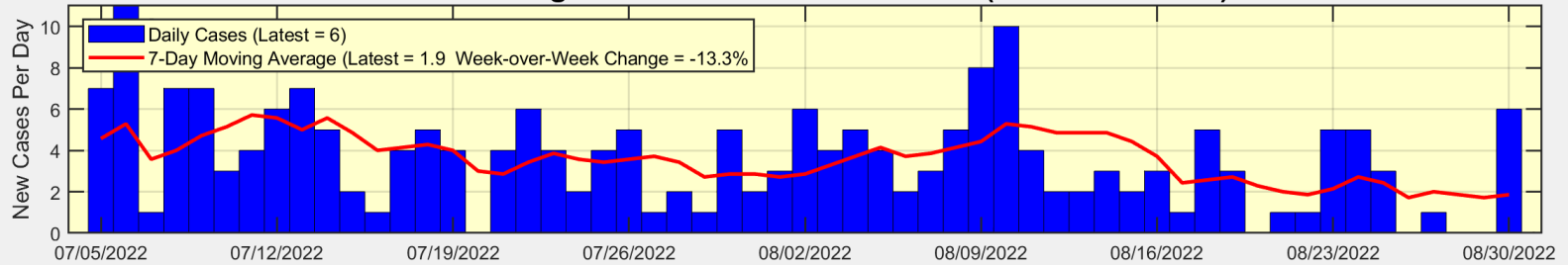

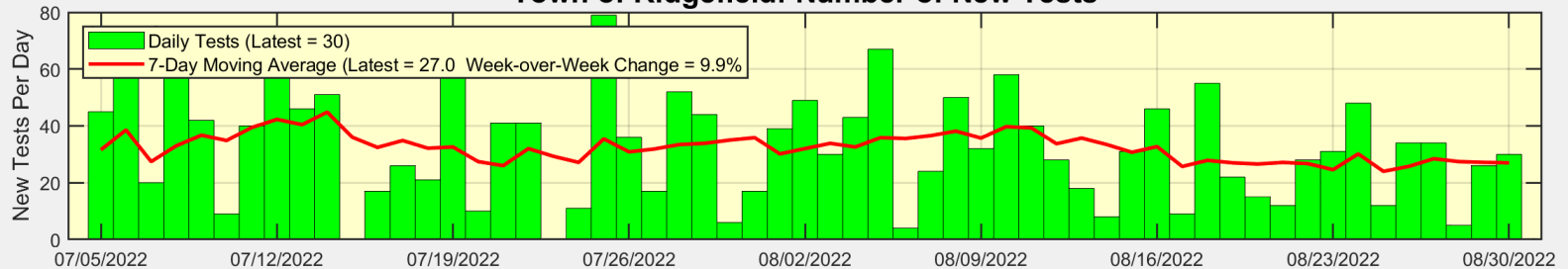

New Cases, New Tests, and Test Positivity for Ridgefield

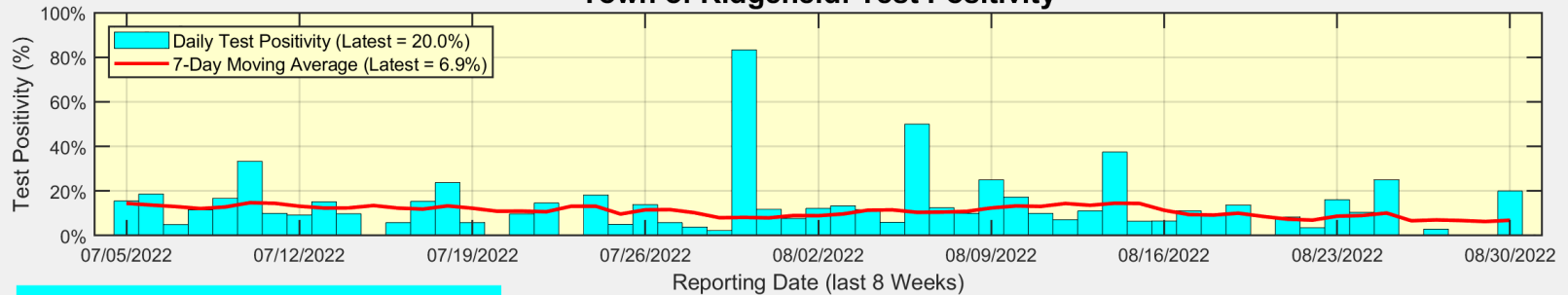
Town of Ridgefield: Number of New Cases (as of 08/30/2022)

Town of Ridgefield: Test Positivity



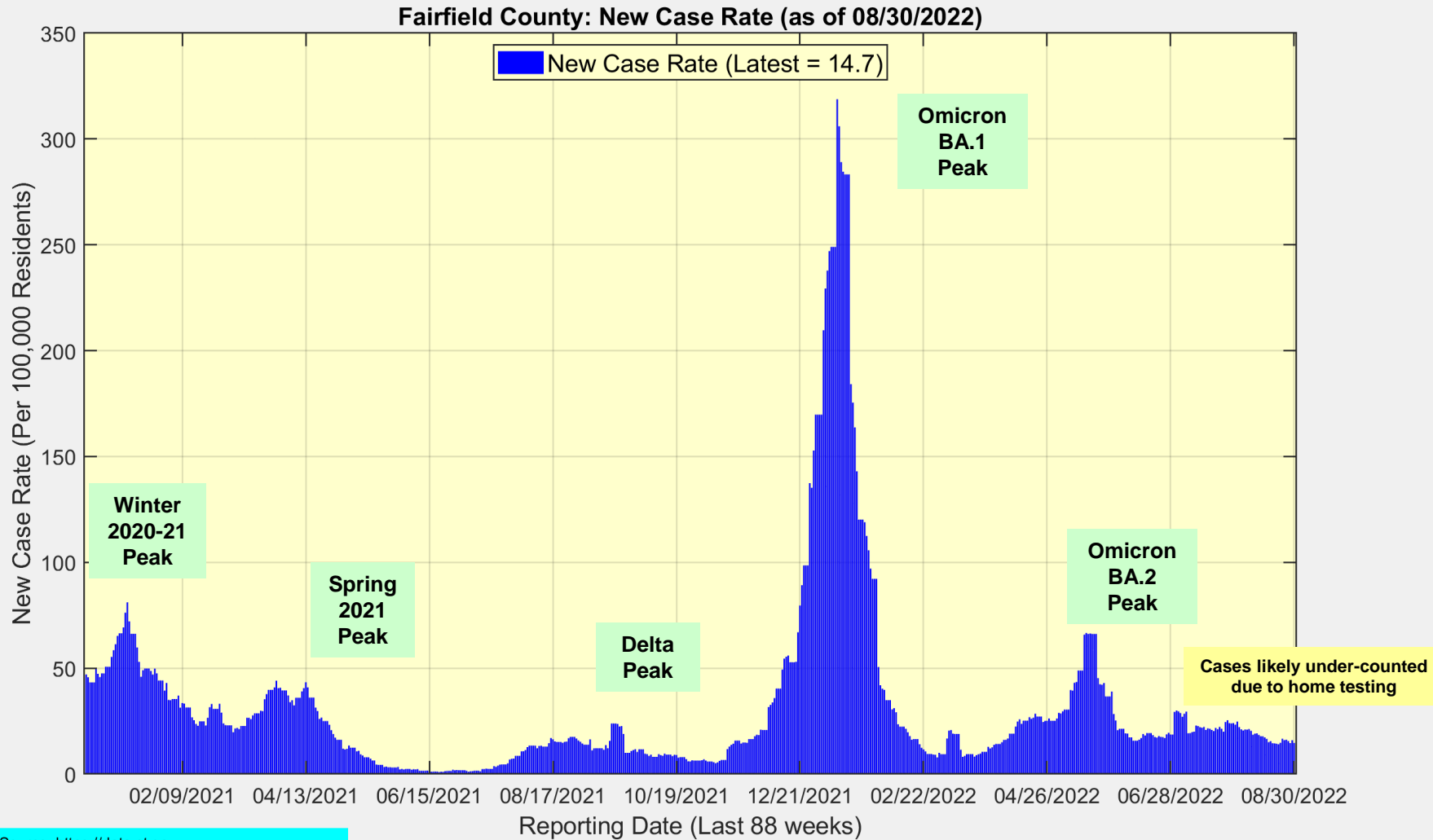

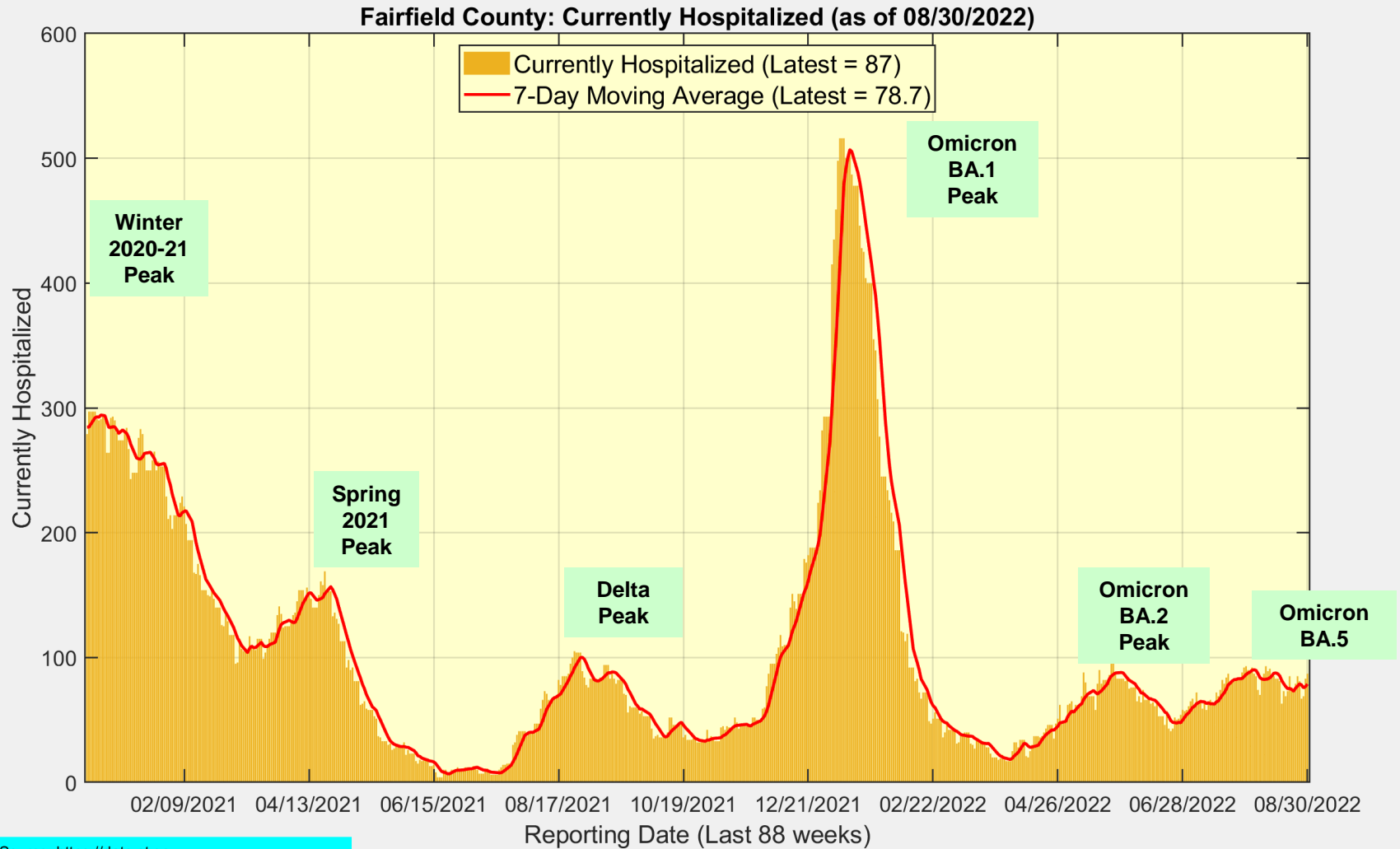

Fairfield County: Currently Hospitalized



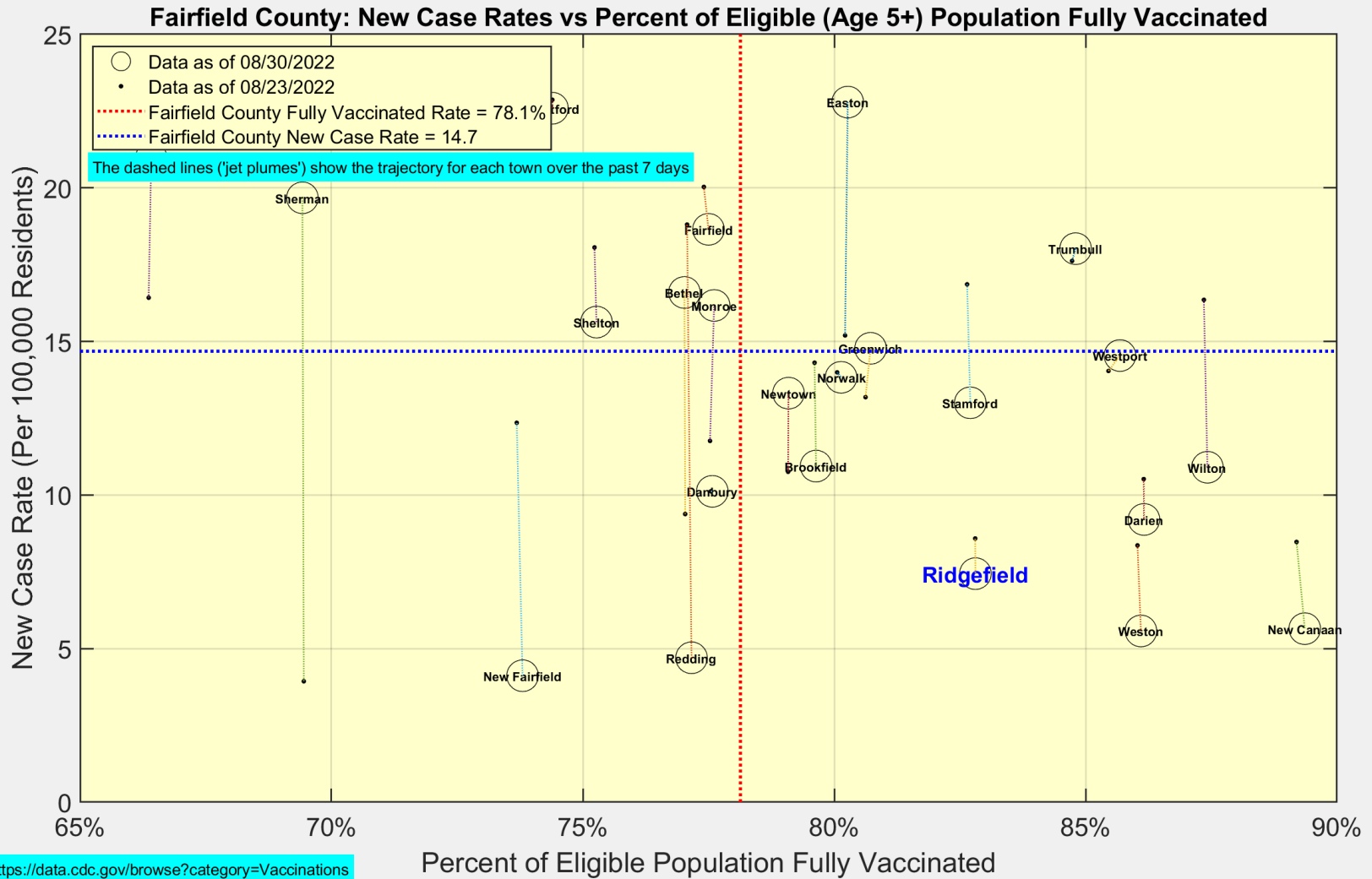

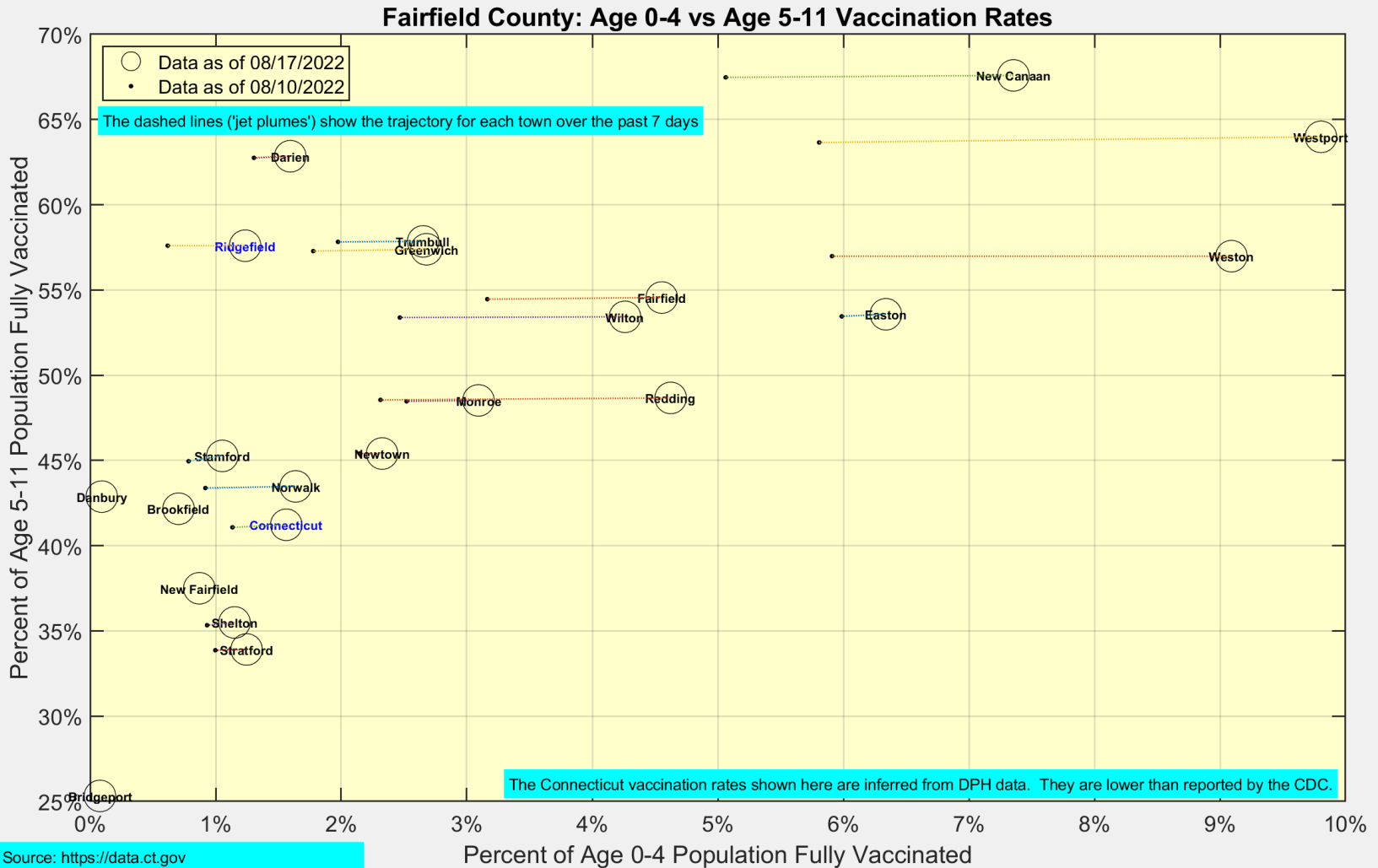

Child Vaccination Rates for Towns in Fairfield County



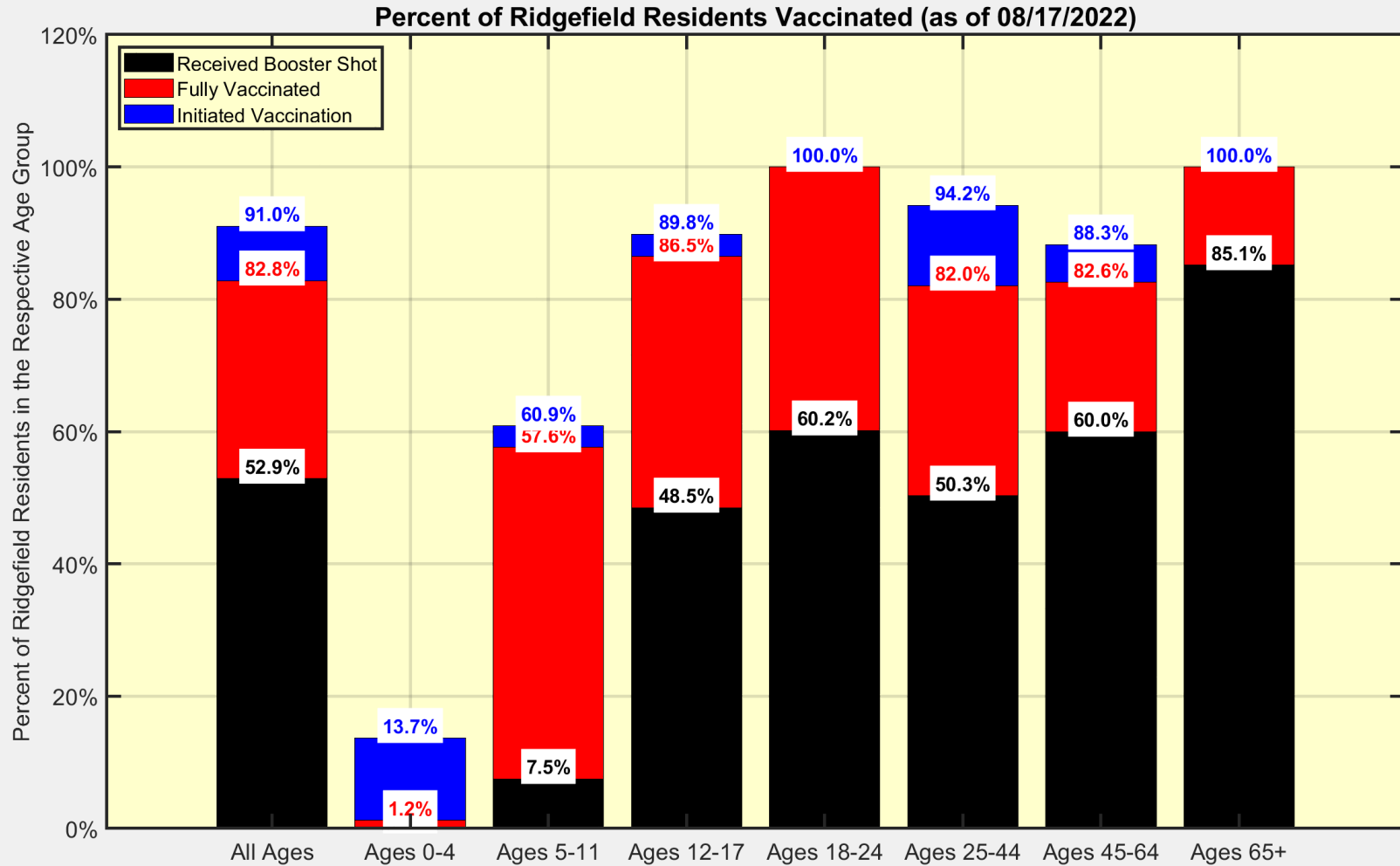

Latest Vaccination Rates for Ridgefield Residents



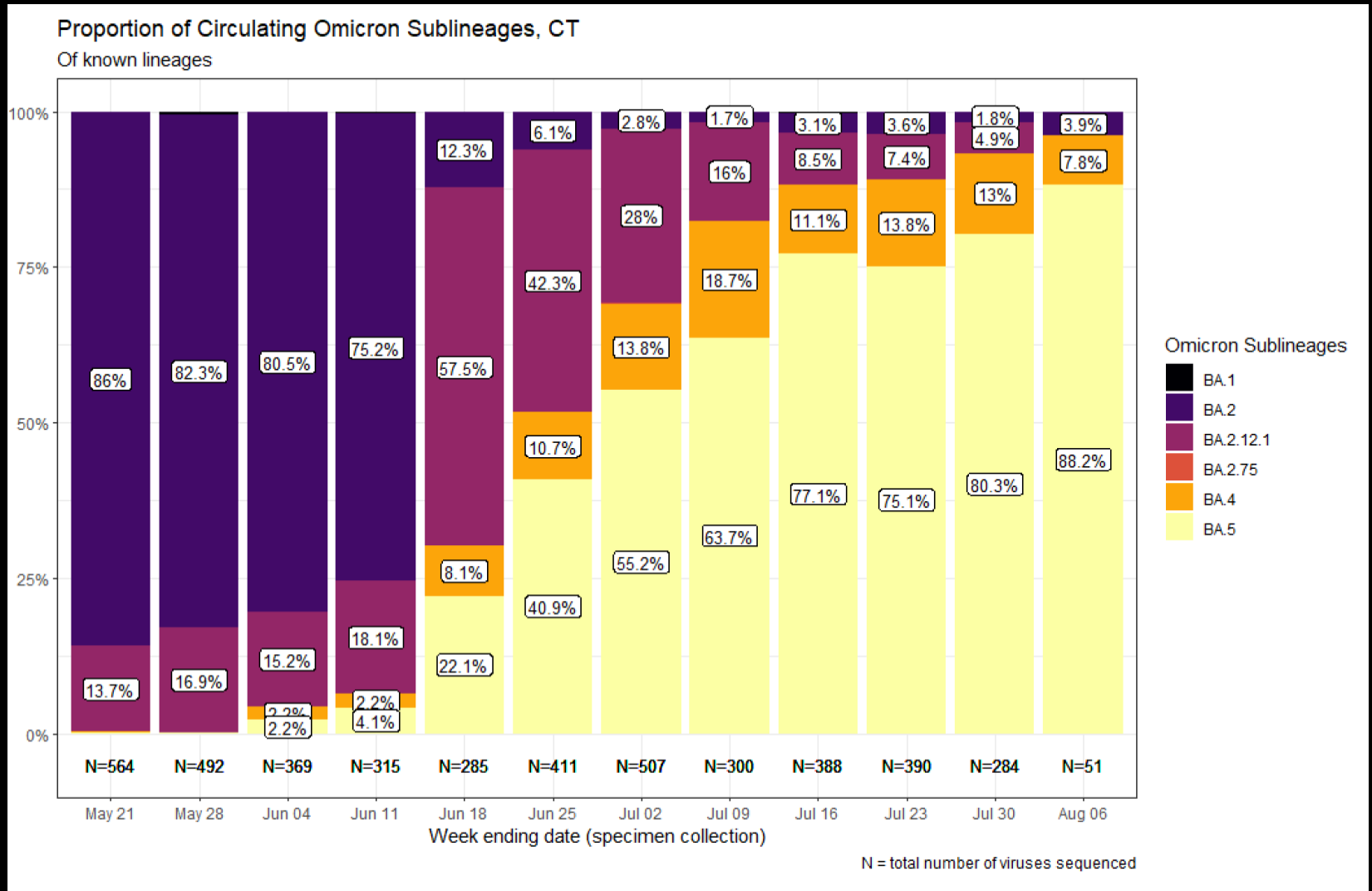

Connecticut DPH analysis shows 88.2% BA.5 prevalence

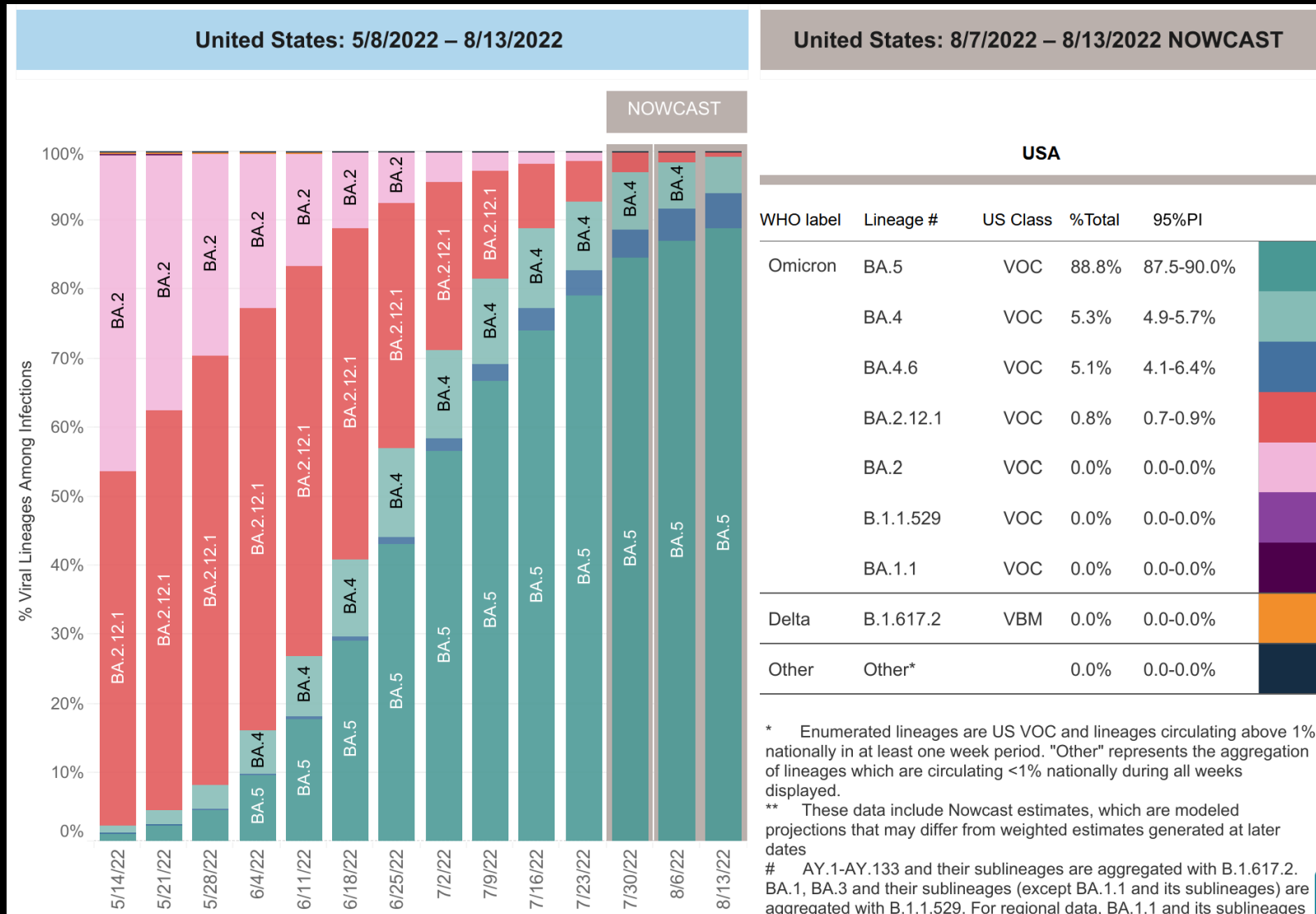
