The Chair called the Meeting to order at: 7:00 p.m. and gave an overview of the meeting, which was primarily about reviewing the final draft Plan of Conservation and Development ("POCD"). Ms. Mucchetti stated that this was not a Public Hearing and, therefore, no public comments would be received.

# PENDING ITEMS

**1.** POCD discussion.

Mr. Glenn Chalder, AICP, POCD Consultant Planner, the Commission and Staff finished reviewing the final draft of the 2020 POCD.

The discussion centered mostly the correspondence received since the February 4, 2020 meeting from: Ridgefield Voters United, the Ridgefield Historical Society, and The Conservation Commission.

The issues discussed included: defining Open Space, defining overdevelopment, and considering the aging population of the Town.

Mr. Chalder will incorporate the edits and get the new document pages distributed to the Commission and the Staff on February 26, 2020.

Mr. Fossi motioned, Mr. Hanlon seconded, to schedule a Public Hearing for April 28, 2020 to consider adoption, and to authorize staff to undertake statutory notifications to the Board of Selectmen and WestCOG. Motion carried 8-0.
