### INSTRUCTIONS TO BIDDERS

1. Submit proposals in a sealed envelope plainly marked with bid number to identify this particular proposal.
2. Withdrawals of or amendments to bids received later than the time and date specified for bid opening will not be considered.
3. The Board of Selectman of the Town of Ridgefield reserves the right to accept or reject any or all options, bids or proposals; to waive any technicality in any bid or part thereof, and to accept any bid deemed to be in the best interest of the Town of Ridgefield, Connecticut.
4. Bidders may be present at the opening of bids.
5. Bids may be held by the Town of Ridgefield for a period not to exceed sixty (60) days from the opening of bids for the purpose of reviewing the bids and investigating the qualifications of bidders prior to the awarding of the contract.
6. Insurance requirements, if any, must be submitted with the bid. This includes any Hold Harmless requirements as well as Certificates of Insurance, if required, for the full amounts specified. **Unauthorized changes** to these forms, i.e. adding, striking out and/or changing any words, language or limits **will cause the bidder to be disqualified**.

**Please Note:** Certificates of Insurance, if required, **MUST** name the Town of Ridgefield as "**Additional Insured**". Failure to do so may mean disqualification from the Bid.

## APPENDIX - HOLD HARMLESS AGREEMENT

Additionally, show the trade-in value you will offer the Town on the next line below. Then subtract and enter your Net Price (Price with trade-in). Please call Bob Schnieder at (203) 431-2759 to view the trade-in Kubota L2950D or to ask a question about the tractor. The Town of Ridgefield is Tax Exempt. **Prices should be submitted on page five (5) of this Bid. Please attach one page of your company's letterhead. Your Bid Response should be in a sealed envelope with the Bid number on the outside of the envelope.** Contractors shall state normal delivery time from when they receive a Purchase Order signifying the award. The Town is anticipating a quick award.

**Award Process:**

If Town of Ridgefield chooses to not trade-in its existing Kubota L2950D, "price without a trade-in" will determine award. If Town of Ridgefield chooses to trade-in its existing Kubota L2950D, "Net Price (Price after subtracting trade-in value) will determine award.

Sealed Bids must be received by June 5, 2018 by 11:00 a.m. where they will be publicly opened and read aloud.
