

## **One Permit required to use both the Ridgefield Transfer Station and Ridgefield Recycling Centre**

**Permit Cost:**      *Residents - \$20      Non-Residents - \$40 .*

Bought annually from Town Hall - Tax Collector's office (M-F 8.30 am - 4.30 pm)

**Ridgefield Transfer Station** is for Trash (Solid Waste) and some Recycling - 55 South Street, Mon - Sat 7.30 am to 3 pm

Solid Waste:	(building materials, old carpeting, broken furniture, soiled mattresses etc) Cost: \$88.21 / ton (res) or \$93.75 (non-res)
Garbage:	(household, restaurant waste etc): \$88.21 / ton for large quantities, or \$5 for 1-5 bags & \$10 for 6-10 bags for residents, or \$10 for 1-10 bags for non-residents or \$93.75 / ton for non-residents
Large Recyclables:	large household appliances, propane tank (max 40lbs), scrap metal, tires, car batteries, etc Cost: \$0.15/ pound
Cooking Oil:	recycle cooking oil at \$0.15 / pound
Brush:	(max. 5" diameter) and leaves. Cost: \$100 / ton. \$5 minimum charge.

**Ridgefield Recycling Center** is for Mixed and Single Stream Recycling - 59 South Street, Tues - Sun 7.30 am to 3 pm. Cost: \$85.35 / ton

Corrugated Cardboard goes in COMPACTOR #1	Mixed recycling goes in COMPACTOR #2
Glass goes in glass collection bin	Shredded paper goes in blue collection bin
Plastic bags place in plastics collection bin	Mattresses go into green container if they are clean and dry
Textiles go in textile collection bin	E-Waste goes into light blue container, nowhere else. Ask for help.
Food Scraps:	\$3 per drop off, for composting -free compost in Spring after 4 months participation in composting program, restrictions apply, see CT DEEP for more info.
