

Firefighter/Paramedics

The Town of Ridgefield will be accepting applications for the position of Firefighter/Paramedic through <u>4:00 PM, Friday, May 7, 2021</u>. Applicants <u>MUST</u> be non-smokers, in good physical condition and of high moral character interested in a career in the Ridgefield Fire and EMS Services.

No previous firefighting experience is required. Applicants must be a minimum of 18 years of age and possess a valid State of Connecticut Paramedic license to be considered for the position. Candidates must also possess a valid Connecticut vehicle operator's license or eligible for CT reciprocity.

The Town of Ridgefield requires candidates to have successfully passed the Candidate Physical Ability Test (CPAT), and **must provide proof of valid CPAT effective** <u>no earlier than July 1st,</u> <u>2019</u> or have passed the CPAT by the time of appointment (anticipated mid-July).

Fire Fighter Recruit Graduates will be given extra consideration when we review applications.

This position may work rotating 24-hour shifts or rotating 12-hour day shifts scheduled after Recruit Firefighter Training and/or department orientation. The full time starting salary for a Firefighter/Paramedic is \$60,772 per year. This position comes with a generous benefit package including a 401(a) with Town Match and medical/dental/vision benefits. Minority and female candidates are strongly encouraged to apply. EOE.
