PROJECT UPDATE

ROUTE 7 PUMP STATION, FORCE MAIN, AND WWTF DECOMMISSIONING PROJECT

The Water Pollution Control Authority's Wastewater Facilities Upgrade project includes construction of approximately 13,600 linear feet of new 8-inch diameter underground force main piping from the Route 7 Pump Station to the South Street Wastewater Treatment Facility. The existing Route 7 Pump Station will be demolished and replaced with a new pump station in the same location on Route 7. The existing Route 7 Wastewater Treatment Facility will be decommissioned and demolished. The work is anticipated to occur through February 2024.

UPCOMING CONSTRUCTION ACTIVITY WEEK ENDING 6/9/23 (SUBJECT TO CHANGE)

- o Force main pipe installation on Farmingville Road heading east.
- o Typical construction hours on Farmingville Road will be between 5:30 p.m. and 2:00 a.m., Monday through Thursday with pavement restoration on Friday between 9:00 a.m. and 3:00 p.m.
- **Force main installation work at the Farmingville Road culvert and manhole areas may transition to daytime work hours between 7 a.m. and 4 p.m., once these areas of construction work are underway.**
- Force main pipe testing on Lee Road, Limekiln Road and Haviland Road. Construction vehicles will be in the areas of the force main testing along the project roads. Typical construction hours on these roads will be between 7:00 a.m. and 4:00 p.m., Monday through Friday.
- o Traffic management will be provided by RPD and/or flaggers (as needed).

- o Force main pipe installation on Farmingville Road heading east.
- o Typical construction hours will be between 5:30 p.m. and 2:00 a.m., Monday through Thursday with pavement restoration on Friday between 9:00 a.m. and 3:00 p.m.
- **Force main installation work at the Farmingville Road culvert and manhole areas may transition to daytime work hours between 7 a.m. and 4 p.m., once these areas of construction work are underway.**
- Fiber optic cable installation on Lee Road, Limekiln Road and Haviland Road. Typical construction hours on these roads will be between 7:00 a.m. and 4:00 p.m., Monday through Friday.
- o Traffic management will be provided by RPD and/or flaggers.
